**The social housing in Belgium may hold clues to the reason for  
many wars around the world. Sample case study on Woonhaven**

*Dear Chief Prosecutor,*

Further to [my email to the attention of the Honourable Mr Bart De Wever, Mayor of the City of Antwerp of 4 August 2022](#) with the [letter](#) concerning my arguments for Woonhaven for a quick allocation of social housing, I am sending you this file on the comments on why I do not want to have social housing at Woonhaven.

This is not a complaint against the housing association, but a document aimed at improving the social rental sector in general. I suspect that the social housing sector is governed by a criminal gang that seeks to gain a stranglehold on the migrant population in order to ensure its economic expansion in the migrants' countries of origin.

Providing housing is a way of controlling the lives of immigrants who enter the country in various ways (reunification, work, study). [We are talking about an estimated 519,684 third country citizens in Belgium according to the European Commission, of which 14% come from Morocco, 7% from Turkey and 3% from the former colony of the Democratic Republic of Congo.](#)

The subject I am addressing in this letter is the financial exploitation of this group of people in Belgium and the colonisation through the dispossession of this group of migrants of their

property as well as the bankruptcy of entire families whose basic human rights are violated by this system which I call criminal, making this group a burden for the rest of the population.

This colonisation takes the form of bilateral trade agreements related to the tourism sector and the construction of hotels such as the [NH Hotel](#) Group. An example of a colonised area is the Western Sahara region, which is larger than Morocco, and some forests in the interior of Morocco, such as the American forest in Tangier owned by the Fertoul family, which I discuss below, and which generates a lucrative interest in the production of fire-resistant wood that cost the life of [Mr. Mark Arends, a Dutch shareholder of the Linder Group, probably killed by the Covid at the SNCB in Antwerp Central](#), and probably in the context of sustainable construction of social housing.

The agent executing the trade agreements between Belgium and Morocco is the [Belgium-Luxembourg Chamber of Commerce in Casablanca](#), which is headed by Mr. [Lucien Leuwenkroon](#). I have the honour to include the photo of Mr. Lucien [Leuwenkroon](#) below:

This chamber of commerce is said to handle the export of vaccines worldwide for Covid19. It is a clandestine chamber of commerce whose legal adviser is [Attorney Inès Wouters](#), a lawyer at the French-speaking Bar of Brussels. This letter concerns her. I leave it to you to ask her where the above photo of His Excellency Lucien Leuwenkroon comes from. He is a terrorist who does not care about the whole of Morocco.

I would like to make it clear that I am only referring to the social housing sector, which is privately owned and often confused with the Belgian public authorities.

Among the private shareholders, I suspect a lawyer named Inès Wouters, who has historical family ties in the countries of origin of immigrants in Belgium, and whom I will discuss throughout this letter. She would become a shareholder with the funds that come mainly from the [trafficking of Arab women and illegal migration](#).

I suspect this lawyer of irregularities in the awarding of contracts within Woonhaven for the construction of social housing, the management, maintenance and HVAC systems of the social housing, and the management of the tenants. Contracts are probably awarded to companies in which one or more members of the Brabant killers gang have an interest, such as shares if they are not the owner. An example is [Renson Ventilation](#).

It seems to me that there is a domination of the social housing sector by the mafia led by [Attorney Inès Wouters](#) in addition to the fact that [they use false identities](#) so that their real name never appears in all these areas and in all documents. Her name will only appear in the event of a dispute with the tax authorities, but the truth is that none of their companies or organisations have ever been questioned or investigated as a matter of allegiance or association. Examples are [Bouwbedrijf Rombouts, INJO sarl](#), and De Kock HVAC.

For example, I was asked by CAW (Centrum Algemeen Welzijn) for an integration programme through social housing at Woonhaven, which I explain below. It seems to me that Ines Wouters is both involved with CAW in its financing, real estate, and fiscal and financial control, and at the same time she would exercise the same role with Woonhaven, with the result that the users of both organisations are dominated by the same person.

The intention of this letter is to verify the suspects I state in this letter in order to pursue and claim damages.

## This time I share my observations on Woonhaven, both as a housing applicant and as an anti-money laundering controller

The photos and videos I include in this document were taken by myself and I am handing them over to the Vlaamse Maatschappij voor Sociale Woningen, which will become the owner of them and the rest of the content.

The photos below show the impressive number of social housing units in large blocks in Luchtbal (Antwerp). Thus, there are a large number of concrete-only neighbourhoods in several Antwerp municipalities where the question arises "are all these people dependent on the social system?

How many people in total are we talking about in Belgium who are housed in social housing and/or who receive a living wage, because I can't find these figures?

Woonhaven says on their [website that they have a total of 19,400 dwellings](#) and in [their annual report 2021 they say it is 17,258 dwellings](#). The difference is 2,144 dwellings. Furthermore, if one were to find the estimated value of the property from a specialised estate agency, this difference suggests a significant sum. I cannot judge myself how to classify or value properties.

In terms of subsidies for, let's say, sustainable living, such as energy saving, different heating, garden and patio, fire safety, rent adjustment, ventilation, pests, bed bugs, mold, damp, etc., 2144 dwellings is a lot of money. It could well exceed the government's annual budget for social housing.

It could be that they are emergency houses intended to provide accommodation in social housing in an emergency. If this is the case, they should indicate this in a separate balloon on the same drawing with "Emergency accommodation" on top.

Applicants on the long waiting lists would be well advised to know how many units are available. This figure is not indicated anywhere. On the other hand, this figure could also be interesting to better adjust housing projects to expectations. But when there is no explanation for this margin of 2144 houses and at the same time there is a shortage of housing, families are growing, people are becoming homeless, houses are affected by weather disasters, all sorts of accidents leaving people homeless, when so many people are disadvantaged, there could be a diversion or embezzlement somehow. This is by no means a mistake or a miscalculation.

There are people who have been waiting for 10 years for social housing, especially among the indigenous population. This is an awfully long time and the state is being held responsible for this, even though - as I understand it - Woonhaven is not a service of the Belgian state.

At present, this situation is causing heated debate in the social class about refugees from Ukraine being given preferential treatment over all other citizens. Well now, maybe this margin of 2144 houses is reserved for this group of refugees and asylum seekers. Why don't they publish it that way?

When Her Excellency Eva De Bleecker made a mistake of 1.7 billion euros in the budget, she was expected to resign. In her case, it was a budget. It was about estimates, something you never expect to be correct. She had to resign over an estimate when a simple correction would

make her look very human and very professional in the eyes of the general public, compared to someone who wants to look perfect and supposedly makes no mistakes.

Who decides the figures at Woonhaven? The figures are usually decided by one final decision maker.

In terms of income, Woonhaven states on its website that it manages [37,500 tenants](#). [In its annual report for 2021, Woonhaven](#) reports a lower number of tenants, namely [26,113 family members](#). The difference is 11,387 people who do not live in their homes.

As for tenants or family members, here the figures should be accurate, and they are not.

Perhaps it is about 37,500 people registered as applicants, and there are 26,113 actual tenants. In either case, Woonhaven is only correct in saying that there are 11,367 people who contribute nothing to the whole.

Is my application part of this figure? At least that is what I want to find out and why I am writing. After thinking long and hard about whether I wanted to continue working with Woonhaven, I decided that I did not want to be in the middle of all this. With this letter I am making this clear and I would like a guarantee from the government that all my data and documents will be destroyed at Woonhaven, so that they will not be used for any other purpose.

A little further on the same site, I found other figures. Woonhaven [serves 36,000 residents and 20,000 homes](#)

## My registration to Woonhaven

My registration with Woonhaven has happened more than once without any response. I always had to chase to get a file number

### January 2022

At the beginning of [January 2022](#), I started to look for accommodation because, in the previous months, [the Victor night shelter](#) had given me the choice between removing [this letter to His Excellency Naftali Bennett, the former Israeli Prime Minister about Mr. Stephan van Collem](#) from the internet in order to be admitted, or to leave.

The decision is said to have come from a team of officials at Victor's night shelter, who are embarrassed by the situation. However, the question is which Stephan Van Collem they are talking about, because it is not the same person. There is someone of that name who also uses the Victor night shelter, but he is a homonym of the person I am talking about. There are tons of others called Van Collem. So there's no way I'm taking my letter off the Internet. So, what's bothering them?

I was talking about a Stephan Van Collem who lives in Israel, and I suspected that he might be related to a vanished Dutch Van Collem family, who were Jewish tobacco merchants and who owned farmland in Kenitra, Morocco, where I was born.

In 1944, the van Collem family had not yet returned from Western Europe to their home on their property in Kenitra. The locals did not know that there was a war in Europe, let alone what the Holocaust was. They have never heard of it to this day.

That is why in September 2016, I launched the "[From Mawazine to Panama Papers](#)" programme to promote a modern method that integrates DNA (genetic code), business or company and financial performance data that allows you to see the logical link between these elements to identify its owner no matter what name he or she has. It is a method that helps to avoid risks related to financial behaviour in business, and to avoid losses and bankruptcies.

To teach the method, I propose a research on the First and Second World Wars with the question "who made money during the war?". The answer will lead directly to the Enemy and his business. Once you can identify the Enemy in WWII, you will be able to identify the Enemy anywhere until the end of Times, given a determination by the DNA factor and by extension a culture that will probably never change. The chances of success are much higher with this type of intelligence than without any. If you don't develop this knowledge, chances are you will find yourself working for the Enemy, living in the house the Enemy wants for you, falling into incurable disease conditions, and suffering. I want to avoid that for my people and at the same time I want to expose them to the knowledge of the two World Wars in this way, learning to identify the Enemy's business to make sure that their business is not like his.

If I had not detected Ines Wouters in Woonhaven, I would never have written this letter, and I would have said 'yes' to the flat I was offered.

In Kenitra, when the villagers finally learned that the van Collem were all dead, they could not understand what had happened. They imagined that they must have eaten something poisonous.

The whole neighbourhood was waiting for them and nobody knew how to start a search for them. Their house, their office and the farmland where tobacco was grown remained untouched until they would return, because they also had children born there. They were babies, and no one imagines that infants would also have died when they are not yet eating anything.

The minds in the village in Kenitra cannot conceive that the kind of atrocities committed in the destruction camps, where people are [held as hostages and left to starve, and then taken to gas chambers and ovens where people are brought en masse to die](#), officially for the sole reason that their religion is Jewish, but in reality looting is the real reason. Most people in Africa cannot imagine the extent of the hatred that still exists in some people. They can imagine someone being punished, but they cannot imagine an innocent person being cut into pieces, especially not in Western Europe because of democracy. That is why the history of the Holocaust is necessary and should be taught all over the world, in order to make people interested in finding the truth.

[Between 1946 and 1956, a Mr. Victor Louis Leemans and his family lived in the house of the van Collem family in Kenitra. In 1956, when Morocco became independent, the Leemans family was expelled from Morocco.](#)

The news spread throughout the Ouled Ziane neighbourhood in Kenitra - Souk El Garb - that the entire family of the brothers Samuel and Joseph van Collem had died.

No one in Morocco knew how they died until I met Stephan Van Collem in Antwerp in 2021, who explained to me that his whole family had been exterminated in the Buchenwald death camps.

I then started to research their exact history, how they died, why, by whom and where they are buried, so that I could show all Moroccans that we had relatives in the NAZI camps in Europe, and that there should be a settlement.

I was born in the van Collem house. The Moroccan government leased the farmland of the Dutch tobacco merchant to my grandfather El Arabi Bouhammou (my mother's father) and he was not allowed to change anything.

[Naturally, I contacted the Jewish state to report the existence of Stephan Van Collem in Belgium. I was expelled from the Victor night shelter without understanding what I had done wrong with this letter.](#)

As this farmland issue is far too important for my country, whose government also reads my blog letters, I opted for the second solution. I left Victor because they were meddling in my private affairs. My situation was followed by OutReach, a branch of the Antwerp CAW (Center for General Welfare). I asked them for a tent, which I got.

While [sleeping in unsanitary conditions](#), I made contact with social rental offices, during the Corona lockdown, when it was not possible to get to the rental office, which seemed ideal. They eventually began to use the Internet for registration, finally

In fact, I was turned away from Victor's night shelter for futile reasons; Victor's night shelter (which belongs to CAW) is also very interested in creating long lists of homeless people who are first admitted and then excluded. They always find a reason other than violation of the house rules, such as drunkenness, drug use, violence and nuisance. In my case it was none of these but a letter on my blog, which was not theirs. The reason for removal or eviction is rather related to providing a revenue stream for the CAW shareholders to do something else with it. Perhaps Victor Night Shelter and Woonhaven have the same shareholders, as it is housing. Survival' in other words.

With an accelerated allocation, a response suddenly arrived

Here are the bank statements for the second registration in August 2022, which this time goes through CAW

When I sent my bank statement, it was with the agreement of Outreach of CAW. There was about 200 euros on my bank account.

I make it clear that I have no income

Another communication concerning the 3rd attempt. I was informed that a sheet was missing

I did not want to go to Borgerhout, Kiel, Merksem and Seefhoek. However, through this procedure, Woonhaven decides where you should live

On 31 December 2022, I sent [a report to the Antwerp prosecutor's office and to the President-Delegate of the Superior Council of the Judiciary of Morocco concerning a file of fake passports apparently manufactured in Morocco](#), with [my recommendations for the US Congress](#) concerning [the 2020 US election fraud](#).

In [that letter](#) I mentioned a person who had returned from Ukraine. His name is Mr Tim Fransen. To escape Ukraine safely in March 2022, he used a fake Russian ID and passport to return home via Russia. The person who brought the fake Russian passports to Ukraine to help many other volunteer fighters like Tim to flee is [Professor Roland Willemyns of the Vrije Universiteit Brussel](#).

Between September 2020 and January 2021, Mr Tim Fransen was also a user of [the Victor night shelter](#) until he was removed for his repeated involvement in fighting in and around the night shelter area in Desguinlei 33, 2018 Antwerp. He had then just returned from Syria and Afghanistan where he had known Stephan Van Collem. He was provoked by others who were probably sent to attack him.

He pitched a tent in the immediate vicinity of the Antwerp South railway station. So this is in Kiel. There he was threatened with beheading by the Islamic State. I come back to him at the end of this letter. Note that Woonhaven's offer for me is for a property in Kiel. To me, that means "to kill".

## The invitation to visit Woonhaven and the flat in Kiel

The contact person is Ms Anja Wouters.

Is she a relative of [Attorney Inès Wouters](#), the former Afschrif's lawyer who also deals with visas for migrants or tourists like Mr Béchara Matta?

Could she be on the board, perhaps with [others](#), or a shareholder in Woonhaven?

I am asking whether Ms. Anja Wouters is related to [Attorney. Inès Wouters](#) because, if so, this is not the first time that [Attorney. Inès Wouters](#) has tried to force social housing on me.

In 2012, I was approached [by Mr. Mohammed Brika a Moroccan MP](#) to call on the lawyer Ines Wouters for her tax expertise regarding the transfer of funds from Morocco to Belgium. Against my will, I did it [in writing](#) and sent it [by e-mail](#), because I don't believe in the rectitude of someone who needs more than one summer house in Morocco and especially in Dakhla and Laayoun (in a territory occupied by the Polisario terrorists), but also in Fez and Tangier. It is not an ordinary summer house that she owns but a riad. A riad is a palace and [Attorney Wouters](#) owns at least three in Morocco, as well as a small house. A riad looks like this:

[Ines Wouters earns a lot of money abroad that she does not declare to the Belgian tax authorities because she uses false identities in Morocco, for example, to acquire riads.](#) A riad has the capacity to accommodate between 50 and 70 people in a personalised and intimate atmosphere. All year round, her riads are fully booked at an average price of 70 euros per night per person. She earns at least 4,500 euros per day, or 135,000 euros per month, just from tourism in Morocco, to speak of what we know about her there.

She could also have something similar in other countries, such as Hurghada (Egypt), Qatar, where she has a villa, in Turkey, and possibly in Ukraine, to shelter criminals. In fact, her secret foreign accounts show that she would have properties

How does it do all this?

Do you think Woonhaven has something to do with it?

She would own a house in [any country following the path of mass migration to the West](#). This corresponds to the bank's requirement to have an address in the country where the account is opened. As such, the Belgian mafia is directly involved in mass migration, illegal migration, refugees and wars around the world.

In Ukraine, for example, houses that were pre-war shelters where trans-migrants from Pakistan, Bangladesh, Nepal, Tibet, Afghanistan, Iran and Iraq stopped to spend the night can now be used to hide fake Russian volunteer fighters such as [Oleg Vinyenko and Frederic Templar](#) and [weapons](#). As volunteer fighters, they do not use hotels to avoid traces of their false identities.

According to the witnesses I met at the Belgian Red Cross asylum centre, there are also many volunteer workers from NGOs from different countries who do humanitarian work there. As volunteers, they are not supposed to be able to afford a hotel.

It also answers the question of where these volunteer fighters sleep and eat when they decide to go to a foreign country without much money without being part of the government forces. To stop the war, the central banks must find the corresponding addresses on this list of secret accounts and raze the whole building.

Can you imagine the income that [Attorney Inès Wouters](#) gets from all these countries? In Belgium, she does not declare anything to the tax authorities, and we have to show her our bank statements in Woonhaven and tell her what property we own in the country of origin, in order to be entitled to social housing that does not resemble the riads she owns. Did she ever tell you that she had bank accounts in Morocco to put the tourists' earnings in? There is no one asking her to resign as Her Excellency Mrs Eva De Bleecker had to do in a painful way. This is a phenomenal injustice.

I did what Mr Brika asked me to do anyway, otherwise this parliamentarian might decide not to help me anymore. This is the risk linked to the gap between the way Moroccan migrants perceive and live their lives in Belgium and the way Moroccan politicians perceive Belgian tourists and development workers, who obviously behave differently with Moroccans living in their own country. To avoid a clash between Moroccan politicians and myself, I have addressed my observations to another Arab government in a sister country until it is clear that we have serious problems to solve with Belgium.

I think the property that lawyer Ines Wouters owns in Dakhla and Laayoun (which is in terrorist-occupied territory to which she is attracting more Belgian settlers) exposes enough evidence of the hypocrisy of everything she does there. The same tax lawyer is technically involved in [the plot that killed His Majesty King Hassan II](#).

In 2012 she was a partner in the law firm Afschrift. She invited me and offered me her 'help' in obtaining social housing. However, this was not the purpose for which I approached her. I have one aim, she has a totally different aim which I knew all about at the time without being able to substantiate it with evidence at the time, like I can do now.

I told her no and I never wanted to see her again because she refused the assignment I had for her law firm. It was a large sum of money from the Moroccan government to solve my housing problem, in a way that ruled out using the funds for anything else, such as financing violent terrorism. That is why I involve the banks and the lawyer. Instead, she wants to force me into social housing at all costs.

I have to fit her model, but I don't think in the same way as her, otherwise I wouldn't be just like her not be able to propose innovations. This is what I wanted to teach young entrepreneurs from disadvantaged areas. You have to change your way of thinking first to get out of that 'social environment', even if you still live there.

I will fit her in the dock at the International Criminal Court, where they will make her pay until she can't pay anymore.

That's why I think she mobilised a lot of people to force me [out of my home](#) in 2014, and in 2022 she may mobilise her family to force me into social housing for a reason, because the decision in 2021 to evict me from the Victor 4 night shelter also came from her and not from Mr Peter Rombouts (alias Stephan Van Collem) because he was there too. He suggested that I simply return to the night shelter. He doesn't care what all the Wouters think, and he's right.

So this could be a second attempt by Master Wouters to get me into the accommodation she wants for me, through the back door, and probably through a family member, and through [CAW, which I always thought was a Brabant Killer organisation, but that doesn't mean that all CAW members are bad. The Brabant killers have many other companies that employ a large number of people.](#)

The [Brabant killers](#) own construction companies (such as the construction company Rombouts) and are said to be shareholders in concrete factories such as Heidelberg Cement, Titan

Cement, and Cold Crete among others, and in architectural firms, all of which could be involved in the construction of social housing, thus attracting social funds that they launder through shares. They dominate the social sector for these very reasons. They have an impact on crime in the most vulnerable social group and on the security of the whole society.

Because I don't know if Mrs Anja Wouters is related to the lawyer, and because I don't want to get in touch with any Wouters whatsoever for good, I answered "NO" to the offer of Woonhaven.

After checking, I found another Wouters in Woonhaven. It is Mr. Jan Wouters. There may be others who dominate social housing, social services, urbanisation and architectural heritage, security, insurance, not to mention railways and public transport. I have sought them all out to convince Morocco to expel all of them immediately

I do not wish to be dominated by Wouters for my housing, [my work, my applications for jobs or funds](#), my [taxes](#), my [health](#), my [pension](#), [my public transport](#) both by bus and [train](#) and maybe also in Morocco. It is a name that has been on a blacklist since the Second World War at least because of their anti-Semitic and racist character, and that does not suit us. This is a list that I found while researching van Collem, in which I came across [a blacklist of Belgians who were arrested and died or were killed between 1940 and 1945](#).

Not all the Wouters died at home in their home town. Most of the Wouters died in Germany and one wonders what they did there. They probably did the same thing as Attorney Ines Wouters did with her riads in Morocco, namely [slavery](#) and [looting](#). She has riads in all the Arab countries whose entire population she hates. For this reason, I am not at all surprised that the Wouters were arrested and probably executed to stop their heinous behaviour.

The end of the Second World War can be explained by the fact that many members of the Wouters family were killed in a very short period of time, around the second half of 1945. To stop their own decimation, they laid down their arms. This must be why the war suddenly ended. [The list of those executed shows this](#).

Wouters is not a name we should have in our banks, our companies or in our country. At least I don't take risks with this family. They are simply too dangerous. The fact that they can still be found in the oldest organisations like [the Red Cross](#), in [some banks](#), in [the judiciary](#), in [the railways](#), in the social housing (this one) and [food distribution](#) services [for the poor at CAW as during the war](#), in [administrations](#) and universities shows that their war machine was not dismantled at the end of the Second World War.

This explains why the war has continued in a different way, this time against immigrants such as Moroccans and Muslims, through all channels, including the media, housing of course, education, work and unemployment, both in Belgium and in the country of origin, which is most serious. Belgium has always been a war zone, but for a Belgian war to extend to Morocco is unacceptable. They have changed their target audience and they are working very hard to finance the I.S. this is the observation I made in my book [AllahGhaleb](#). Because the old structures have not been dismantled and because they are part of a war machine, it is possible that a third world war will break out exactly where the first and second world wars started. Therefore, [the Maghrexit](#) is no longer a wish, but an obligatory evacuation of all Moroccans.

[With all due respect to those who are not Wouters' family, but no one with the name Wouters, the Wouters or Wouterse enters my home because I discovered a direct link with Covid19 regarding Attorney Inès Wouters, of which a first report was sent to Morocco in the framework of an investigation into the causes of the death of the late King Hassan II](#)

Apparently, I will have a hard time keeping the Wouters out when I accept accommodation at Woonhaven, where they have keys to all the flats.

I myself was a victim of Sars-Cov disease in 1997 and 2000.

A link between social fortification and Covid19 infections could provide a clue to the same author(s)

Therefore, I am considering filing a complaint against AttorneyInès Wouters for racist persecution and I would like a judicial investigation to put an end to it.

## You get the key before you have signed a contract with Woonhaven. Absurd, isn't it?

20 in cash was mentioned on the invitation to guarantee the key. I had to bring only that and the invitation. The identity card was not required and they did not ask for it.

I refused to pay in cash and asked for a bank account number to deposit the 20 euros. I explained to the lady at the counter that a lawyer is my debt mediator and he asked me to prove that I would not spend the 20 euros on anything else.

Now 20 euros, then 7 euros, then 10 euros here, 30 euros there all in cash... You will never be able to keep track of your expenses at Woonhaven like this.

The employee said that this is not done because it is a guarantee that is returned in exchange for the keys, and that this return in cash is difficult if you work with bancontact or bank transfer.

In my case, it was a visit to the flat. "Now, suppose you don't take it and you paid through the bank. How can I return the 20 euros?" she said.

If it is only a visit, then a valuable item such as a driving licence, bank card or credit card is requested and returned on return from the visit. Either someone from Woonhaven has to go with the candidates with the keys, or a caretaker has to be appointed in the block to accompany the candidate. Under no circumstances can the keys go to the candidates. The management lacks a lot of imagination and is only thinking about money. That's all they know.

The lady said it was the first time she had heard such a thing. Never before had a debt mediator asked for such a thing.

And I've never seen a landlord say: "Here's the key, do the visits yourself". You might as well move in as long as you don't want the 20 euros back.

**It is on Jan De Vos lei 41, bus 17, 2020 Antwerp.**

## But what is in these documents that others should not know?

Here are some documents that you are only allowed to keep if you accept the accommodation. However, my name is mentioned all over these sheets, so I can at least take a copy of these documents. I said that I have a very difficult lawyer who deals with my debts and he asked to take pictures of everything I have to sign, and show them to him before making a decision. I handed over the documents to the counter when I finished copying.

Please check what is said that is not to be known. With all my thanks.

I expected to see the bank account number on the letterhead of all the letters, and I did not find one.

The employee at the counter said that she did not have a bank account number directly at hand, and that it is mentioned in the contract, which I will only see upon acceptance.

Nowhere on the Woonhaven website is there a model contract or a specimen.

She also said that I only had one chance to make a decision. "Normally we ask for the decision immediately, but if you want it, you have a cooling off period of a few days (this was a personal offer from the lady who wanted to make an exception)." She is a very nice lady who works at Woonhaven.

In fact, this is how it should be for everyone, because let's assume that a person in debt who is only given one opportunity, and who finds himself or herself more in debt after a few months because he or she has not had the time to discuss the feasibility of this price with the debt mediator or the PCSW (OCMW/CPAS) first, does this person not have a second chance to apply for social housing?

It is not clear whether this high pressure is only for the 'fast track scheme' (which is for homeless people) as it is for all other applicants, but assuming that someone has a current lease with a notice period, how can they decide immediately without consulting the other landlord first. There is no consideration of the actual situation of the candidate, only that if someone is homeless they expect that you will say 'yes' to everything. **This pressure is human trafficking.** Putting people in financial difficulties is also racism and human trafficking, and that is what Attorney Inès Wouters is doing with her gang of killers in Brabant.

Eventually (well after the visit, when I was on my way home), I found a bank account number on one of the documents she had handed over for the visit, with the rent details:

## Is the IBAN BE87 0960 1808 8194 the general bank account of Woonhaven?

It says "Woonhaven account number", but it almost looks like it is my account number for Woonhaven, because my ID is listed right above it.

How can I prove that this account number and these figures have nothing to do with me? It's a mirage and a typical DNA trait of people who like scapegoats. I know it's not [my bank account number](#), but maybe they are using this piece of paper to fool someone else.

I refer to the above, where I discuss the difference of 11,367 family members. Could it be the applicants like me who registered and did not take up accommodation?

I ask because the homeless are suddenly in the spotlight in Woonhaven, as they are a group with no home address, where there is no way to verify where they actually live.

Besides, where do they get these figures from if they never asked after the tax statements. I didn't provide any figures and I don't have that much money. I think it's a pity that they don't use real figures, that's why I declined the offer. It surprised me and I might get more surprises this way if I choose to live in their social house.

They were only interested in the family composition to see if I have children. Are they looking for childcare allowance or some other large family allowance?

Who prepared this document?  
Where do these figures come from?

**I have the honour to hand you my fiscal note (which I have also used for other social housing offices in Belgium)**

How did they use these documents?

The reason for this concern is that neither woonhaven nor CAW have asked for proof of actual income apart from the [account statements](#). So they only want to know how much money you have in the account, without knowing from what source you get this income.

I have attached [the letter from the tax office](#) stating 0 euros with the registration documents to explain the low amount on the [account statements](#).

I don't understand where they get these [estimates](#) to know that I can pay 310 euros per month on time. It's mainly about paying "on time" because when you have other expenses like electricity, telephone, internet, insurance, mutual health funds, bank charges, transport, food and hygiene, it's difficult to decide what to pay first. A person with such a [tax sheet](#) cannot pay in time, except through prostitution.

**Your life ends here, in Woonhaven. So you are safe for a lifetime. Apart from a roof over your head, you will own absolutely NOTHING else**

In the waiting room, there were only foreigners and veiled women, visibly poor, tired and perhaps in poor health. They speak little or no Dutch. They obviously cannot read and understand the conditions of renting accommodation with Woonhaven either.

A blonde employee, who looks a bit like Mr Jan Wouters, spoke English to a young African man; she was very friendly, helpful, understanding, really impeccable, and the lady who welcomed me was also a lovely woman. Outreach was full of praise for the team.

That said, the procedures need to be reviewed; by buying this key for 20 euros in cash so to speak, by not giving people a cooling off period and a second chance, they are forcing people to take the property. As a result, these foreigners are falling into an inextricable trap.

I found unpleasant and dangerous wording in the documents for all foreigners, namely that they are not allowed to own anything, neither in Belgium nor in their country. I had already read this in the invitation.

### **Offer from Woonhaven**

The main thing is that you arrive at Woonhaven without any assets, like people who flee a war or a disaster area, like the earthquake today in Turkey. This document states that. If you own or use property, such as real estate, locally or abroad, you are required to declare to Woonhaven the nature of the property or the rights you have in it. In the case of real estate, you must declare the country, city, street, house number, etc. If you have sold, inherited, received as a gift or disposed of property, you must declare the date on which this occurred, the place, the nature of the property and its price or value to Woonhaven.

This could explain cases that have not been clarified so far, such as that of the Fertoul family, which is a client of Woonhaven, which was recently allocated a new house in Kiel, precisely in De Vos lei, and they are owners of a forest in Tangier (Morocco), currently occupied by terrorist groups (possibly I.S. and Al Qaeda in the Maghreb) and by thousands of illegal migrants, the majority of whom come from African countries, but also from Palestine, Syria and Iraq, who want to transit to Europe.

In the last two years, a kidnapping has taken place in the Fertoul family. A young man with no history of the Fertoul family was abducted in Antwerp and driven blindfolded to [Tournai](#), where the kidnappers threatened to receive a sum of 500 euros or to break the young man's legs. The young man had to call his family and ask them to transfer 500 euros, which they did using Western Union.

Like many crimes in low-income groups with social housing, kidnapping and extortion have remained undocumented and unreported in the media, giving the impression that we live in a quiet country. The numerous bombings in the city of Antwerp in recent years show that this tranquility is only an illusion that was revealed as soon as the underlying economy, which carries part of the social system, was undermined.

The Fertoul family or the young man never filed a complaint with the police about this kidnapping, although I advised them to do so, because if it works once for the gang, it will probably happen again every time the gang needs money.

A year later, I found the trace of Mr. Geert Leysen who is part of the Fertoul family, and of the Brabant gang of killers, and who is especially linked to Mr. Lucien Leuwenkroon and his chamber of commerce in Morocco which functions in this way.

The intention is to further impoverish the Fertoul family so that they will part with their property abroad, which they will never do because it is ancestral land.

I think that what will happen is that the bilateral agreements with Belgium will be terminated to avoid all this and that Lucien Leuwenkroon, Ines Wouters and Geert Leysen will be tried for high treason towards a country that is not theirs.

For more information, please see the links to the files below. Please investigate the full situation of the Fertoul family at Woonhaven.

The Boudaich- El Morabit family was allocated social housing at the beginning of 2013 through the social rental agency Elk Zijn Huis in Tervuren. In the first few months, they had some unusual experiences, such as two home care workers from Soins - chez - Soi, who fatally wounded grandmother Mrs. Fatouma El Morabit on the orders of a person who was unknown until recently. What we suspect is that the old lady wanted to hand over her house in Tangier to her youngest daughter, Mrs. Fatima Boudaich, and that someone who had seen Fatima Boudaich knew something about this. It was not me. I even made sure that the street and the door of Fatima's house were not known to Mr Renson when he drove us home one evening. I made sure that she came to my home first. I am so suspicious when a racist suddenly takes an interest in foreign women.

This racist is Mr Daniel Renson who saw Fatima in [the meeting room of 352Biz chaussee de Wavre, 1040 Brussels](#), where I received her to see the cosmetic products I was presenting to take the photos for my online shop. Other people who saw Fatima Boudaich were the staff of the Church of Scientology where Fatima accompanied me to a rock concert one afternoon. There was a photo shoot with the musicians in which she and I participated. Two veiled women alongside the rock singers. It is possible that her photo was used in the plot with the carers of Soins-chez-Soi. Mrs Agnès Bron, director of public relations and friend of [Attorney Inès Wouters](#) (who is the defense lawyer of the Church of Scientology in Belgium) never wanted to give the photo to me or to Mrs Boudaich.

Mrs Fatouma El Morabit was neglected in hospital and died a week later. You can find the story in the files entitled "[Was Mrs El Morabit murdered by a health professional?](#)" and in Dutch you can find the story in "[I accuse Najat Sabir of the attack on the home of the mayor of Antwerp](#)".

The new owner of the little house in the oldest part of Tangier, with a view of the sea and Gibraltar in the distance, could be [Attorney Inès Wouters](#) under a false identity. That's how she does it. That's how she acquires the riads.

The importance of this house is that it is on the route to Europe for a large number of migrants who pay sums of between 5,000 and 20,000 euros or hand over their property papers to be smuggled into Europe and get social housing here. Many never make it.

In December 2014, the body of Ms Renata Bura, a Polish-Russian woman, was found in a flat in Schaerbeek in which she had recently been living. The landlord lives on the ground floor and wanted to receive his rent from her. After knocking on her door several times with no answer, he decided to open the door to see if she still lived there. He found her body hanging by a rope around her neck and called the police.

I had never heard of Renata Bura until I became homeless and was referred by friends who lived just around the corner in my old neighbourhood of Sint-Stevens-Woluwe, to a young Turkish man with a large flat and extra rooms in Saint Lambrechts Woluwe, in May 2015. I was allowed to take a small room in exchange for cleaning. The Turkish man's name was Mete Karvak and he would have helped Renata to get a replacement income from the CPAS (social

assistance) and social housing, in Woluwe-Saint-Lambert. He offered me the same help, but I did not rush in that direction.

When I started to clean up, I found traces of blood all over his flat, but especially a big blood stain that had dried on the mattress in his room. Apparently he discovered this at the same time as I did, and only then did he start washing all the clothes, even though it was 6 months after the fact. He's on medication to detox and he doesn't see these things himself. For 6 months he didn't notice the enormous blood stain on the mattress he sleeps on.

He briefly locked himself in another room where he began talking to someone on the phone. When he came out, he immediately ordered me to get out of his place as if I had done something wrong. If I wanted to leave by my own decision without saying a thing about what I thought was blood, he would have asked me to pay him rent or something so he could buy some weed. He wouldn't let me go, But I was sent away by order of someone who knows that I am not an idiot and that I might help the young Turk to avoid being accused of something; that's why I was sent away. It was someone who knows me that he was talking to and he was probably the murderer too.

I left in silence and was glad to be rid of him. As an immediate solution I was secretly received at Jeremy Rhoux's, who is Ms. Bura's lover, who told me his story and showed me his photos. When he went to greet the body of the young woman, he discovered a large wound on her head, like that of someone whose head had been smashed with a hammer, and wanted to know more about the exact cause. He finally took peace with the possibility that it was a suicide in which she had injured her head due to drunkenness, a real problem she had.

Although I showed no semblance of suspicion regarding Mr. Karvak, I immediately made the connection with the large stain on the mattress and the numerous dark drops which turn red when touched by water. The drops were all over the walls and cabinets all the way from the bedroom to the exit, suggesting that it must have been a struggle for life that the young woman had lost, after which her body had been dragged outside (she was a six-foot woman) and then hung in her new flat to make it look like a suicide. There were still long trails of blood stains underneath certain objects.

I thought I was doing the right thing [by reporting my discovery to the police in Etterbeek](#) to avoid possible friends in the municipality of Mr Karvak in Woluwe Saint Lambert. The inspector didn't find Mr Karvak at the address I had given, he didn't find anything worrying in my story, and he didn't make a file. Like almost all the policemen here in Belgium he told me that it is not proven that it is blood and that anyway there was no reason for me to panic because I am not there anymore. So he finished his investigation. At first sight it's disappointing, but I think that the policeman immediately understood that it was an international crime because of the number of nationalities involved (Turkish, Polish, Russian, Moroccan etc). With that, I left Brussels.

On the basis of the Woonhaven documents, I understood why she would have been killed: her property and inheritance in Poland and Russia, where the father and mother came from respectively, and where she lived before coming to Belgium. In her social housing documents, she will have mentioned in good faith her property and inheritance rights in Poland and Russia. This is how foreigners are attacked and abused in Belgium, which is considered racism, but it is more than that.

This already brings us closer to Inès Wouters regarding property and heritage in two countries currently in the line of fire of the war in Ukraine.

As for the possible culprit, my attention is drawn to Mr Pascal Marit, the son of my former neighbours at Rijmelgem 10, 1932 Sint-Stevens-Woluwe. I could be wrong, but I wondered

about Mr. Karvak's supposed contacts with the mafia that has been pursuing me for years. Mr Pascal Marit seems to be the most likely contact given that he has potentially carried out similar missions in relation to wills and inheritance in Morocco. He would do anything to keep his job at Volkswagen, including committing murders, doing everything to blame the death of the woman on the Turk, under the protection of a lawyer.

The connection between Mr Mete Karvak and me is Elisabeth (Else) Vermeiren. When I met Else Vermeiren, a very quiet and gentle woman of my age, we exchanged phone numbers. She was very interested in astrology, so we spent many pleasant afternoons with mint tea and honey. For a visit, we agreed to phone each other. That's how the neighbours found out who I was hanging out with in the neighbourhood. [My phones in Rijmelgem were tapped](#).

A few years after we met, Mr Mete Karvak became a friend of neighbour Els Vermeiren. She sometimes told me about him without me meeting him or seeing him until I needed shelter.

What binds them together is horse betting and the pot they smoke almost daily. It seems to me that he made it easier for Els to get access to weed but her friend Camut, like me, did not get along with Mete very. Camut is a cheerful intellectual and Mete is a depressed person, he has no specific interests and does not try to understand anything about his own life. This is also why he never bothered to understand what happened to Renata Bura. Like everyone else around him, Mete Karvak repeats what he thinks he understands when he went to greet the body of Mrs Renata Bura in the morgue, namely that she hit her head while drunk (as always) and then hanged herself. I think a proper autopsy can determine whether she was already dead before she hung herself.

The connection between Mete Karvak and Pascal Marit is not clear, but perhaps they have a third party in common. I have no information about the private life of either of them except that Mete Karvak's parents are very rich and live in Moorsel in a villa where Mete has his official address. He showed Else around and she was very impressed, especially with a meeting room with a huge table like the one in President Putin's Palace. Everything suggests that this is a very important business, but no one knows what these people are involved in except that it has to do with foreign countries and Turkey in particular.

Apart from that, the two men have in common the neighbourhood where I lived. Pascal Marit has his mother who lives just below me and to lose weight, Mete takes a walk with his dog almost every day from Woluwe Saint Lambert to Sint Stevens Woluwe to Else's house in Woluwe dal. He usually goes to see her very late after 10 pm.

Another possible link to the mafia could be the apartment building where Mete Karvak was hiding, which is located Chemin des Deux Maisons 61/21), 1200 Woluwe Saint Lambert, which is not his official address. It could be a social housing complex where you have several blocks in a row that look exactly the same, in a rather posh neighbourhood. The result on Google street view is this:

The building has been rendered unrecognisable on Google Street View. I wonder why, how much it costs and who pays for it. It shows that Mr Karvak is of great interest to someone.

Since this is a social housing building and Mr Mete Karvak had received a flat as a gift from his father, the court could determine whose hands this flat was sold from. From there, we can find clues as to who might be pulling all the strings.

Typing in another number allowed me to capture the image of the building. Let me warn you that the house numbers on the Chemin des Deux Maisons are not logically ordered. from

house number 4, you move on to house number 34, and a few metres further on, you suddenly find yourself in the hundreds. Unless someone points out the entrance, you won't find the place.

I noticed very few children in this part of the commune when I was there in late April, early May 2015. Most of the people who live in these flats are on social assistance, pension or sickness, but the poverty is not seen in this part. It can be seen in another part of Woluwe Saint Lambert, near the Clos du Lynx, where there are old blocks full of foreigners.

Another striking observation is that I did not see any Arabs or Blacks living in the locality, which is an indication of a racist policy in this area of the municipality. A sad experience in this sense was the sudden closure of Mr. Samo Ferman's telephone shop in May 2009 on Prince Héritier Street. He took over the phone shop from a Pakistani who had been running the shop for 10 years before the takeover. Mr. Ferman, originally from Armenia, had been running the shop for just 4 or 5 years until he found it closed one morning on the grounds that the space was not reserved for a shop and that he had never applied for planning permission to open a shop there. Given the arbitrary way in which the young man and his brothers were put out of work from one day to the next, this was a political decision. Someone very jealous knew that I used this place to prepare the business plans I sent to Saudi Arabia and to send faxes like the one for the Mohammed V Foundation for Solidarity. It was on the side of the recipient of the fax that the sender's fax number became known although I was careful enough not to give it. I have to be this careful with Morocco.

Do you think there could be someone called "Wouters" working at the Mohammed V Foundation, because that is how this vile species develops a hold on whole countries and people they want to enslave.

It's a species that wants to have the money first, and for that reason they will dominate the foundations, and some banks, including the World Bank. That's why I went to the foundations where no Wouters exist, [like Kingdom Foundation in Saudi Arabia](#), but they intervened anyway, I don't know how but I am submitting the case for verification to the Saudi state security.

If this case concerning Ms Renata Bura is now brought to the surface, you will see a spat between Mr Mete Karvak and Pascal Marit. We could have known the truth about the alleged murderer much earlier if the police had launched a DNA investigation when I reported the case, and if they had arrested Mr Mete Karvak as a suspect so that he could defend himself.

As for Mr Pascal Marit, not only do I think he is the racist murderer of Ms Renata Bura, but also of Her Royal Highness Princess Diana. I have been thinking about him for some time, as my brother and I almost had a similar accident in 2004. We made an appointment by phone to buy a second-hand computer at Mechelen Industrie with my Peugeot 205.

Someone knew we had this appointment and followed us on the motorway from Zaventem to the Mechelen Industrie exit where the car behind us was rushing into mine at breakneck speed. I was at the wheel and made that car drive itself off the road almost into the trees, staying on my path.

I suspect that it was Mr Pascal Marit who followed us, and perhaps he took revenge for this failure a year later, in June 2005, by unscrewing the chassis of my Peugeot 205, which fell apart while I was on the road, fortunately not on the motorway and on a Sunday when there was no traffic. He also took revenge by drilling underneath my balcony, to make it unstable and to cause me to fall down. As you understand, I have to be on guard all the time in Belgium

against psychopaths. It is tiring to live in this country, when you have to fight all kinds of aggressions all the time including fake accusations.

I remembered the last words of the Princess of Wales. According to the only survivor of the accident Mr Trevor Rees-Jones, she saw a car coming and thinking of others first, she instructed her driver to let it pass. I used to think like her too. Now, living in a country like Belgium, going out of your way always means colliding with someone else or with something else.

If I think of Mr. Pascal Marit, it is on the basis of the enigma about the white Fiat Uno hitting the black Mercedes of the Princess which was thrown against a pillar, then the wall, then that car started to tip over in all directions, while the Fiat Uno disappeared and remained untraceable for days. That morning, nobody saw a white car anywhere in the streets of Paris. Even the paparazzi don't know in which direction the car disappeared.

How did they do it?

[In another file, concerning the trafficking of women](#) by one of the members of the Brabant killers, the [unknown person whose name is M. Daniel Charles Renson](#), an inhabitant of Saint-Josse and originally from Liège, there is mention of a bakery in Paris called [Le Coin Du Pain Les Lilas](#), 15 Bis Avenue De La Porte Des Lilas, 75019 Paris 19, Siren number: 419872338, Siret number: 41987233800035 (head office), Intra-Community VAT number: FR52419872338, of which he is the proprietor under the false identity of Vincent Duprêtre.

This bakery undoubtedly uses [Leemans Transport](#) to deliver goods worldwide. The Brabant killers are all shareholders of [Leemans Transport](#), which only has trucks, one of which was used in the terrorist attack in Nice on 14 July 2016.

The bakery [Le Coin du Pain](#) is not terribly far from the Pont de l'Alma, I imagine that the white Fiat Uno which was probably intentionally chosen for its small size was speeding towards the exit of the tunnel not only because there would be casualties on that side, but also because it had to disappear before the arrival of the police and the ambulances.

With all the elements taken together, it is likely that the Fiat Uno was inserted into a truck to allow the Brabant killers to go away quietly, much like the photo below). By the time the Princess of Walles was declared dead at 4 a.m., the Brabant killers had all returned home, with some of them nursing their wounds that would have caused the scars I noticed on the face, throat and neck of Mr Daniel Renson and Mr Alfons Nuyts.

The former explained to me that the windscreen had shattered in his face during a rally without saying where. It is clear that he did not receive professional care. The second one doesn't explain anything because his injuries were probably professionally treated in a hospital in Belgium, and this within hours of the accident. I mean a hit-and-run accident.

The driver who is more capable than all the others among the whole gang of [Brabant killers](#) to target his car route with perfect precision and to beat an opponent (like the Mercedes), is Mr. Pascal Marit because he participated in the rally car championships in the forests of Belgium and in the Moroccan desert. All his cups from these competitions are at his mother's, Mrs. Marie-Louise Marchand, at Rijmelgem 10, 1932 Sint Stevens Woluwe, and also in the basement next to the garage.

In 1997, I did not know Mr. Pascal Marit but he was certainly still young, too young to decide himself to rally under the Alma bridge in Paris, but he was probably influenced by an older person who provides protection from prosecution. I am of course thinking of [Attorney Inès Wouters](#), who inspires young or vulnerable people to promote themselves by committing extremist acts. [The link between Mr. Pascal Marit and Attorney Inès Wouters is the SNCB \(Belgian rail\) and the pension of Mr. Louis Marit, Pascal's father.](#)

As she is a hardcore racist, she probably made it seem that the target would only be Mr. Dodi Al Fayed. On that basis, she finds cooperation quite easily around here, [including in the Belgian judicial system](#), when it concerns an Arab or a Muslim. The Belgian context, Mr. President, was never different from the one that led to the Shoah, in which similar acts were aimed at the Jewish people.

The credibility of the Belgian justice system to guarantee the rights of a person and to uphold the truth is at stake, if a jealous and hateful lawyer manages to set the whole legal system in motion against a person on the basis of false information, not to mention lies, simply because she is interested in stealing assets ([such as those that the candidates at Woonhaven have to declare](#)). She firmly believes that this works because this is her religion for which there is still no common name, but which her whole family and the families of the Brabant killers have been practising since the dawn of time, against the Jews, the Congolese, all Africans; all Arabs, Muslims...

The group is growing of victims of this racketeering practice in which masses of people are mobilised to take justice into their own hands on the basis of lies against an individual. Despite the existence of a whole democratic system with the possibility of involving law enforcement to keep the peace, people here still seem to resort to settling scores by group or mob attacks, as in the Middle Ages. They are the jury and the judge, and that is what Ines Wouters is. She wants to decide on your life or your death.

I don't know [what the precise lie](#) was that led to my arrest in 1990. [I don't know what she made the municipal administration of Zaventem believe so that they refused to register me in their municipality](#). I don't know how she changed the attitude of [my neighbours, the Marit-Marchands](#), Mrs. Sonia Meylemans, to follow me on the motorway, to unbolt my car, to unbolt my balcony, [to poison me with diseases](#), to organise [my eviction](#). All this happened to me without me knowing who is doing all this until [2012 when Attorney Ines Wouters appeared at a UN conference for young people organised by the Church of Scientology](#). I didn't know it was her until she insulted me in her office at Afschrift by offering me a social housing right away while a Moroccan parliamentarian advised me to transfer the capital.

Apart from the venomous jabs from a woman I had never seen or known before in my life, the fact that she is offering social housing is an indication that the social housing sector is her personal property. The unfriendly pokes in the conversation with her are predicting a poisoned gift she has for me. As she is someone who I have never seen before in my life, this led me to conclude that she has at least one problem with me which might be rooted in the court case in which there is a gruesome murder unsolved and closed, because it concerns a Jewish woman, [Mrs. Denise Janssens](#).

Allow me, Mr. President, to include my last two letters of pardon to His Majesty the King of the Belgians, in which you will find different approaches to the case of false visas aimed at Moroccan nationals in Belgium, [a letter of pardon to His Excellency Donald Trump who lost the elections](#) probably due to a mobilization of new Americans who bought American papers with a false identity in it and [my letter to President Bennie Thompson of the January 6 Committee which examines the fraud during the elections](#).

In order to find out who decided to sue me and throw me in jail, I started in 2016 to find out by asking anyone about the lawyers who refused to defend me properly in this fake visa case, who are called [Attorney André van Lidth de Jeude and Attorney Kristin Stas](#), until someone answered me "yes the first name rings a bell". The witness is Mr. Niall O'Quinn, a Northern Irishman who lived in Antwerp and who told me about the war in his country which was a Belgian war. According to him, [Attorney André van Lidth de Jeude](#) is a gangster and [a murderer](#) involved in financing arms for the belligerents. You will find [his picture](#) at the bottom, in the middle of the collection of the Brabant killers' faces.

What kind of badge does Attorney Inès Wouters use to rattle the police and customs at Brussels airport?

Niall O'Quinn also told me about a Belgian lawyer who pretends to be the Belgian state and is involved in sending fighters to Belfast under false identities. It's [Attorney Inès Wouters](#). When they return to Belgium, she is waiting for them at the airport with security guards by her side, and she holds a special badge that allows her to pass anywhere she wants, which she shows to the customs officers who fearfully step back and let her through. I really wonder what this badge is. He couldn't explain to me what is on the badge, but she uses it in case someone is arrested based on doubts about the papers. Niall O'Quinn himself entered Belgium in this way with his comrades. At that moment she immediately confiscated all (false) identity papers and put the fighter in a fancy armoured limousine to take them to the Metropole Hotel at the Place de Brouckère. He did not exclude that she has relatives in the airport security who collaborate with her, perhaps with the name Wouters as in all transport companies in Belgium. In any case, Ines Wouters seems to be a woman who is far too busy preventing any information from coming to light. If she wants this, she has to let people live in peace, otherwise people will break her and all her dirty business.

When I told him that the judicial police had come to search my student room for fake visas, he burst out laughing and said: 'the judicial police will find a lot more if they search Ines Wouters' house'. She is the one who fits the fake visa element for which I was tried and which I could not explain.

[In November 2016, Mr. Niall O'Quinn was murdered in a shooting ranch in Antwerp](#), probably as a result of [the interview he gave me under a false identity on all aspects of International terrorism](#). In my opinion, the financier is Mrs. Ines Wouters who started to execute all the witnesses or any person who collaborated with her in order to launder money; like [Mr. Louis Marit \(Pascal's father\) who probably laundered dirty money accumulated in Morocco by a chip shop](#). For all the others, it is only a matter of time.

As I am a witness of the fake visa case in 1990, Mr. Mete Karvak was part of this big plan to get me into the social system of Woluwe Saint Lambert, which will allow them to know where I live and end up like Mrs. Renata Bura. I detected this racist religion acting on me quite quickly after my arrival at Mr. Karvak's, which made me get out of there quickly.

When I arrived at Mete Karvak, we were guests at Robert and Bénédicte Lamotte's house (Chemin des Deux Maisons 63/28), 1200 Woluwe-Saint-Lambert. Mrs Lamotte has known Mete for years. She was a model and her family had a chain of shoe shops. They were very rich and she was the only heiress. Her life changed after a car accident in which she almost lost her life. The car was a total loss and she underwent many operations on her neck, legs

including her face, and years of rehabilitation. I think she told me that they never found the perpetrator.

It was by listening to her story and comparing it with my story and the story of a Flemish friend from Zaventem, Mrs. Danielle Stoop with the same profile of a model with a rich inheritance who had a very serious car accident on the motorway in 1994 (while on her way to an appointment with me), which put her in a coma for several months, and that the driver of the opposing car was never found, that I knew that the Enemy was not far away. He could be the great specialist Mr. Pascal Marit whose favourite sport is rally cars. It is probably his favourite weapon too, which he uses to please Attorney Ines Wouters.

In my opinion it is she, Mr. President, who uses the Brabant killers to further her interests or the interests of her family. As a lawyer who promises to protect them from prosecution, she is in control of all their crime files with which she might as well crush them. I can imagine that sometimes they have no choice but to do what she asks or go to jail. In order to stop the violence, aggression and abuse that has been increasing lately also against the Belgian population, I think that the removal of Ines Wouters from her position as a lawyer is an improvement. It is so simple.

My stay at Mete's house lasted two or three days, during which he offered to arrange for me an income from the OCMW ( PCSW), and a social house too, if I wanted. However, the people around him whom I met on the first day and who compared me with Mrs. Renata Bura, told me about the arguments he had every month with Renata to get her to give him all the money she receives from the PCSW and that she tried to keep some of it to feed her 3-4 year old child. The social housing he paid for with the help of an accomplice in the municipality, was used to be able to knock on her door every month as soon as he knew that the CPAS payments had been made.

I kindly thanked Mr. Karvak and promised that I would think about it and see how it goes between us. I took my things out in small packages, to go out lightly at the end. The decisive moment was during the cleaning. This is where you see the death of Mrs Renata Bura, which must have been excruciating because the traces of the struggle in which she must have lost a lot of blood were visible all over the flat. This is the kind of stain that you normally find in a slaughterhouse for horses.

I left some places untouched during the clean-up, taking into account the inherent lack of cooperation from the public security services at the time, and with the hope that someone would one day take an interest in the fate of Ms. Bura and her child. Her case was filed as a cold case. That is how powerful the Wouters seem.

After my disappointing visit to the Etterbeek police, I passed the whole story on to the Arab governments who are criticised for being inhumane and violent towards women who allegedly have no freedom, for being corrupt, for funding terrorists, and for exercising the death penalty; etc. "[She would have hanged herself](#)," I told them. Now I will pass the story on to Russia and Poland to ask for the autopsy report and explanations from the Belgian government. I hope for Belgium's sake that [Attorney Inès Wouters](#) is no longer a lawyer at this time.

You will find all the documents transmitted on [this link](#), which contains [a judgment concerning a fake visa scam in Antwerp targeting Moroccan nationals in which I was accused](#) while having the documents related to a visa application concerning a Lebanese citizen named Mr. Béchara Matta. It turns out that his visa might have been arranged by the lawyer Inès Wouters, for a client of Afschrift who paid 20,000 Belgian francs. I was arrested, [imprisoned](#), tried and [fined](#) and I have never seen a fake visa in my life, while all the police had to do to verify the

documents they found in my house was to question the people mentioned in them, who are Dr. Amine Matta and his brother Mr. Bechara Matta, which they did. Béchara Matta, which they did not do probably out of solidarity with the person who made the complaint and who made me look like a danger to the security of Belgians, and it works as I said above. I think Dr Amine Matta is a client of Afschrift Law Firm where he paid the bill of 20,000 Belgian francs while the price of a visa is 80 Eur (3,227.19 FB) possibly to Attorney Inès Wouters. This is too expensive in addition to deviation from the scope of what a tax law firm is. They don't deal with immigration.

Justice did not check this. They focused their attention and resources on checking an innocent person. They should not complain about the lack of means of the judiciary if the investment goes to support the forgery, to postpone trials, to decide that the prescription period has expired, and to lawyers like Mrs. Inès Wouters who uses false identities to cheat the CPAS, to open bank accounts abroad and to be able to say that Muslims are doing all this. I'm sorry, but you can't say that there is any justice in Belgium with all this.

Belgium deserves no more oil or anything at all until they solve all the unsolved cases to teach them to take action when it is feasible. They solve problems by letting murder cases go by, with statements like the police inspector's who said to me "it hasn't been proven that it was the blood you found" so they can say at the end that the statute of limitations is up. I, who have no home and no money, am supposed to arrive at the police station with laboratory evidence, and they have laboratories with an army of people working in them. This country deserves a country like Iran and Russia as its only trading partners.

Given the above cases, it seems that it is better to have no property at all. You are expected to own nothing if you are housed by Woonhaven, as if owning nothing is what people seek. The condition for being allowed to stay there is that you do not acquire any assets.

One can be reassured for a lifetime as far as housing is concerned, but progress stops at Woonhaven, for the poorest group in society once they accept a house through this rental company, given that a secret group has access to the data on the properties acquired by each tenant, especially in the country of origin,

It is for these reasons alone that Inès Wouters is very fond of bringing in as many migrants as possible, preferably Moroccans Who because of the low price and good quality of the accommodation take it. Only years later, they feel that they have been trapped.

There's worse: Moroccan politicians congratulate Belgium for its social housing policy thinking they are doing the Moroccans a favor. That's why I didn't argue with the MP when he asked me to see lawyer Wouters. Saying no to people from a country that helps Moroccan migrants to be housed is an insult. We would not agree, and that is why I kept silent, but it is colonization that they seem to like in Morocco. This has been my observation since 2004 when they unwittingly leak innovations to the Enemy.

People gain security with cheap accommodation in Belgium, but risk losing everything in the country of origin, to which most are thinking of returning, simply because a mafia has asked to fill in the details of the declaration of honour concerning the ownership conditions.

This means that 36,000 family members in Antwerp will not be able to contribute optimally, as poverty will continue to grow for all, both here in Belgium and in the country of origin, and this is not the purpose of a social system.

### It is economic exclusion

This is a case for the European Court of Human Rights. If Belgium does not sue those responsible, I call on the United Nations to sue Belgium for the way migrants are being mistreated here by a group of criminals who have been allowed to go free for four decades, while committing bloody attacks on their own people.

No one in my family has ever been a tenant in social housing because of the bad reputation of the social housing sector and the social system in general. There was a time when, through [Flora Vrouwenwerking](#), the pressure was so great on my parents who were falsely accused of deliberately dilapidating the house at Eendrachtstraat 28, 2060 Antwerp.

They tried to force my family into social housing, but fortunately they already owned property in Belgium so they were not entitled to social assistance in general. They tried to push them down. You can find this story in an [information request to put Mr Stephan Van Collem in the proper context of the Rombouts construction company accusing everyone of wanting to dilapidate their home](#) and in the related article on [the disappearance of at least 10 young Moroccan women in Flora Vrouwenwerking](#), probably in the same race to get their hands on properties in the victims' country of origin.

[Flora Vrouwenwerking](#) is a NPO (non-profit organisation) similar to CAW Outreach and many other NPOs that support and guide migrants to social welfare and social housing, on the one hand to artificially increase the demand for social housing and on the other hand to find out where migrants have property in their country of origin, and to prevent these migrants from acquiring other property.

For example, [Mr. Daniel Renson](#) followed a beautiful young Brazilian woman who was following courses like a mini MBA to obtain a certificate of aptitude for running a small independent business at the non-profit organisation Progrès-Vooruitgang VZW, where he was the business coach who wants to help young migrants to prepare a business plan.

Of course, this is how these young people end up revealing what they have as capital in the first place. In Belgium they usually have nothing, but in their home country this ambitious group usually has something, even if it is just an olive tree or even a hut. The wonderful young Brazilian woman had a coconut plantation that she wanted to make profitable.

He told me about her far too often because he thought that I would be interested in vegetable oil producers and he was hoping to learn more about cosmetics I was making if he introduced me to her and to spy on me in this way. I never saw her or asked to see her and I made him wait. It is precisely for these reasons that I leave him out of all my multicultural diversity projects. He seeks to establish settlements to exploit the locals because he is used to the enslavement of others and like the whole gang of Brabant killers, he is incapable of achieving property other than by theft. I seek to exclude him and his band of racists, as they do to others.

Daniel Renson offers help in financing the creation of businesses by migrants, even if they do not have the necessary guarantees here in Belgium or even if they are on the blacklist of the Belgian credit bureau. He accompanies the migrant entrepreneur to the bank as an associate partner with the business plan and he always manages to get the loan he wants. By telling me this many times, he hoped that I would ask him to get me the loan I want, but he never said which bank he goes to for this kind of business which bypasses the central credit office, and that is what I remembered.

The bank he probably goes to for small business loans would be Deutsche Bank to which he invited me one evening in Charleroi where they gave a presentation on the Brics countries. There was a drink after the presentation where he introduced me to some people he knew to talk about my plans, but I kept quiet because I knew the bank was not German, but Belgian.

To be honest, I knew it was a Nazi bank and the official European branch of the World Bank, and it is the equivalent of BNY Mellon which is also a Belgian bank, just like [the World Bank](#). These banks do what [the World Bank](#) cannot do because it is not officially registered as a financial institution, so it cannot give loans to small businesses and it cannot take legal action to recover money owed.

Mr Daniel Renson obviously has friends at Deutsche Bank who help him to easily grant loans that the starting migrant entrepreneur will not be able to repay. Imagine that the young Brazilian woman accepts his help to get a loan in Belgium and gets it before she has her first clients. She will probably find it difficult to pay back the full amount to the bank in Belgium.

Mr Daniel Renson's contact at Deutsche Bank could probably be someone called Wouters, for example [Luc Wouters, the Vice President of Deutsche Bank \(DB\) in Brussels](#). Mr. Wouters joined DB as a trainee in 1987 and within 7 years would have risen through the ranks at this bank in Brussels to become Vice President in 1991.

Immediately afterwards, in [2005, he left this important position to become a simple branch manager of a smaller bank, Van Lanschot Bankiers](#). He probably went to work for his own client when he was vice-president of Deutsche Bank. He may have left Deutsche Bank at the time when [Progrès - Vooruitgang vzw](#) for the integration of immigrants was founded in Sint-Joost-ten-Noode, a municipality of Brussels, [on 27 January 2005](#).

At that time, Mr. Daniel Renson was negotiating with His Excellency Benoît Cerexhe, then Minister of Economy, Employment, Scientific Research, Fire Fighting and Emergency Medical Aid, as well as Agricultural Policy of the Brussels Government, to subsidise his asbl Progrès-Vooruitgang in Sint-Joost ten Noode. Mr. Daniel Renson pretended to be the director and was accompanied by Mr. Levon Muradyan, a defender of the rights of undocumented migrants, who became the manager of the non-profit organisation, which aims to provide training in business management, languages and IT. He often told me about it, probably to make me want to propose mine so that his gang could hijack them. "But I don't trust anyone in your country", I said.

The focus on migrants was never that important until they heard about the [Center for Excellence in Diversity Competence and Globalization](#), I think that in Sint-Joost-ten -Noode not much has changed and that poverty has increased despite the non-profit organisation [Progrès-Vooruitgang](#) being established there.

I don't know the amount of subsidies released by the Brussels government, but the departure of Mr. Luc Wouters to Van Lanschot Bankiers around the time when the non-profit was founded, could give an indication of the financial mass they were hoping to obtain within the framework

of the non-profit organisation Progrès Vooruitgang, or rather the Groupement d'Intérêt Social (GIS) which consists of several units, of which only one is visible and accessible to all.

He would probably have changed jobs to launder for his new bank the mass of funds in the framework of the start-up loans that Daniel Renson was setting up for young entrepreneurs of immigrant origin, often excluded from financial and economic opportunities in Belgium. He would write business plans for them to accompany them to the bank, which could be a combination of Deutsche Bank and Van Lanschot Bankiers. Why two? Because the real wish of the Nazi minded people is to crush the immigrant from several sides, and therefore with several banks, in order to better play with their fate.

One bank will provide the necessary guarantee so that the other bank can provide the desired credit. Thus Van Lanschot Bankiers offers the bank guarantee service, but apparently only for Dutch speakers, as the same service is not offered to French speakers.

This is already a reason in my eyes to close this bank and the Deutsche Bank as well now. It is a bank that seems to favour some and disadvantage others, and feels good doing so.

I discussed the issue of financial favours in the case of the migrant-owned Dims bakery with a lot of concern about who to pay first with the cash flow compared to a Belgian-owned bakery like Bakkerij Wouters which can pay everyone on time thanks to the cash advance service that banks readily provide to local business owners, and with difficulty or not at all if the business owner is a foreigner.

When Mr. Daniel Renson offered me his service to get the credit for realizing Anacell Biointelligence, I made him understand that he must leave me alone with his simian approach to my business.

The obvious plan of Mr Daniel Renson, whose mind is shaped in this way, is to favour someone Belgian with the young immigrant's business plan. At the same time, he will indebt the entrepreneurs by denying them access to markets and partnerships, depriving them of information about opportunities, charging them high fees for utilities and telecommunications, and sending fake bailiffs to collect payments or seize their assets. In this way, they will get the young entrepreneur to sell his assets to the Van Lanschot Bankiers for nothing in order to give it to the young Belgian entrepreneur, who often is a member of the Wouters, Renson, Rombouts, Leemans-Leuwenkroon, Willemyns, Verhoeven, Michiels family, to name a few.

This is the norm in Belgium because there is no counterweight to this form of slavery of immigrants and their families. This is what Islamic finance denounces. All Arabs know in advance that this species has a criminal financial behaviour. You see the proof.

That's why I think someone like Wouters would leave an important position to target large donations to "help" poor migrants to rise. Progress Vooruitgang promises "Creativity, Initiative, Work". They are bums!

[Mr Luc Wouters left Van Lanschot Bankiers in 2009](#). This corresponds to the period when Progrès Vooruitgang decided to dissolve the ASBL (non-profit) while the institution continued to operate.

The corresponding statutes were removed from the database at the Moniteur belge, because they put the ASBL back into assets to demonstrate that there was no interruption, and presumably with the aim of diverting public funds intended for the integration of immigrants in Brussels.

I remember that the dissolution was decided without the knowledge of the managers who is an Armenian and a Russian woman, namely Mr. Levon Muradyan and Mrs. Irina Mkhitaryan, who continued to work in their shop out of sacrifice for the foreigners in difficulty. At that time they were beginners themselves. I don't know now, but at that time they didn't know how to draw up the statutes and organise the registration of the association with the legal, tax and economic authorities. Mr Daniel Renson did not teach them how to file an annual balance sheet, which does not exist for any of the associations. He did not show them anything financial, but he wants people to show him everything.

I will be able to find the file with the exact logic of the scam to which these two foreigners were exposed in my archives, and communicate it to you.

The data at the Crossroads Bank of Enterprises shows at least one double entry of the same organisation, under the same name, but once in Dutch and once in French, which could be an indication that they sought funding from the government of both communities on the basis of language courses.

To perpetuate this system of misappropriation of social funds and aid, the subsidies have undoubtedly been used to finance international terrorism and the wars that make people flee to Western Europe. They have chosen the Arabs to encourage the rich countries of the Gulf to commit themselves to humanitarian aid, as the same mafia is accustomed to doing with the Palestinians every day. This humanitarian aid is channelled through [the IMF](#) and the [World Bank](#) and [the International Federation of Red Cross and Red Crescent Societies](#), whose account is held at [Credit Suisse](#), whose majority shareholder is Qatar (hence the Qatar Gate in the European Parliament, which also implicates Morocco in the corruption of officials).

All this game is a case of the Wouters family that I wish to see tried at the International Criminal Court where the reference number for all my research files is OTP-CR-322/13 .

The successive crises took shape in 2011 in Tunisia with the Arab Spring. The code that might refer to this is "GIS". This almost reminds us of the GIA (Groupe Islamique Armé de l'Algérie), as Mr Renson is obsessed with Algeria for a woman they apparently did not want to give him, and rightly so.



Mr Luc Wouters joined a recruitment company. He does global executive search at Odgers Berndtson where he is a director. Based on the same activity that Mr. Daniel Renson started in the same period with his CEO Europe, I think he means [executive search](#) like these:

That's Progress - Vooruitgang. This is how they like diversity in Belgium. Here are [the rates for recruiters](#). It starts at 2000 euro just for the interview

If I think this, it is because Mr. Luc Wouters could be from the same family as the lawyer Inès Wouters, who financed the Islamic State through Islamic finance I suspect. She ensures the presence of the Wouters in all the cities of the country and in all the institutions, [including the Belgian Central Bank and through this the European Central Bank where she has someone who only deals with the macro economy, as if this economy](#) is self-supporting.

This domination of the upper echelons of Belgian society means that absolutely everyone is afraid to help the Moroccans, for example, or afraid to refuse to do harm to others when the order comes from Attorney Inès Wouters. Because of her, Belgium is a dictatorship and the social housing sector is a living expression of this.

For example, they have the keys to the mailbox and they will be able to prevent communication, work contracts or invoices from reaching you, until the day you see a bailiff who will tell you that he has warned you several times "but you have not reacted". You don't know how to respond because you don't think about this kind of sabotage. They are like that with all foreigners, and they wonder why I can't stand their faces.

What supports my opinion that Mr. Luc Wouters could be related to Ines Wouters is that he is probably related to [Mrs. Anne Verhoeven](#), since, the residence of the Vice President of Deutsche Bank Belgium in Heverlee is located at a stone's throw from the residence of [Mrs Anne Verhoeven](#) in the [centre of the old town of Leuven](#).

He is also a neighbour of Ms Kristin Stas, who probably did not present the alibis that I sent her to the courts, which prove that I could not be present at the meetings on the dates indicated by the Belgian courts. I imagine that the lawyer acted on the orders of someone who could be behind the significant change in the material state of this young lawyer who was a trainee at Peter Roosens lawyer's office, when I solicited her for the first time, and who became a lawyer with her own office with an assistant in a mansion in Heverlee, in one year time.

This shows how failure is manufactured for foreigners in Belgium. It is through the justice system as an institution that has many dishonest people and even perverts inside. The parents of the missing children can confirm this.

There are masses of ASBLs in Belgium and they are never subject to financial control except in the case of politico-judicial cases such as the current Fight Impunity because this organisation disturbs those who want to maintain impunity forever and it is founded by foreigners. There are searches, arrests, interrogations, loss of parliamentary immunity and loss of reputation.

But organisations like Progrès-Vooruitgang, which receive subsidies and offer nothing special, nothing very complicated or very intensive, nothing that cannot be found elsewhere or in an

official school, these are not investigated. They are not investigated because they search foreigners and their assets as well as the land of their forefathers. This is the villainous way in which opportunities are sought in Belgium, instead of normally approaching the foreign government and asking "do you have land that we can cultivate? Why don't they know how to make deals this way?


Now, Deutsche Bank has 1,572 branches worldwide, including in Brazil with inside of it all the Nazi gangsters who have not been tried and their children and grandchildren, like Mr. Luc Wouters perhaps.

The help that Daniel Renson gives is to get the bank to give a loan secured by a collateral, like property, farmland, a house in the country of origin, like Woonhaven asks you to fill in the declaration form. In case of non-payment it is the branch of Deutsche Bank in the migrant's country of origin, like in Brazil in this case where there is a branch.

[All the Brabant killers and their helpers](#), and probably their entire families, have at least one bank account with Deutsche Bank in Belgium and abroad.

The recent trip of Mr. Peter Rombouts to Brazil could be linked to the plantation of this young woman, whose name I do not have, but I do have the name of the head of Progrès Vooruitgang, the non-profit organisation that realises regression through racism.

The Belgian social system should only be concerned with the functioning within the Belgian market. The assets abroad are linked to the functioning of another market and to a previous situation of a migrant, and have nothing to do with their situation in Belgium. If migrants become poor in Belgium, it is because there is a problem in the Belgian system and not always with the migrants.

The social model has not changed since the Second World War, when Victor Louis Leemans was in charge. Mr. Victor Louis Leemans is the father of Mr. Lucien Leuwenkroon, president of

the Belgian-Luxembourg Chamber of Commerce in Casablanca, Morocco, who may have organised his property development business in this way, through the social housing offices such as Woonhaven. Woonhaven could be a member of this chamber of commerce, which provides for illegal workers from poor countries to work in construction for a precarious wage in the black, otherwise they will not be able to rent at a low price of 310 euro per month, if they were to apply the legal wages for this sector, social charges, pensions and insurance. Hence my request for the shut down of this chamber of commerce. This will be a great help.

If Woonhaven wants the applicant to have or acquire no assets to qualify, it must apply the proportionality rule as in Islamic finance. This rule says: if you, as a company, impose this rule on the client, the whole supply chain in your company must follow this rule. If they ask me what I own abroad, they must first show me what they own abroad. If the shareholders, the management and the employees of Woonhaven want the applicant to have no property, then they too should not have any. If they do, it creates an ethical imbalance where customers risk being exploited by shareholders, which is likely the case at Woonhaven.

Woonhaven thus violates the principles  
of democracy and equality and the  
fundamental human rights, such as freedom,  
the right to property and the right to work. I mean:

If they take away your existing assets,  
so what's the point of going to work?

For more explanations on Islamic finance, please turn to the great specialists such as [Attorney Inès Wouters](#) who is professor of Islamic finance at the Catholic University of Leuven and she has acquired very interesting publications such as I.S.Finance

She was also a professor of taxation at the Université Libre de Bruxelles. An example of her business model related to migrants is the [Wouters bakery](#). She advises high net worth individuals who can sometimes be dangerous bandits, and very high profile companies such as [the Prince Jamal Al Noaimi Foundation](#) where I thought I saw [a gentleman like Salah Abdeslam under the name Omar Yahyaoui, the Foundation of the Princesses Jacqueline de Croÿ and Massimo Lancelotti](#) (who [had offered me a job by sending me to the CPAS of Saint-Gilles to ask for an integration income](#)), the [Lavazza coffee shop](#) which has probably expanded thanks to social funds, as well as the [NH Hotel group](#) and [Nanogenetics](#), a laboratory which is perhaps studying the activity of Sars-Covid.

Racism, discrimination and exclusion are economic strategies by which the world's richest 1% build their wealth. They lure people in with the promise of a better life. Once they enter, they are squeezed like lemons to the last drop, or even murdered. Whether they are illegal migrants from far away countries or regular migrants, the principle is the same. People are deprived of their opportunities, their money, their property and their lives.

Some people in this country allow themselves this simply because the others are foreigners, and this is the function of the Belgian social system. [Thanks to social housing, people like Attorney Inès Wouters and the rest of the Brabant killers gang know everything about the applicant's financial situation.](#)

It is not designed to contribute to the overall economy. To promote growth, I prefer to provide services to people who have assets to make them contribute; should I want social housing to be profitable for as many people as possible. Social housing is about sharing your happiness

with others. In Belgium, the system was designed by [cannibals](#) whose aim is to devour everything and everyone, hence the racism towards foreigners. The aim of racism is to intimidate people so to take away their place, their property or their rights.

Inès Wouters is supported by the OCMW in several Belgian municipalities under false Belgian identities:

I personally find Kiel to be an unsafe district with a high concentration of people who feel mistreated, who have no chance because of too many shortcomings that persist not for a few months but for decades, who experience more setbacks than successes, and who are at risk of turning to crime such as drug dealing, human trafficking, banditry, prostitution, in short, many problems. It all started with an offer for accommodation, which is warm, with water and heating costs included

You should also find out how they manage to heat these huge buildings for so many people who do not pay much rent. Below is an interview at the Princess Jacqueline de Croÿ Foundation on "where to dump the oil.

An example of an offence you will never hear about are the fake identity cards that some migrants are also offered for 500 euros instead of 21 euros at the town hall. You may remember the [story of Ms. Fawzia \(Fouzia\) Stitou that I reported in early 2019](#). Ms. Stitou is a Moroccan of Spanish nationality from Murcia. When she arrived in Antwerp, probably in 2015, she and her son were living with her sister in Kiel (Antwerp South), possibly in social housing. She has enrolled her child in primary school and is considering moving to Belgium so that her child can get a good education. For her son, she has stayed here and has applied for social housing like her sister.

I met her in the Victor 4 night shelter for registered homeless people, where we were gradually selected to join Victor 5 due to overcrowding in Victor 4. She was one of the first to leave overnight because of her invalid identity papers.

I did not see her again until a week to 10 days later when one evening at check-in they ordered me to go to Victor 5, where they provided me with a bed. The reason was that I was not registered with the social welfare centre (OCMW /CPAS) that funds the Victor 4 shelter. The Victor 5 shelter is probably funded by the European Social Fund for Migrants and Refugees.

In the refectory I met Fawzia again and that's how the conversation started about life without valid papers. My story was that the municipality temporarily took my ID card and gave a letter as a replacement until I had an address to get the ID card back.

Her story was different. She showed her ID card and had no idea what was wrong. She assumed that she had done everything right and was stunned that this was not the case at all, so much so that she suspected Victor's night shelter management of bad faith, blaming them.

Her question mark got even bigger because the identity card she had worked very well in the past. Thanks to this identity card she was able to enter her first social housing. This identity card ensured her a monthly social pension for over a year.

It was only when she moved to another neighbourhood because she found a bigger house, and when her social file was also transferred to another social welfare centre, that she was no longer able to obtain the same social rights as before.

The social service invited her with his identity card and then nothing worked. As it is an electronic card, the chip did not work. In addition, they informed her that she could not apply because she had lied about her ownership. She allegedly stated that she does not have a property. She argued that she had declared her property in Murcia when she first applied for assistance. She told me that the social services had cancelled her identity card and returned it to her. Suddenly unable to pay the rent, she was evicted from the house and ended up in the night shelter for the homeless.

I cautiously suspect that this is a fake ID. Everyone listening, including the administrators of the night shelter, booed at this possibility, especially as she had already collected benefits and also because this type of electronic ID card is difficult to forge because of the chip. I secretly stuck to my guns, because many people don't understand the whole Belgian social system, which consists of cheating people and money laundering.

I asked how she had obtained her identity card. From then on she started to explain things in vague language, including that she was helped to obtain a Belgian identity card for EU citizens via a contact she described as a Moroccan woman, presumably via a clandestine circuit in Kiel. The Moroccan woman assured her that she could help her obtain an ID card. She asked Fawzia for 500 euros. She helps her to fill in the documents. The unknown Moroccan woman filled in the rest and sent the documents to Brussels, Fawzia said.

Fawzia stated that she received her identity card from the Antwerp administration. With this card she could apply for social assistance, which she received every month. Her Belgian identity card was cancelled at the new PCSW because she had declared that she had assets in Spain, whereas the file indicates that she has no assets and therefore lied. She did not tell the social services that someone else had taken care of her files for 500 euros.

The other woman who "ordered" the identity card for her is said to be Ms Najat Sabir. She would have made sure that Ms. Stitou would not receive anything more than she is obliged to sell her house in Spain if she wants to stay in Belgium. This is the objective.

This is the system and in recent years there has been a large influx of Moroccans from Spain, like Ms Stitou, into Antwerp. Most of them live in social housing. So the demand for social housing projects is also increasing, thanks to the high number of Moroccans especially, to launder large amounts of money through construction.

Then, when the money is white enough, they hate and despise Moroccans outright, they make fun of the sex of Moroccan women and the academic results of all Moroccan children in schools, they ridicule all Moroccans looking for a job. We don't know how to help such people. That's why I say, if they want to get rich by laundering dirty money through high numbers of needy people, they should use their own people to launder dirty money, and leave the Moroccans alone.

If the Moroccans knew that there was a war in Europe and what the Holocaust was, they would never have set foot in that region, where one can only expect to be buried alive.

That's what I think Woonhaven is all about.

It seems that social housing with Woonhaven is an endpoint for many people who, instead of rising, are massively crushed in a mill of human destruction. Perhaps this is why the buildings are in separate areas like in camps. Even if they offer free accommodation, I don't want to move there.

Kiel is the area near Antwerp South station, which I mentioned recently in a letter to the 6th January Committee of about how false identities and passports are used to fight wars. I mentioned Mr Tim Fransen who identified a small plot of land to put his tent after he had been evicted from the Victor night shelter and after he and others had first been evicted by the police from the land around the night shelter, as if by persecution.

One morning, when he came out of his tent, he found a piece of paper stuck to the tree in front of him with a drawing that he also saw in Syria and Afghanistan where he met, according to his own words, Mr Stephan Van Collem. The drawing is used by the Islamic State to designate the next victim for beheading. He knew that the threat was real as in this neighbourhood a little further away (in the vicinity of the night shelter in Desguinlei) he was chased by a group of youths with knives, he received a bar on his skull, and he fought with undocumented migrants on several occasions. In the summer of 2021, he left Belgium to work in Greece for Frontex. In February 2022, he was in Ukraine.

He soon moved to another place, but he kept the same friend who was "the General" in the war zones, and who is Mr Stephan Van Collem. This explains the persecution of him. "The General" was probably trying to get rid of anyone who had seen him in Syria, Iraq and Afghanistan. He has achieved his goal, and he no longer needs to be friends with those.

In 2013-2014, there were a large number of young people with an immigrant background who went to fight in Syria. There are videos of young people talking to each other in Flemish in Syria. We hear more about this problem nowadays and we have forgotten that these young people come from social housing complexes like Woonhaven in Kiel where they were recruited, according to local community representatives. They invited these young school children to go on holiday to Greece or Turkey and they ended up in Syria immersed in the horror on which they responded with horror. They are selected to die one way or another. They are removed from Belgium so that this country's reputation will not be damaged for the death of a few Moroccans.

The young woman at the counter in Woonhaven said to me "but madam you are missing an opportunity for 310 euros a month rent to live independ. Most people take it straight away. It's the first time I've seen someone say no. You won't find cheaper".

Cheap is cheap. At that price, you can't complain because you don't mean much to the owners. When you really pay for quality, you have more freedom of expression because it costs the owners a lot to lose the income. That's the big difference.

All the above elements show that Woonhaven is part of a war machine of a Belgian mafia. I dare to bet that there is no legal complaint against Woonhaven, because whoever files a complaint will be out on the street. This is the worst punishment anyone can experience. That is why I suggest that the countries of origin agree to file a complaint against Woonhaven for the serious violations of human rights and for the infringement of territorial integrity by the unannounced misappropriation of private property, not to mention the "plundering of the property" of the economic victims.
