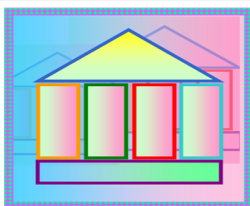

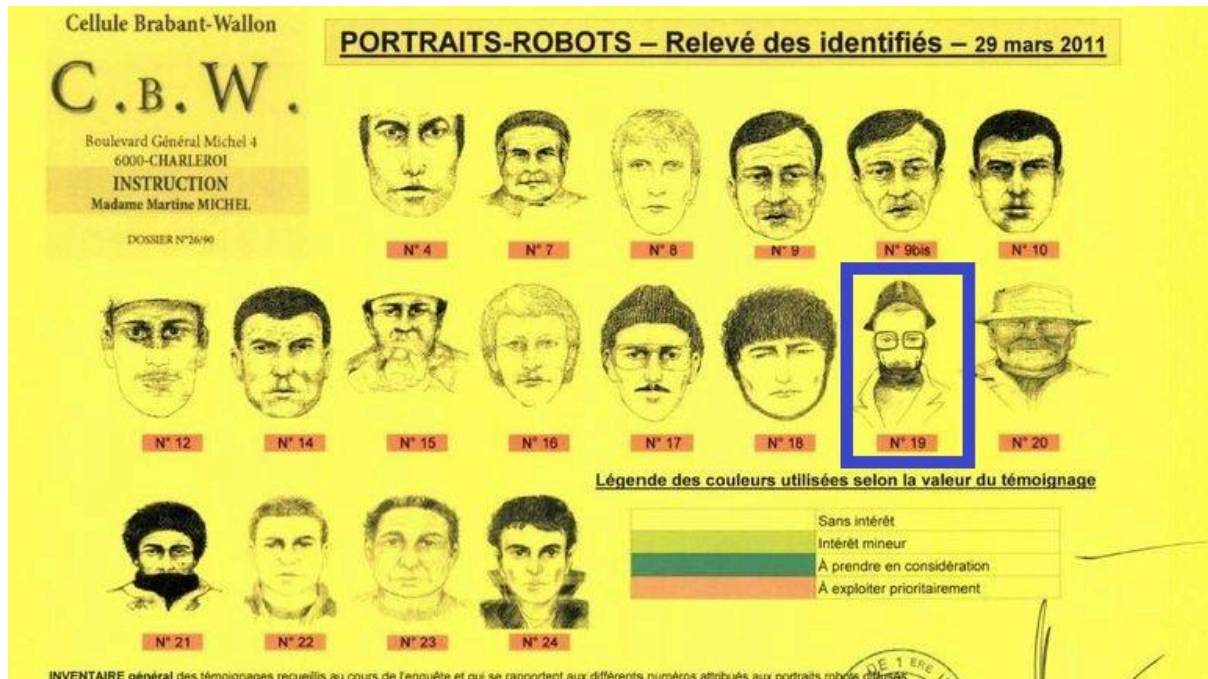
Mr Bernard Crépin resembles to 95 % to the first picture, which is [the robot photo of suspect number 19 of the Brabant killers on the wanted list of the Belgian Federal Police](#).

I notified this in [the first file of Leemans Transport](#), and I didn't change that information.

This picture was taken in Beirut in 75. It could be Mr Bernard Crepin when he was very young seen from the big eyes, the fine nose and the high cheekbones like [suspect n°19](#), as well as the small mouth and a thin moustache above the upper lip like the one of Hilter. The hairy chin reminds me of Bernard.



It seems that Mr Bernard Crepin has already worked previously with Alfons Nuyts on several occasions. In particular, they shot together at the Delhaize and Colruyt shops in Brabant between 1982 and 1986.



Mr Alfons Nuyts holds at least **9.5 %** of the shares in the **Carrefour Group** under the false identity of **Adolf Wiezmann** or **Wiesmann**, born in Berlin (Germany). These shares are linked to a secret account opened on **19 January 2001** at **Deutsche Bank** in **Hanover** (Germany). The current total is **57.898.596,00 Euro**.

He holds another **5.5%** of Carrefour under the identity of Adolf Wiesmann from Berlin (Germany), for whom a secret account was opened at **ING Bank** in **Ixelles** (Brussels) on **2 August 2000**, the most recent account balance was **43,000,178.00 euros**.

Mr Alfons Nuyts is said to have obtained the shares through an exchange between himself and Mr Bernard Crepin, who acquired a total of **20% of Vander Zijpen**.

They can change their names as much as they like, but neither of them can claim not to know each other. They are linked through Carrefour and Vander Zijpen shares, among other companies that you will find on [this list of members of the Belgian-Luxembourg Chamber of Commerce in Morocco](#) (CCBLM). 80% of these companies are fictitious and are used for money laundering purposes.

There are too many fakes, too many fictitious things, and counterfeiting. There is nothing real in anything they do, which is the main reason for ending the partnership with them. This chamber of commerce is mainly concerned with trade and business in the occupied territories. This has nothing to do with Morocco. Why don't they set up there? Why don't they set up in Gaza, for example? Why are they coming to Morocco?

Have you ever seen the list of CCBLM members? We have the right to know if this chamber of commerce wishes to remain on our territory, otherwise they should just leave. Security and territorial integrity are also protected in this way.

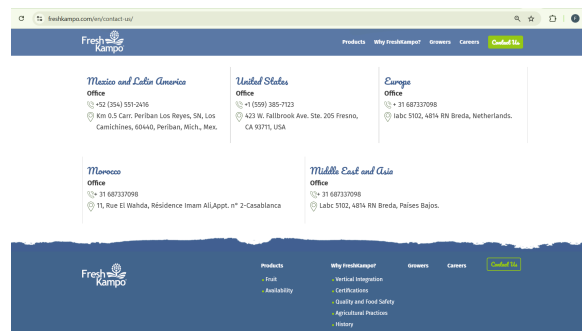

Mr Bernard Crepin, if I remember his CV from memory, was a procurement manager at Carrefour Olympiades in Evere (Brussels), where Carrefour Belgium was headquartered. He may have built his shares through the company stock options for the staff. I didn't keep a copy, but I slightly remember that his ERP (Enterprise Reporting Program) with SAP was the technological asset he brought to the team, but Orange was not using SAP.

Only Mr Alfons Nuyts praised him in a threatening tone among all the other candidates for the position of planning analyst, which made me realise that it was better not to argue with him. I said to him, 'Yeah, yeah, he is terrific, just get the hell on with hiring him and fuck it!', I said.

I do not exclude that Mr Bernard Crepin may have jumped out of Carrefour quickly for a reason, this as well as the whole career at Carrefour of Mr Bernard Crepin should be explored [in the context of the crash in which the CEO of Carrefour, his wife and the pilot lost their lives](#). The air crash could be the culmination of a series of other actions aimed at causing the CEO's failure, resignation or disappearance.

[There was a listeria threat in 1999](#), during the year when Mr Bernard Crepin applied for a function at the He applied with KPN Orange in December of that year. It is also not excluded that he was working under a different name at Carrefour, through which he can't be found like all [the Brabant killers](#).

If there is evidence of his involvement in SARS-CoV contamination, in cases such as mine, in the construction of the GSK-Texas A&M laboratory - Awex bioterrorism laboratory, now Moderna, and if he holds shares in this company and in Pfizer, then he must be investigated in connection with contaminations in the food chain such as listeriosis and E. coli bacteria, and perhaps covid19. It was probably spread through the agro-food industry as well.

Until recently I always thought that the two (Mr Alfons Nuyts and met for the first time at KPN-Orange where Mr Alfons Nuyts (born **Jean-Philippe de Wouters d'Oplinter**) recruited Bernard Crépin to his team as a planning manager, but the two are related.

I had a hunch that something incestuous was going on between the two men, which made me avoid Mr Crepin. I flattered and praised anything he did, just to keep him at bay. I also avoided team meetings with them outside the context of the company, such as a team building at Paridaiza zoo they wanted me to join, which I turned down based on the fact that it was on a Saturday. "I am not interested" was my answer upon which Mr Nuyts was red and offended or angry, knowing that it is the only thing he can't oblige a human to do. The chances were that I was probably going to be the only one ending up in Paridaiza with these two, who were possibly going to bring the rest of the Brabant killers with them, like [Marleen Seymour](#) and [Attorney Inès Wouters](#), who I didn't know existed..

I didn't know they had anything to do with the Brabant killers. All I knew is that Belgians are a little like this when they encounter a Moroccan who stands out from the crowd, they parade her around, introduce her to so-and-so, and ultimately it amounts to human trafficking. They almost all do that, especially someone like Alfons Nuyts, who comes from Boerengat, from the middle of nowhere. As he is not an exception to the rule, I said "no".

They were puzzled at how I strongly maintained a strictly professional working relationship, doing what they asked me to do without chatting, without smiling at them, giving short answers and not letting myself be disturbed by their provocations. They have never met a Moroccan who doesn't trust them, who doesn't want them in her life. They only meet those who think they can win friends with generous hospitality, and with saying yes all the time.

There was a Moroccan colleague in our team named Nordin, who once reproached me that when it comes to Mr Alfons Nuyts, "**vous ne le caressez pas dans le bon sens du poil**", meaning that you have to flatter him to get something done from him. "You do that, please go ahead, but I am not going to make myself ridiculous", I replied.

The whole [KPN-Orange](#) company was doing this . The entire company was largely filled with local Belgians, especially in the period after the departure of Mr Mishak Vihuni, a personnel director from Lebanon, who encouraged me to work there. When Ms Laurence Garrido arrived, the atmosphere and dynamics changed. They were not busy working, they were only busy pleasing one person, **M. Scarface**. who is Mr Alfons Nuyts, perhaps out of fear of an armed insurgency by this person. That means that the investment money was being spent on soothing the savage nature of a wild man among the staff instead of spending the money on becoming the first telecom operator in Belgium.

That is why we need to avoid him in our businesses and our banks. If Belgium is not doing it, we will avoid Belgium then

The aim was to make them understand that there are also Moroccans who are fed up with them, who can no longer stand to see them, who are not impressed by Belgium, who are not bootlickers like Nordin and who are not afraid of racism, exclusion or the pink slip, which only means that they shut themselves out. In this way, I don't have to exclude them too, because "**out is out**".

They are more used to Moroccans giving them a value they don't deserve at all, and who are pardoning. It's the big mistake Morocco has made when dealing with Belgium. This time, they are dealing with a Moroccan woman who makes them feel like shit. It's what I have learned from them.

These are the kind of psychopaths who attack people who have done them no harm. They are sadists who enjoy seeing people suffer, especially when they envy qualities they cannot have, because they are beings of a different order from the rest of humanity.

The more you flatter them or treat them like human beings, the more you expose yourself to an attack that they have been planning for years in advance. Avoiding and ignoring them is the only solution. They have organised genocides, forest fires and floods everywhere. You will agree that I was right to treat them this way and that Mr Nordin Kaddour was wrong to try to please cannibals.

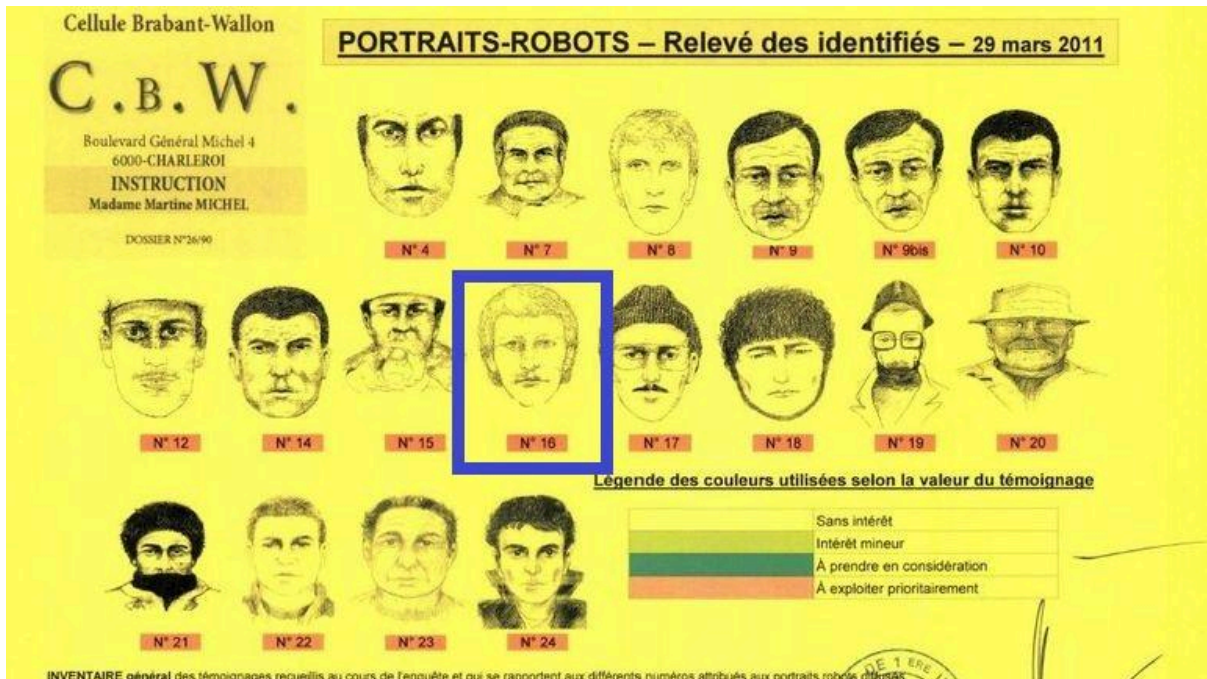

Bernard Crépin is said to have supplied Alfons Nuyts with the weapons used in [the plot that led to the deaths of Princess Diana, Mr Dodi Al Fayed and their chauffeur, Mr Henri Paul](#). Mr Alfons Nuyts used the weapon allegedly to shoot on his colleagues in the Alma tunnel, including [Bailliff Dirk Duflou](#) and [Colonel Major Sellam Sadki](#), while in the white Fiat that slightly clashed with the black Mercedes of the Princess of Wales, which was pushed against one of the pillars. Shooting on colleagues. That is what Mr Alfons Nuyts calls **teamwork**.

In both cases, the main motive was jealousy mixed with deep-seated racism towards Arabs such as the Al Fayed and Khashoggi families who produced Mr Dodi. The murders began in 1982, with the arrival of a class of highly skilled people from Lebanon, who came with their capital, their knowledge and their culture, which meant that they did not need the Belgian social system. In the case of Princess Diana, the problem for these poor Belgians was the capital of Mr Dodi Al Fayed and his family.

Mr Alfons Nuyts himself was seriously injured by debris from the Fiat Uno. In 2000, he had a very large cyst removed from his neck, probably at UCL Saint Luc. Perhaps this has something to do with the photos that were taken of his injuries, in which the cyst was exposed. It measures approximately 3 cm in diameter and approximately 2 cm in height, which he hid with his long hair. In principle, it is a cancerous growth. I describe the scars I saw on [Mr Alfons Nuyts' face and neck](#) in the report on the death of Princess Diana:

Bernard Crépin is said to have spent around four years in Essaouira, Morocco, between 1996 and 2000. No one bothered him or attacked him, but he attacks our fellow citizens in his country and elsewhere. This cannot go on. For me, this is unacceptable and that's why we have to change our attitude towards these people.

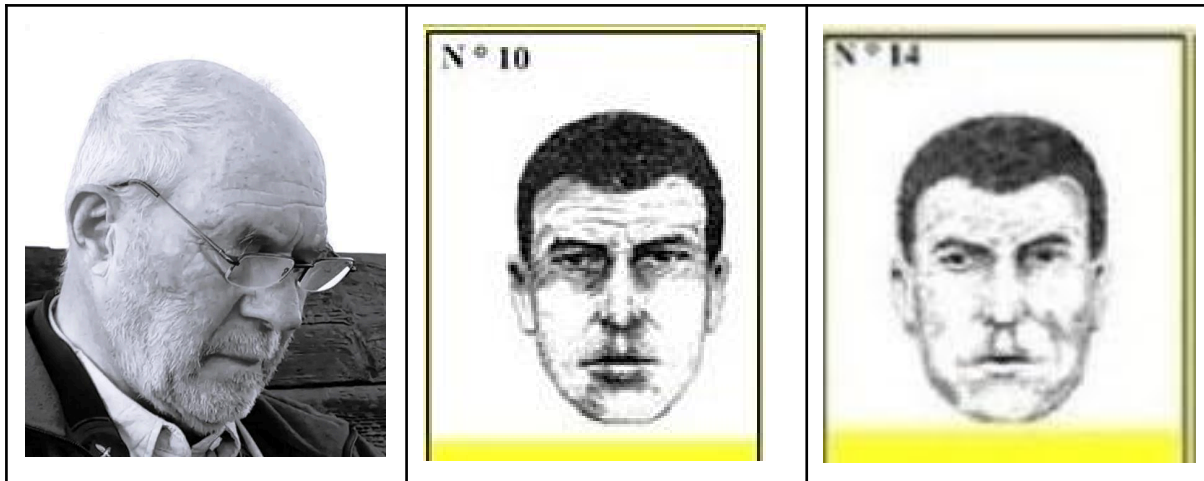

I suspect that Alfons Nuyts and his half-brother [Jens Hoegsholm, who lives in Copenhagen \(Denmark\)](#), are responsible for [the accident in England in 2003 in which Paul-Louis Halley, the main shareholder in the Carrefour group, died with his wife in a plane crash](#).

By shooting unarmed civilians buying food, does he think he is showing these shops how best to behave so that they are no longer punished? That's what the whole world is wondering about [the Wouters family from Oplinter](#), who [execute people](#), [slit their throats](#), [disembowel them](#), [hang them from trees](#), [poison them](#), [chop them up](#), [torture them](#), [burn them alive](#) or [throw them to crocodiles](#) and [take them hostage](#) to punish everyone, when their own behaviour is no better. Are these are modern people? They're not a constructive family in the way they give instructions.

For example: I don't know if Delhaize and Colruyt have understood what they need to change to avoid shootings in their shops. Those who try to make themselves heard in this way, we call '[savages](#)'.

They're boerengat, as we say in Belgium!

To begin with, Mr [Jens Hoegsholm](#) hides his wild nature behind the mask of a fake Dane and a scientist from the European Space Agency (ESA) in Noordwijk (Netherlands).

He is suspected of abusing ESA space facilities to [disrupt the routes of commercial airlines](#) and hijack or hack aircraft autopilots, sending them to his personal targets which included [the Twin Towers and the Pentagon on 11 September 2001](#). The US Air Force Boeing CT-43A crashed in Srebrenica on 3 April 1996 because someone was jealous of the fact that black people liked to ski, or they were simply looking for copper that way.

This can certainly be determined by [Jens Hoegsholm's](#) shareholdings in supermarkets in general, and in Vander Zijpen in particular, which I will inform you about at a later date.

This can certainly be determined from the black box and compared with information from other black boxes from similar plane crashes. These could show a similar procedural pattern in the final moments before the accident, with control of the wings being primarily handled by a control tower somewhere. He also wants to get Morocco used to consuming couscous from the occupied territories of Palestine, so that Moroccans no longer produce anything themselves and have nothing left to export. They will have no choice but to buy everything from Vander Zijpen, Alfons Nuyts and other primates who are unable to sell their so-called "fair trade" products, such as [Oxfam Belgium's couscous, which costs €6.70 for 500 grams produced in Palestine](#), or 70.53 Moroccan dirhams (MAD) for half a kilo, or 141.06 MAD per kilo. This is saffron. It is no longer couscous.

Oxfam Belgium olive oil costs €14.50 for 50 cl (half a litre), or €29 per litre, or MAD 305.30 per litre... "But it's organic," they will tell you. And that's how they raise funds to buy military equipment to disguise their soldiers as Israeli soldiers who indiscriminately shoot Palestinian civilians from the occupied territories.



All the deals and contracts that go through Lucien Leuwenkroon's CCBLM are aimed at continuing the colonisation of the Palestinian territories. This is the friendship between Morocco and Belgium that I have always denounced on the basis of their relentless hatred for all Moroccans, including Nordin Kaddour (originally from Nador), whom they treated better only to obtain real estate in Nador through his intermediary.

The same man, under the name **Gérard Lacroix** from Le Mans (France), still holds **18.5%** of the shares for which he opened an account at the **Bank of New York Mellon** in **Charleston** (USA) on **30 January 1998**. The current amount is **USD 68,701,584.00**.

He therefore holds a total of **36.5% of Vander Zijpen's shares**.

So they want to get everything they can by killing people who have been trained and educated for a certain job, or who possess scientific knowledge. That is why it is better to avoid someone like Alfons Nuyts, because he considers it his job to kill people who occupy the position he covets. However, 20 years after the death of Carrefour's CEO, Mr Alfons Nuyts has still not become the CEO of the Carrefour group.

The first country to which Morocco no longer wants to export is Belgium. All they will do is sell our products to others.

We might as well do it ourselves.

Between 1 and 8 September 2021, Alfons Nuyts is said to have travelled to Morocco, both as part of an aggressive takeover of the **Marjane** hypermarket and to commit the murder, in hospital, [of Halima Bouhamou, whom he had stabbed in Ifrane in March of the same year, in order to facilitate her rape by Professor Roland Willemyns](#). She survived both attacks. A witness to the stabbing and rape, [she was euthanised by Marleen Seymour using an euthanasia syringe and by Anne Verhoeven, who allegedly closed her mouth and nose](#).



His Majesty King Mohammed VI: The child of Ms Bouhamou and Mr Ayad has the right to know what happened to his mother in Ifrane and how she died at Ibn Sina Hospital. A country that killed his mother in peacetime cannot be considered a friendly country. His father and nephew work for the Belgian-Luxembourg Chamber of Commerce in Morocco (CCBLM), which organised the rape and murder. The CCBLM represents Belgium and carries out the will of the Belgian people (pdf).

Someone filmed the entire incident and sent it to the Moroccan police as part of a complaint. However, the video was not accepted as evidence and was confiscated pending further evidence. I therefore hope that this case, that of Ms Rachida Targali (raped and stabbed to death, whose husband may be a drug trafficker working for Mr Alfons Nuyts) that [of Ms Saida Mahmoudi](#) (raped, killed and probably dismembered in Antwerp, possibly by Mr Alfons Nuyts) and that [of Saudi media star Ms Muna AbuSulayman](#) in Laayoune, whom Mr Alfons Nuyts kidnapped with her baby, locked up and held hostage for at least three months, after

which he sold her baby to a family in Belgium, will be tried by an international court as genocide.

Saint Pope Leo XIV: The American-Saudi media personality Muna Abusulayman is said to know Cardinal Dominique Mathieu very well under the name of Clément Feraud de Paris XII. He is probably the owner of the huge villa with luxurious suites in Laayoune (Western Sahara) where this journalist was tortured and raped. He is wanted in Belgium as suspects 7 and 22 in the Brabant killer case (pdf) (Spanish - French - Dutch)

Mrs Halima Bouhamou was the heir to the lease of the former tobacco plantations in Kenitra belonging to Dutch Jewish businessman **Joseph van Collem**, who was exterminated along with his entire family during a business trip to Western Europe between 1940 and 1945. She also worked in a Fresh Kampo tomato processing factory in the region.

The aim was for the tobacco trade to be taken over by criminals. Mr Nuyts and his entire family from Wouters van Oplinter wanted the land for their Vander Zijpen, and they thought they could get hold of **land with no history with Belgium**, from a **cigarette manufacturer**, [Gebroeders van Collem](#), **who was not Belgian and** was not established in Belgium, and from a **businessman who had nothing to do with Belgium**, whose remains, those of his wife **Julie Bloemgarten**, his son Henri, his daughter-in-law and his grandchildren, have still not been found. I remain convinced that we will be able to find them and repatriate them to Morocco.

We will probably find their remains with people who had absolutely nothing to do with Joseph van Collem and who were involved in his affairs.

However, we have discovered that Joseph van Collem was a client of Société Générale in Morocco, that its director, Baron Charles de Wouters van Oplinter, visited him very often, that one of the transporters of his goods was Vander Zijpen, and that Joseph van Collem was a collector of antiques and probably a member of collectors' clubs, such as Dr Amine Matta of UCL Saint Luc, who had known at least 34 women who had disappeared during his lifetime. It turns out that they had all been murdered by the Brabant killers, who probably wanted to make this Lebanese doctor responsible for the disappearance of all these women so that they could seize his car collection through legal channels. For me, his case could provide clues about the potential thieves who killed Mr Joseph van Collem in 1941.

I myself was born in Kenitra in Joseph van Collem's former tobacconist's shop. That is why I wanted to find out who Vander Zijpen is and what this company is still doing in my country today. It was by chance that I discovered that it is active in Palestine and the occupied territories.

It is a Belgian company that denounced Jewish traders to the SS. That is why I believe that Mr Joseph van Collem was arrested in Belgium on his way to a collectors' club in Tournai. On the day of his disappearance, he was looking for a powerful motor to pump water from the Sbou River to irrigate his agricultural fields. My grandfather found at least two powerful engines for pumping water, which he continued to use until his death in 2009.

My question is: who were the SS officers? What were their names and places of birth?

[Mr Alfons Nuyts](#) travelled to Morocco with [Mr Daniel Renson](#) to attend [the execution of Mrs Halima Bouhamou at the Ibn Sina Hospital in Rabat](#) and, as part of another project, to become respectively chairman and managing director of the Marjane Group, a Moroccan distribution company similar to Delhaize and Carrefour in Belgium.

They act as if Morocco was unaware of [the killings in Brabant](#) against shopkeepers before Carrefour arrived, and as if Morocco still wanted to do business with Belgium, with such savage individuals.

To do this, they must first get rid of the current CEO, instead of applying like everyone else or buying shares. For them, it is easier to kill. If it is quicker to get the job, that is another matter, because more often than not they give up when the situation becomes too complicated. As always, they will have killed a great talent for nothing.

That is why the whole world should avoid them in distribution until the Belgian justice system has resolved the Brabant murders

I suspect that there is a link between Alfons Nuyts' plane crash, which targeted [KPN-Orange CEOs Stanley Miller and Jean-Claude Vandenbosch, and the company as a whole, by imposing fines on them](#) so that shareholders would dismiss the CEOs and then appoint managing directors... That's how he spends all day thinking up traps to bring down this person or that person. He saw everyone as a competitor, except Bernard Crépin. He would arrive at the office at 5:30 in the morning, obviously not to do any real work, but to plot and probably rummage through other people's drawers and computers.

I noticed this among many workers in Belgium, who all arrive very early. They are never late, but they spend a lot of time smoking cigarettes or drinking coffee and gossiping about everyone, especially the new recruit of immigrant or Moroccan origin.

Mr Alfons Nuyts asked other jealous colleagues for advice on how to have an affair "with that one". He gets up very early to go to work for this specific purpose, not to develop the business. If you tell him this, he will reply, "They have a lot of money, don't worry."

Do you want people who think like this in your company?

In the end, he himself was dismissed after causing so much damage and loss to the company. He started, and when it got too complicated, he gave up.

Remember this about people like him: they go somewhere, they kill people, they burn down forests, probably to expand Vander Zijpen's farmland, and in the end, they move on to something else.

Mr Alfons Nuyts has deadly abilities in abundance, but he lacks the ability to grow, develop and profit. This individual then wants to become CEO or sit on the board of directors of numerous distribution companies, and all of this is linked to the greengrocer [Vander Zijpen](#) and food producers from agricultural land in areas occupied by terrorists, such as Gaza or Western Sahara.

He could hold more shares in Carrefour. I am investigating to have him and his clique removed from the board of directors, otherwise there will be a boycott of the brand, which is not our priority. Our top priority is Magrexit and the closure of [Vander Zijpen, the Belgian-Luxembourg Chamber of Commerce in Morocco](#) and the Belgian-Luxembourg Chamber of Commerce for Arab Countries in Brussels.

I am attaching this file to the letter to His Excellency Donald Trump, President of the United States, [regarding the famine in Gaza. I wonder if anyone knows where Vander Zijpen is](#) now, given that he is the head of the humanitarian mission there. I have attached the list of Vander Zijpen shareholders, who are the same as those of the International Federation of Red Cross and Red Crescent Societies.

[I am informing the International Criminal Court in The Hague about this specific case](#), which demonstrates the aggressive and murderous behaviour of one of the shareholders: Mr Alfons Nuyts. The aim is to invite the court to question Mr Alfons Nuyts' mental health. He wants to be a businessman with a knife in one hand and a Kalashnikov in the other. All those who follow him and wish him success also need a psychiatric examination.

In February 2001, I filed a complaint with the Brussels Labour Court. In Belgium, nothing is happening. That is why I will ask the International Criminal Court to take up the case. This could be useful in determining the [responsibility of Mr Alfons Nuyts in the genocide and famine in Gaza, since he is the one who supplies the equipment and buys the uniforms for his Foreign Legion in the Occupied Territories from the Israeli Army](#). This is the subject of the letter addressed to the International Criminal Court.
