

**A request for royal pardon from His Majesty the King of the Belgians  
on the occasion of Belgium's National Day 2025**

*Se Majesté le Roi Philippe de Belgique*

It is with humility that I once again ask His Majesty the King of the Belgians to grant me a royal pardon on this happy and joyful day of the National Day of the Kingdom of the Belgians.

May this country and its people be blessed with fortune, unity and growth in all the years to come, by the grace of Almighty God.

I refer to [your letter of 19 August 2022](#):



If I seem more confident this time, compared to previous letters of pardon, it is because I have finally discovered the manipulation that took place behind our backs; and behind the back of Dr Amine Matta, anaesthetist and surgeon at the Saint-Luc University Hospital in Brussels, who was the indirect target of legal action aimed at discrediting his talent and sending him to prison.

To target him, they have, for some strange reason, initiated legal proceedings against me by individuals from your country who are fuelled by hatred and blinded by racist emotions to the point that they cannot see that Dr Amine Matta has never been part of my life.

Your Majesty, there are people in your country who have great means and privileges that they use to corrupt anyone, but who unfortunately take catastrophic measures based on misinformation, causing total destruction after which they discover that the result is not what they expected. They do not even need to think or worry about the amount of time and money wasted on themselves and others.

As foreigners, we can only avoid this catastrophe based on racism and hatred by leaving your country and advising our respective nations, the Kingdom of Morocco and the Republic of Lebanon, to review their bilateral agreement in order to prevent certain hateful Belgians from exhausting the resources of our peoples and our nations. This is the only way to alleviate the suffering of our people. Returning home will at least relieve them of the burden of racism and hatred. We will have more energy to devote to building a normal life.

I have taken every opportunity to ask for clemency to have the case reviewed. I have gained clarity in a case that even the defence lawyers did not want to examine. It was easier for them to have me convicted of a crime I never committed than to look for evidence of the involvement of people who were not investigated. What if I was innocent?

I am preparing letters to the European Court of Human Rights and the Court of Justice of the European Union in which I will highlight the functioning of the Belgian legal system and institutions, which work very hard to make innocent people look guilty. I just wonder how this can give Belgium a good image.

It all started with the discovery of Ms Marleen Seymour, a woman from Suriname who has been in Belgium at least since the fake visa case in 1990, in which [more than 20 people were arrested, 16 of whom appeared in criminal court](#), including myself.

I did not know any of them except [Mr Mohammed Al Makrini, a student](#) who apparently had legal status in Belgium: they made him out to be an undocumented immigrant whom I had helped as a translator, but this man is Amazigh and I am Arab. There was nothing I could do for him.

The court convicted me solely for having seen him in the context of an application for a Benelux visa for him, which **Ms Dagmar Weisz** was going to obtain for him. Mr Mohammed El Makrini allegedly paid at least 190,000.00 Belgian francs to Ms Dagmar Weisz, who was posing as a German woman living in Barcelona. After taking the money, she became untraceable by the Belgian police.

At least Mr El Makrini and I saw Ms Dagmar Weisz. I saw her from the front and she looks exactly like **Ms Anne Verhoeven**, a resident of Leuven at Schrijnwerkerstraat 28, 3000 Leuven. That is where the police will be able to find Ms Dagmar Weisz. I looked at her

closely the second time I saw her at Ernst & Young in Brussels in November 1998, at the launch of Nifty Entrepreneurs (a copy of Mr Steven Mariotti's initiative) for young migrants.

Obviously, I wasn't going to ask her if she was Ms Dagmar Weisz, but it was clear that she was trying to make a lot of money off the backs of migrants who are struggling to get ahead. I didn't say anything, otherwise I wouldn't know where she lives today.

And the [15 other defendants](#) in [the 8 March 1996 ruling](#), who did they see? Apart from El Makrini, none of them saw me.

The crime was repeated a dozen times, but only I am seen in this single case involving a student I did not know, who made a tidy sum of nearly 200,000 Belgian francs working in tomato cultivation in greenhouses in Lier at Tuinbouw Marc Pittoors (TBMP). I am not a shareholder in TBMP, but Mrs Anne Verhoeven is. Mr Mohammed El Makreni was a worker in Mrs Anne Verhoeven's tomato company.

The crime continued to be committed, even beyond the Belgian border, as in the United States. In 35 years, they have sold millions, and they want people to keep quiet and not let it be known. These are sick people.

Who sold the fake visas to the 12 other Moroccan nationals in [the ruling of 8 March 1996](#)?

The answer to this question is not found in the ruling [of 8 March 1996](#). I found the answer myself. It is Mrs Marleen Seymour. She was a very dark-skinned woman who spoke perfect Dutch and earned a lot of money here in Belgium. She is believed to be a serial killer in the hospital and home care sector. She has never been arrested. Yet she killed at least 204 fellow Belgians during the Covid period, including nine at [Zorgbedrijf Antwerpen](#), and the police did not act as quickly to catch her as they did in my case.

It was thanks to the file of my neighbour Mr Louis Marit at Rijmelgem 10, 1932 Sint Stevens Woluwe, that I found this woman


My neighbour Mr Louis Marit was killed with an euthanasia syringe at the Saint-Luc hospital of the UCL in May 2005, after weeks of hospitalisation for a Sars-cov-type lung infection.

The murderer is believed to be Ms. Josephine Duvin, who managed to gain access as a home help to visit her client in hospital. Ms. Josephine Duvin was in fact Ms. Marleen Seymour, sent by prosecutor Inès Wouters to kill the man.

The reason was that her son, [Mr Pascal Marit](#), was probably the motorcyclist riding behind the black Mercedes. His accident was real and absolutely terrible. This victim of the accident in the Pont de l'Alma tunnel was not reported in the press, perhaps because he survived, or perhaps because he was quickly picked up and transported to Tournai in Belgium. His father, Louis Marit, was contacted and rushed to Tournai to support his son, who was in a coma. It is probably to silence this context that Mr Marit was murdered.

If no arrests are made, Mr Pascal Marit will be next on the list if they continue like this. For the gang, that's one less witness. This slowness works in their favour.

That is why I believe that Mrs Seymour may have played a role in poisoning me with the same infection when I was living in Sint Stevens Woluwe, in cooperation with Mrs Anne Verhoeven. Fortunately, I was treated by a wonderful doctor, Dr Laszlo Nemeth.



Mrs Marleen Seymour lived in the same building in a flat she shared with Mrs Theresa Mualla from the Tanzanian Mission in Belgium. However, I did not know them personally.

I remembered that Ms Seymour worked at the Saint-Luc Hospital of the UCL. She usually walked to work. This is the Brussels hospital where Dr Amine Matta works.

It was while studying the Diana and Dodi case that I followed the anti-Arab and anti-Muslim hatred as the clue that led me to the conspirators who wanted to put Dr Matta and me in prison with the fake visa scam in 1990.

I would not know who they are if I had not followed [the anti-Diana and Dodi critics](#) who opposed my meeting with Dr Amine Matta. I also experienced similar opposition from people outside the family when a young man of Lebanese origin gave me the attention that only someone can give when it comes to starting a family.

Your Majesty, I do not interfere in the private lives of Belgians, but I have noticed a mental illness in your country that causes some Belgians to interfere in the private lives of Arabs.

When a Chinese man finds a Chinese woman he likes, is that not their right? Does a Chinese man not have a right to a Chinese woman? As a European, would you intervene to prevent a couple from getting to know each other?

That is why I have never interfered in a relationship with a Belgian man, so as not to take that chance away from a Belgian woman, but Belgians allow themselves to interfere in relationships between Arabs. That is what happened to Dr Amine Matta and me. We are both Arabs. It is our duty to come together regardless of the world and remain one people. What Belgium has done to us is unacceptable. The person who prevented our union for 35 years should be imprisoned.

Who do the Belgians think they are, meddling in the personal affairs of Arabs? This is a reason to avoid Belgium at all costs.

In court, I was confronted with reactions from strangers, invisible, violent people who have no connection to him or to me, who are neither Moroccan nor Lebanese, neither Arab nor African, who have absolutely nothing in common with us, and who meddle in everything. Interfering in the relationship between two Arabs is really going too far. Human traffickers are like this and they did this to us. It turns out that they are Belgian. These people must be treated and disciplined with the same force that they apply to us.

My problems with the judges did not begin at the meeting I attended at Ms Denise Janssens' office with Dagmar Weisz and Mohamed El Makrini. It all started much earlier at UCL Saint-Luc.

These are members of the medical team of the young Lebanese doctor, who envy him and me because they have never been able to advance as far in medical science as the Lebanese doctor. The Lebanese doctor is Dr Amine Matta, and he was unaware of the resentment his colleagues and some shareholders of the university hospital felt towards him.

One of them is Ms Anne Verhoeven, who could have played a triple role:

1. as a shareholder with a seat on the board of directors of UCL Saint-Luc,
2. as **Ms Dagmar Weizs**, who presented herself as the Belgian State at Denise Janssens' office and asked Mr El Makrini for 190,000 Belgian francs for a three-month tourist visa. She pretended to live in Barcelona and came to the appointment in a car rented from Hertz. This was on 15 August 1990, as it was the only day I was available **that year**. I worked every day without taking a break in 1990, but the criminal court said that I had attended these meetings more than once without proving what they were saying. I was working as a temporary employee at Universal Communications.
3. as the employer of Mr El Makrini, who was a tomato producer in the Turnhout or Lier region. Anne Verhoeven could be the owner of Fresh Kampo in several countries, including [Palestine](#).

If Ms Anne Verhoeven speaks German, it must be her. The company in Lier consists of greenhouses where tomatoes were grown at that time and is called Tuinbouw (Horticulture) Marc Pittoors.

**Ms Anne Verhoeven** has held **10%** of the shares in **Tuinbouw (Horticulture) Marc Pittoors** (TBMP) in her own name since **23 February 1993**, three years after the fake visa fraud involving **Crédit Lyonnais** in **Cherbourg** (France). The secret account was opened at 9:38 a.m. and the current total is **€57,908,543.00**.

She is reportedly not only a shareholder but also a director, ensuring her daily or weekly role in this company. She is reportedly

She is listed as Martine Peers in the TBMP articles of association. Ms Martine Peers is a real person who works or has worked as a chef in a Sodexo kitchen at MSD. We are trying to find out if there is a second person involved in this falsification.

She then obtained even more shares in TBMP by devious means, in particular by paying other people to lend their names, and thus reached a total of at least 38% in TBMP. She paid €75,000.00 each for this intervention.

The three women are

**Ms Jeanine Verviers** de Waremmes, born in Belgium in Vincennes (France), who acquired **9%** of TBMP, the dividends from which go to **Crédit Lyonnais** in **Lens** (France). The secret account in this name is believed to be held by Ms Anne Verhoeven, who has held it since **12 March 1992**.

**Ms Liann Ferguson** of Birmingham in the United States, who is said to have purchased **10%** of TBMP for which Ms Verhoeven uses a secret account at the **Bank of New York Mellon** in **New York**, which she opened on **16 October 1989** and which currently holds a total of **USD 70,988,041.00**.

Ms **Laurette Vermeir** of Boulogne-sur-Mer, who allegedly received dividends at **Société Générale** in **Paris 12**, but the real investor is Ms Anne Verhoeven who, thanks to this French woman, allegedly bought 9% of TBMP shares on **9 January 1987**. The current total of this account is **EUR 67,113,998.00**.

The amount that the alleged Dagmar Weisz received from Mr Mohammed El Makrini was probably paid into this secret account. The latter worked in the TBMP greenhouses, where another person (perhaps the operations manager or a colleague) had put him on the trail of someone who could "help" him.

In a complaint filed on 19 March 2019 with the Brussels court, Princess Jacqueline de Croÿ, as a civil party, brought a case against KBC Bank concerning Russian treasury bonds worth \$20 billion and 500 tonnes of gold bullion, which the bank allegedly falsified and whose originals it holds. It is stated that migrant workers (such as Mohammed El Makrini) were victims of an internal slavery mechanism in certain agricultural holdings that recovered the wages paid thanks to the fake visa scam in order to use them to organise their stay in Belgium.

Ms Verhoeven therefore played the dual role of shareholder in the company where Mohammed El Makrini was employed and had saved money, and Ms Dagmar Weisz of the Belgian State, who came to give him a hand in sorting out his situation. I met Dagmar Weisz and she struck me as decent, polite and noble, except for the price of this solution, which was inhumane for a so-called illegal migrant working in Belgian agriculture.

At TBMP general meetings, these women are present in person, which means that until now there has never been any doubt about the exact number of shares held by Ms Anne Verhoeven in a company whose main shareholder is Lucien Leuwenkroon. The other members of the Nijvel gang are also shareholders but cannot receive dividends. In the study I conducted two years ago following a photo taken by our AI camera of Mr Lucien Leuwenkroon near the canal in Berchem (Antwerp), I noticed discrepancies in the company's operating results.

Ms Verhoeven may have found Ms Denise Janssens' contact details in the address book of Baroness Louise-Marie Lowenkron-Le Lion, who was killed by her two sons and Marleen Seymour on 28 July 1987 in Valenciennes (France). Ms. Denise Janssens and Baroness Louise-Marie Lowenkron-Le Lion were both shareholders in Douglas Perfumes in Germany.

Ms Denise Janssens was a personal contact whom I visited regularly. I was caught up in the fake visa affair because of this, but the courts acted as if I had organised everything.

As for Dr Matta, Ms Anne Verhoeven, from Leuven, under the false identity of Jeanne Poireaux, from Lille, has held 8.5% of the shares in UCL Saint-Luc since 3 February 2007, which is linked to a secret account at Crédit Lyonnais in Bastia (France) with €54,122,693.00.

Under another false identity, Ms Anne Verhoeven holds 23% of the shares in UCL Saint-Luc under the name Jeanne Montfort from Sint Martens Latem. The corresponding secret account was opened on 3 January 1989 at Crédit Lyonnais in Paris 12, where she hid €59,925,877.00.

She owns a total of 31.5% of UCL Saint-Luc and is believed to be the largest shareholder in this very large hospital.

This is an important position that does not appear in the [Cumuleo register of positions held by civil servants and administrators of public bodies and associations](#). UCL Saint-Luc is a non-profit organisation with a public purpose, whose financing and management must be transparent, as must the identity of its shareholders.

This discovery means that Ms Verhoeven is withholding important information from the Belgian Ministry of Health, as its impact on people's health is unknown, and from the Ministry of Finance, which should ask Anne Verhoeven where she found the money to buy these shares.

Since holding secret accounts under false identities is a criminal offence, it is logical to assume that the money in this account is being used for crimes related to health. This involves killing people.

They would have started plotting Dr Amine Matta's downfall long before he met me, by sending an incompetent nurse to the surgery department, probably to cause the death of a few patients, make it look like they died under Dr Amine Matta's anaesthetic care, and get him fired.

Dr Amine Matta believed he was appreciated, valued and respected by the medical staff at UC Louvain. He believed he was at a Christian university, especially since he himself is a Christian. For the Enemy, your religion does not matter, as long as you have Arab or Mediterranean features. The Enemy, who is responsible for both world wars, hates them all.

The incompetent nurse was Marleen Seymour, a protégée of [Professor Roland Willemyns](#), who brought her to Belgium. From October 1989 to April 1990, she worked at the Saint-Luc University Hospital of the UCL in Brussels under the false identity of **Lucienne Carrière**, originally from Saint-Omer, France.

Dr Matta was able to see her and trust her without knowing that she had been sent by a conspiracy to study his human weaknesses and the weaknesses of the hospital system in

order to identify areas where his skills could be exploited, while presenting herself as a friend, as I saw her do at the Victor night shelter in Antwerp where she is currently hiding.

This conspiracy was [the Brabant killers](#) who, at that time in the 1980s, had never heard of a doctor of Arab origin climbing the ranks of a university hospital on their territory. This made them angry, but what doesn't make them angry?

"There's no way an Arab doctor is going to touch me. He can keep his dirty hands to himself!" That's what the average citizen thought, with an aversion to the idea of an Arab becoming a doctor. "I'm not going to give my money to that doctor... he's a charlatan," was the sentiment that Dr Matta did not hear, and what I did not understand about him was why he wanted to cure these people? **Let them all die!**

**What are they doing with Arabs and Muslims? They're killing them all. They're killing them all. We can't put up with the murderous Belgian species forever.**

I feared that Dr Matta and I would disagree on my opinion that Belgium has the most evil genes in the world. He doesn't realise how backward the people in this country are, and they try to solve this problem by pulling down talented individuals, including their own, with all their might. They live by comparison and identify with others in a negative way. In their speech, they always hear a reference to the fact that the other person is older or younger than them, richer, smarter, taller or more educated than them, and that may be the problem they have with someone darker than them, who comes with everything going for them, as if they never had to fight to get there. That's what I've seen.

What Dr Matta noticed that is different is that he finds that compared to his country, Belgium has a huge number of disabled people, people born with abnormalities, including mental ones, but he has not made the connection between the nastiness present in this country and the [vast social system](#) infested with people with defective chromosomes. They need immigrants to cover all this up and reduce the percentages. However, the wickedness of this people translates into racism, which is very high in Belgium, and don't the wicked people of Belgium deserve someone like Dr Amine Matta coming from Lebanon to heal them? I would prefer to take care of the Lebanese; that would be the first thing I would think of if I were him.

[Lawyer Inès Wouters](#) allegedly helped Ms Marleen Seymour obtain the position of cleaner at UCL Saint-Luc under the false identity of **Lucienne Carrière**, but she was not the only one. Inès Wouters' uncle, [Baron Guy de Wouters van Oplinter](#) (who died in October 2015), helped her to bring down this Arab doctor, using his contacts in the justice system and perhaps also in political parties. They are all linked by a SICAV, possibly [Sofina](#).

[Lawyer Inès Wouters](#) also arranged accommodation for her in one of [Daniel Renson's](#) properties in Saint-Josse (Brussels), where Marleen may have been registered under the name **Marleen Vandeputte**. She may have had a Brussels metro pass with the **STIB-MIVB** under the name Marleen Vandeputte or Marleen Symor.

The so-called "**Lucienne Carrière**" could be the person who offered to help Dr Matta, through a solicitor, to obtain a visa for the Benelux for his brother Bechara Matta, who was in Lebanon. The solicitor in question is [Ms Inès Wouters](#).

It is possible that he gave the solicitor the [visa application letters that I sent in vain](#) and that this solicitor would use against me later in the year. I did not receive any replies because the Belgian Foreign Ministry was slowing down the process for anyone submitting a normal application, probably so that they could make more money by encouraging visa fraud for certain people of all nationalities. As for Arabs, [they are charged at least five times the normal price for a visa](#). They simply want to get some of the oil money this way.

[Dr Amine paid 500 euros instead of 100 euros for](#) his brother's [visa](#). That in itself is an indication that the visa is fake. I was not with him when he undertook all these steps and I was unaware of anything throughout 1990 until I was arrested for visa fraud involving illegal migrant workers from Morocco, but the police used the [letters concerning Lebanon to justify the arrest](#) even though they had found no evidence of any involvement on my part. That is how I learned that some very jealous people, with whom one should not associate, were persecuting Dr Matta.

I was arrested on 16 December 1990, when Mr Bechara Matta arrived, and I was unaware of this because there was no longer any dialogue between Dr Matta and me. I understood that someone he trusted was trying to bring him down with this visa for his brother, which he believed to be genuine because it [had gone through a law firm and](#) he may have received a bill for 500 euros that included the solicitor's fees.

So there were two ways to obtain this visa for his brother. There was the one I had started with real letters from ministries, which had cost Dr Matta nothing and had not worked, and the one that lawyer Inès Wouters had organised, which had cost him 500 euros and had enabled his brother in Beirut to be issued with a visa very quickly. As this was false, a truly diabolical lawyer like Inès Wouters, who seeks only to make Dr Matta and myself pay very high fines to the Belgian state, through which the sale of our assets – wherever they may be in the world, whether in Lebanon or Morocco – will be necessary, especially in a country where no lawyer would question the integrity of a colleague. That's how they do business, don't forget.

I also understood that if Dr Matta is financially ruined, they will blame me by saying: "**You wanted a Moroccan woman. They are not reliable. They are not intelligent. You should have chosen a Belgian woman, you would never have had any problems.**" They said the same thing to me: "Why do you want an Arab? You grew up here. They're not serious, blah, blah, blah." They said that to me about someone who operates on Belgian patients every day. If he's not serious, then the whole UCL Saint-Luc isn't serious either. It's all false. I am convinced of it.

That's where Princess Diana's choice of an Arab corresponds to my choice of someone close, familiar and in tune with our culture and civilisation.

I think Dr Matta is capable of believing them as long as he believes in their degrees, their universities, their hospitals and his work for them, rather than believing Moroccan migrants who have no assets... and who are not from the nobility. He chose what would take him further, and he thought that this Belgian mafia would do it for a Lebanese person instead of

choosing someone whose country is very large over someone whose country is very small, as they do.

My total absence from Dr Matta's life has the advantage that I have never met Mr Bechara Matta in my life. I kept my distance because the image of Moroccans at that time was so tarnished that foreigners were warned in advance that Moroccan migrants were dangerous and that they were thieves.

Even Dr Matta was somewhat concerned, and I thought he would eventually believe his employers (although I know absolutely nothing about the stock market or how the financial world works) rather than me, due to a perceived class difference.

You would think that Baron Charles de Wouters van Oplinter's family belongs to a high social class until you discover the devious means they use to make money. [They run prostitution rings and cabarets to raise funds for their businesses.](#) They are not respectable people.

It was Lucienne Carrière, a nursing assistant in the anaesthesia department at UCL Saint-Luc in Brussels, who personally delivered the fake visa to Mr Bechara Matta in May 1990, with the intention of having me accused of forging this visa in December 1990.

Although I have never seen Mr Bechara Matta in my life, [Ms Marleen Seymour](#) claims to have met him in Beirut. She left her job as **Lucienne Carrière** at UCL Saint-Luc in April 1990 and travelled to Beirut under the false identity of **Sophie Demartel**, originally from Saint-Étienne in France.

She first travelled to Casablanca in Morocco, to the [Belgian-Luxembourg Chamber of Commerce in Morocco \(CCBLM\)](#), where she obtained the false Benelux visa from [Mr Lucien Leuwenkroon](#), the president of the CCBLM.

**On 3 May 1990**, she travelled to Beirut under the false identity of Sophie Demartel. She flew **with American Airlines from Brussels to Beirut and back**. Her return journey took place on **13 September 1990**.

Under the false identity of Sophie Demartel, she had a secret account in Lebanon with **Byblos Bank** since **16 January 1990**. This account currently contains **USD 68,923,711.00**, possibly funded by the proceeds of this type of fraud involving false visas, false identity cards and false passports.

Under the false identity of Sophie Demartel, she has a secret account at **Deutsche Bank** in Hamburg, which she opened on **17 February 1994** and which contains **EUR 69,033,726.00**. She has another account in the United Kingdom, at **Barclays Bank** in London, opened on **17 December 1992**, which currently holds **£77,798,106.00**. All of these secret accounts can be linked to the false identity she uses in the Middle East.

She took pre-signed stickers and the stamp with her [in a diplomatic bag](#). She stayed there for several months, during which time she organised a car accident to kill the wives of prominent Lebanese politicians. In August, she travelled to Palestine to discuss arms with Hamas. Returning to Belgium in September 1990, she began to consider how and when [Mrs Denise Janssens and I](#) should be arrested for the false visa scam.

Like most people, Mr Bechara Matta may not have discussed with his brother Amine the appearance of the official who issued the visa. Who cares about the appearance of an official when you receive good news such as "you have access to the Benelux territory"? You pack your bags and happily set off for a new world without war.

Even if he described the officer's appearance, Dr Amine Matta would never have imagined that it could be the same illiterate nursing assistant from the anaesthesia department at

UCL-Saint-Luc in Brussels, who simply found a way to make money off him. Even the fact that she was a black woman would not have alerted him, as it is not uncommon for an adopted child from Congo to get a job in a Belgian ministry.

What characterises Marleen Seymour and the whole Brabant killers gang is that they make money off someone's back through illegal means, with false identities, and then go after the person who applied for a visa with her, to kill them because they might remember that she was the one who issued the visa. What she wants is for the justice system to think it was me. I am still resisting her attempts to accuse me, even though many things have gone wrong with her initial plan, which was based on typical behaviour, but I am not typical behaviour.

To prevent Mr Bechara Matta from testifying and confirming that she is the person who issued the false visa, they probably sought to kill him specifically in [the huge explosion at the port of Beirut four years ago, on 4 August 2020](#), which killed 218 people. Mr Bechara Matta is a captain in the Lebanese navy, based at the location where the explosion took place.

I also found an answer that no Belgian lawyer was willing to give me to the question of who had filed a complaint with the Antwerp public prosecutor's office for visa fraud.

A retired officer in Wallonia believes that it was CAW who filed the complaint with the public prosecutor's office, but there is no mention of CAW in any of the documents in this case. However, I was never a client of CAW before 2018. How do they know my name?

The complaint against me in 1990 was far-fetched, but the Antwerp police may have acted on the basis of a complaint submitted by CAW, Centrum Algemeen Welzijn or the Belgian Red Cross, given the international scope of this fraud thanks to the International Federation

of Red Cross and Red Crescent Societies. Behind these organisations are other people, notably Mrs Anne Verhoeven, the lady who pretended to be Dagmar Weisz.

[Ms Anne Verhoeven](#) holds 18% of CAW's shares under the false name of **Marie-Jeanne Fraiture de Waterloo**. To this end, on **18 October 1991**, she opened a secret account at **Crédit Lyonnais** in **Vincennes**, which currently holds

My investigation into the 40 disappearances is still in its early stages. They had been admitted to hospital for various reasons, including lung infections.



How do they find the women they meet? That's a question we ask ourselves. For my part, the problem started as soon as I got a phone line that I had never used to contact him. I had barely been connected in November 1990 when, in December, the police raided the student dormitory. There must be other ways for them to find girls.

I was happy for him when he found some stability with Ms Najat Sabir, the woman who has stayed by his side the longest so far. However, the gang began to assassinate him, starting with his sister, who was killed **on 11 September 2023** in the private residence of [Maître Inès Wouters](#) in Uccle, perhaps to send a message to Ms Sabir that she would be next.


