

A new witness claims that Ms Halima Bouhamou did not survive the stabbing

Someone answered my call for witnesses in the case of **Halima Bouhamou's death**. I just received some news from a lady close to the Brabant killers who provided **the whereabouts and the return flight of Marlene Seymour and Professor Roland Willemyns**.

In Dakar they are staying with **Mr Pierre Joyeux**, who is believed to be a **French man** who has been living in Dakar for at least 25 years, but he could also be a Belgian close to the de Wouters van Oplinter family who uses a fake French identity.

Their flight back from **Dakar to Brussels** is planned on **Tuesday 27 January 2026**, with **Flight SN 204**. The estimated time of arrival is at **5:10 AM**.




I will pressure the Moroccan government to immediately restore the death sentence, and to apply this immediately on **General Sellam Sadki's** son Reza, who fatally injured his father with a firearm a while ago. You will see that changing the law on capital punishment will cause La Société Générale to move out of Morocco in no time, to one of their occupied territories like **Guantanamo**.

In a certain way, the information this woman gave, who asked not to reveal her identity, corresponds with what a shepherd who knows the forest very well also reported. He heard something clicking two or three times after which the screaming for help faded.

She also said that the person who received the lethal injection at Ibn Sina university hospital in September 2021 was not Madam Halima Bouhamou. It was someone who resembled her and that person was pregnant.

Halima died at the hospital following the attack in March 2021, and that is why it could not be her in September 2021, because at that moment, she was already dead, the lady said.

All I can do is submit both the first and the second report for verification by the legal authorities who should request all the hospital files concerning madame Halima Bouhamou beginning with the one at the hospital in Ifrane and her husband **Mr Ali Ayad**. They should check if they found any bullets.

The other thing which the forensic authorities can do is to request the shepherd to indicate the exact spot and to screen for residual elements. They may have burned all the clothes Halima was wearing after hospital staff removed them and handed them over to Ms Marlène Seymour, who pretended to be her family member and went to a villa in Ifrane belonging to **Mr Lucien Leuwenkroon, President of the Belgium-Luxembourg Chamber of Commerce in Morocco**, who instructed her to throw all of Halima's clothes into the fire.

However, the forest has a memory and preserves the fossils of everything related to life and death for millions of years. It is where the notion "forensics" comes from.
