

Once that is over, what are they going to fill all these stadiums with?



What is the total cost of the building or renovation of each football stadium? How much budget was allocated and how much of it is left ?

There is no transparency. Please help me find the figures. I think the people of Morocco are also very curious to know more about who financed the building or renovation, how much

money was spent and who was awarded a building contract, and why. With many thanks in advance for putting pressure to publish the figures.

The responsible authority is [ONARGES \(National Company for the Construction and Management of Sports Facilities\)](#).

This organisation will only tell you how many seats a stadium has. There is no financial information and nothing about how the works evolved, nor a list construction companies participating, how much time it took to build it up, what the total of workers involved, what the successes are and if any incidents occurred. That is how we learn about doing things right next time. That is how Morocco builds the expertise which they share with partner countries.

There were 9 opportunities for learning lessons, but it looks rather like an opportunity for filling the pockets of someone. This is why a list of participating companies is mandatory.



I am denouncing the extremely bad economic calculation. The financial haemorrhage could be resulting from psychopaths who decided to build football stadiums all over Morocco for doing other things, like infecting masses of people, with [respiratory diseases like bird flu](#), if they could help it.

It happened already in Morocco. They use respiratory diseases for working people into a hospital bed, after which they send a contract killer like [Miss Marlène Seymour](#), who acts like a nurse who gives a jab, making it look like a routine operation, while the content of the jab is poison. King Hassan II was killed in this way by this woman and her gang of terrorists in July 1999. She would have killed more people in this way in several African countries, including Kenya. 'Public execution' in football stadium shows Libya's descent into lawlessness - Amnesty International

'Public execution' in football stadium shows Libya's descent into lawlessness

A shocking video showing an execution-style killing by an armed group at a football stadium in eastern Libya highlights the authorities' failure to prevent parts of the country from descending into violence and lawlessness, Amnesty International said today. An amateur video published on social media sites shows the purported execution of an Egyptian man apparently organized by an armed group called the Shura Council of Islamic Youth in the eastern city of Derna. "This unlawful killing realizes the greatest fears of ordinary Libyans, who in parts of the country find themselves caught between ruthless armed groups and a failed state," said Hassiba Hadj Sahraoui, Amnesty International's Middle East and North Africa Deputy Director. "Such acts can only lead to further human rights abuses in Derna, where residents have no recourse to state institutions and therefore no means to seek justice or effective protection from abuses." "The Libyan authorities, with the support of the international community, must urgently address the breakdown of law and order that has persisted in Derna and elsewhere following the end of Colonel al-Gaddafi's rule." The video posted online shows the Egyptian victim, Mohamed Ahmed Mohamed, being brought blindfolded into the football ground in a pick-up truck. Masked men armed with rifles then force him to kneel on a stretcher. A statement read out prior to the killing accuses him of stabbing to death a Libyan man, Khalid al-Dirsi. It is stated that he admitted to murder and theft during interrogation by the Legitimate Committee for Dispute Resolution, a body apparently operating under the authority of the Shura Council of Islamic Youth. It is stated that the Committee ruled he is to be "executed" unless pardoned by the family of the victim. It appears from the video that the family refuses to grant pardon. An unmasked man wearing plain clothes, believed to be the brother of Khalid al-Dirsi, is then given a handgun. He is seen shooting Mohamed Ahmed Mohamed from behind, possibly in the head or neck. Amnesty International has also reviewed photographs of the incident posted on social media that show a large crowd of people watching the killing from the stadium's benches. Amnesty International has confirmed with sources in Derna that the killing did take place on 19 August on the outskirts of the city. "This was an unlawful act of brutal revenge, not justice," said Hassiba Hadj Sahraoui. "The Libyan authorities must do everything in their power to restore state institutions and the rule of law in Derna and elsewhere in the country." The state has failed to assert its control of Derna since the end of Libya's 2011 conflict. There has been no police or army presence since then, while the Derna Court of Appeals has been suspended since June 2013 following the assassination of a senior judge, amid repeated threats to judges by armed groups. Members of the judiciary have refused to report to work unless the state provides the necessary protection and security, which it has continuously failed to do. The security vacuum was exploited by various armed groups, including Ansar al-Sharia, which effectively controls the city. Over the past two years security officials, politicians, religious figures and judges have been victims of targeted killings in Derna. These crimes have yet to be fully investigated. Numerous Islamist armed groups operating in the city appear to have taken advantage of the breakdown of the rule of law to assert their control in an apparent attempt to enforce their own interpretation of Islamic law (shari'a). Execution-style killings, such as the one depicted in the video, contravene the fundamental principles of humanity enshrined in international humanitarian law.

What happened to the Moroccan architecture? There is nothing Moroccan about all these football stadiums. There is nothing special to travel to Morocco for.

The lack of Moroccan architecture and design in all these building projects leads to believe that almost exclusively European-based construction companies participated in the construction or renovation of the the major football stadiums, seen from the interior architecture companies, bathrooms and sanitary facilities suppliers, paint suppliers, [steel and other metals suppliers](#), HVAC suppliers, restaurant and cafeteria, ultra modern kitchens, smart lightning everywhere and other electronics, sound and vision technology and high speed wifi and satellite technology which will not be used constantly, only when big matches occur and that is not every day.

It sounds like a big achievement for making the Moroccan people happy, but this could well be just **an illusion behind which perhaps an abusive reality lies**, given that **this situation is suspicious**.

The Moroccan people are not so happy with the expenditure and they have shown their dissatisfaction in a very violent way at [the end of September 2025](#). They are wondering what a high number of football stadiums is going to change in the lives of the Moroccan people. While football was given a priority, other possibilities were suspended.

I would like Morocco to speak up, not to shut up. [The declaration of independence of Morocco was drafted in 1944](#). Morocco has to stand up against abusive foreign interference in Moroccan society, in sports and sports education, in building construction; in telecoms, in Moroccan football media rights, in the vending of entry tickets, in the prices of the entry tickets...



Someone has to remind the Belgian mafia that Morocco is an independent country and that our people are not the property of anybody from Belgium.

Seen from the light show and the sound in and around the stadium, it seems to me that the contract for the sound and light show was awarded to the same team that developed the [Mawazine show](#), which is **a concert-based tourism concept** which my brother thought of and which most probably leaked through Miss Anne Verhoeven who was paid by Mr [Lucien Leuwenkroon](#) to hear my brother's ambitions out, to give that advantage to the Belgians only. That was between 1995 and 1997. They applied the same concept to achieve football-based tourism.

Where did all the beautiful Moroccan tiles go?

Easy to clean Moroccan tiles or Moroccan marble in areas such as the VIP lounge would have been of great added value for our country, and instead of this, it seems that they have used a lot of paint on top of concrete, it seems from the pictures and the videos . Why did they use wood which is inflammable and not appropriate for hosting large groups of people of whom the behaviour is unpredictable ? It will make the room with a low ceiling feel like a sauna during the summer. If an international public is what is expected to come there, then Morocco must showcase the best it has in terms of design and architecture to open new markets. The function of the new football stadium has been limited to football and a little entertainment. If it doesn't help the country open new markets in many other fields, then it was not worth the investment. How much the cost was of that stadium is what we don't know.

What was the description of the project in the tender? There must be more details than just a football stadium. The stadium is not just any football stadium. Did they receive any guidelines concerning participation, ethics, decision-makers, contract awards, and conflicts of interest with the government? There must be a report showing why this football stadium is significant, whom it benefits, and the commercial logic behind it. Did they award contracts to

any sponsors of any football club in Morocco? Are there other similar contracts the same sponsor has with the Moroccan government? What is the total value of all the contracts? Is it any wonder that some sponsors have more capacity to invest in the leading Moroccan football clubs than others? Has that sponsor faced any legal action, such as labor or human rights violations, anywhere in the world? Could he be among the wanted by the International courts of justice ? Is what we see **corruption**?

The absence of distinctive features of Moroccan culture leads me to believe that the project manager was foreign, probably [Sofira Holding](#) of [Mr Lucien Leuwenkroon](#). There could be certain verhoeven involved they would definitely keep the Moroccan tiles for themselves to ship for free and sell very expensive.

Apart from the special press room, the equipped reporters desks at the tribune, the high speed telecommunication, the air-purifiers, which they copied from [Pollock Stay](#) to position their offer to be selected, the concept is not revolutionary at all. It is only up to date with the standards for optimal comfort.

From the VVIP lounges (would you believe), I figured out that these were hotel builders who got involved in this, and with a limited view of what one can use a hotel for other than sleeping. Fashionable furniture and smooth finishing does not mean an upgrade. The people in the best position to evaluate how their experience was so far at Moulay Abdellah Stadium in Rabat and if that is any different than in the old stadium or in any other stadium in the world.

The upgrade is missing, which is still to be done. They could have done a lot better for making the stadium more profitable, and offering more jobs than it does.

The total cost of the Moulay Abdellah football stadium is unknown but what we do know is the total deaths during the constructions

The construction of this stadium, known as Moulay Abdellillah Stadium, was overseen by a foreign bank in Morocco, named [La Société Générale](#) and the project was completed under the regime of a dictator. The pressure for full disclosure and an end to corruption concerning a football stadium that was apparently built at cost, even when people are hungry, dissatisfied, and angry, leaving them with fewer financial resources, is mounting.

A number of Belgian companies were involved in the construction of the new football stadiums and in the renovation of old football stadiums. Massive fraud would have been committed in the construction and renovation of nine football stadiums, in related hotels and restaurants, train stations and high speed trains, and bus connections to help football fans to see all the matches that were held in different cities. The Moulay Abdellah Stadium in Rabat was particularly put in the spotlight on the occasion of the African Nations Cup.

The contractors brought migrant workers to build and renovate the football stadiums. I am wondering what the agreement was with the Moroccan ministry of Foreign Affairs, but in all likelihood, they employed undocumented migrants that were given fake travel papers mainly from Djibouti, Sierra Leone, and Tanzania. Were they truly flown over or are these the people who were hiding in the Forests of Morocco cutting trees and preparing the timber for shipping for [Mr Geert Leysen](#)?

The African workers were underpaid and worked long hours. A total of 2,110 people came to the Moulay Abdellah stadium in Rabat. They were working more than 8 hours per day during which they were exposed to life threatening dangers of falling down or of something falling on top of them. They received €5.75 per day (6,68 USD - 61,51 MAD). That is about the rate per hour in Morocco, which is already a cheap labour country, which they were receiving in one day. That income was insufficient to survive in Morocco, leave alone sending some of it to their families because that was the whole point of traveling to another country for a job.

The slave traders provided everything they needed to survive, such as shelter, food, hygiene products and medical care, and shoes.

Since these were undocumented migrants, they called on the [UNHCR](#) to provide the stadium workers with all the basic necessities. This way, humanitarian aid was provided in peacetime, in an area free of armed conflict, to people with jobs, who had come to earn money, who had not fled their country, and who had come with the intention of returning with a comfortable sum.

Did they have a contract? Is their contract known by the Ministry of Labor and to FIFA, the Africa Cup of Nations, or the African Union Sports Council Headquarters who sponsors the games and the infrastructures? What does the contract say? Is it possible to publish a sample contract on the internet?

The exploitation of African workers on Moroccan grounds in the context of football stadiums would have started in 2002, after Mr Alfons Nuyts was fired from KPN-Orange with a very large dismissal fee according to former colleagues. He didn't have a job, so began stealing our projects for Morocco, because the poor thing would not know any better than killing human beings in the various conflict zones.

I have been exploited by Mr Alfons Nuyts for over 25 years, just like the migrant workers they brought to Morocco for building the football stadium. Could he be the same man who was using the Africans like his slaves?



Many workers will have followed promises and encountered circumstances that didn't match what they initially were led to believe. It's important to remember that these are undocumented migrants, who may not be allowed to be found by the local population, and the workers are often unaware of this. These are people who, with complete freedom, were offered temporary work in another country that they could hardly refuse, and who made that choice based on an agreement. They then find themselves in a situation of captivity, repression, and even murder. At least, that's been my personal experience working in Belgium, which is why I would have preferred working with foreign companies in Belgium.

Given the fraud and extreme exploitation, attempts to silence witnesses to abuse on a massive scale must be considered.

There are rumors that people died during the construction of the magnificent Moulay Abdellah Stadium in Rabat. A total of 283 people were reported killed in that stadium alone, and I am requesting verification of this total and an official report on all these cases.

Of the 283 who died in various ways, 17 were killed by premeditated murder, allegedly slaughtered. Others were [poisoned](#). A female name was cited of a woman who would have carried out the executions in this context. Do you think that she might be [suspect number 4](#) of the most wanted on the list of [the Brabant killers?](#) Do you think it could be her? That's why this needs to be confirmed by the police first, and then I will reconsider my position.



Agronomists and micro-biologists are tackling the problem from the end of pesticides for which they recommend fewer use or organic formulas. They say that the use of pesticides has disrupted the natural balance. The native people in Africa and Latin America knew this before they discovered this in the West.

Their position has further evolved with the discovery of nitrogen, which is currently believed to originate from livestock farming, from animal excrement. The animals have been producing excrement for ages, and now they are treating this as a problem.

Not only the soil, but also the river water in Belgium contains a certain level of PFAS and PFOS substances that are gradually becoming alarming for the safety of drinking water and agricultural products. The number of cancer cases continues to rise in this country and even occurs in newborns. This increase must be reduced, otherwise life expectancy in a prosperous country like Belgium will have to be revised downward. There is a very big difference between living near a 3M production site and living near a mass grave that has never been uncovered, or living in a house with bodies of humans

buried in the cellar, obviously as a consequence of a murder by someone who is hiding this fact to the rest of the society. It happens a lot in Belgium and they are not tackling that. This is where the organic poison comes from.

It comes from dead human bodies that lie underground and do not belong there, and that release poisonous mold. When that mold comes into contact with water contaminated by corpses, decomposer organisms derived from corpses nestle in the bodies of living people, because these organisms multiply in an identical environment that is specific to humans, whether alive or dead. The proteins and sugars they seek are identical in both cases. This nest in the living body causes degradation of human tissue. The spread is called metastasis. This is what we call cancer, and people want us to believe that they don't know where it comes from.

Just one dead under the ground can contaminate the soil of an entire district. That translates into the appearance of cancers among residents, particularly those who have vegetable gardens or who pump water from the ground to water their plants and trees, who use this water to wash their car or clean their house, thus saving drinking water for these purposes or for filling their private swimming pool. In addition, they do this in the conviction that they are doing the right thing for the planet, for the plants, animals and humans. The government will have to forbid this too in order to push back the cancer rates in Belgium.

In our countries (North Africa) we believe that a clandestine pit with human remains is a major cause for concern as it spoils the grounds in ways that are not easily turned back to the original state. When there was the black pest in West Europe in the Middle Ages, there was none in the whole of the Mediterranean region. Cases of cancer only began to appear with the development of the tourism sector in that region. We found indications that this is probably related to the fraudulent acquisition of real estate for which they kill the owners and make them disappear in untraceable ways, so that they would never be found. That would be very deep in the ground most probably on the property itself so that no one would have seen anything strange happening.

Those civilisations in the Mediterranean region have strict rules when it comes to burial of the dead. Clandestine mass graves are not allowed on our territories to keep the soil healthy and appropriate for growing food. That is why we insist on removing the bodies in the mass graves and on an appropriate burial in locations reserved for the dead.

The Western Sahara used to be a virgin region, and since the savages from Belgium came to grow water-based fruits and vegetables like strawberries, melons, tomatoes, bell pepper and citrus fruits, brought with them their criminal habits in search of clean areas for growing healthy food, and they come and contaminate the Moroccan soil with their stupidity.

Killing humans is not an intelligent action and dumping them in a pit is more scandalous. They want to take over an entire region to set up food companies there to grow organic and power foods, using armed conflict, and then they run away to avoid being caught, leaving behind mass graves, just like in their own country, which are discovered by chance and which, in the meantime, are causing deaths due to health problems. These people are so foolish that they should be sent back, as ICE does in the US, and never allowed back into our territory to avoid the plague.

We are not going to allow them to solve their stupidity with their colonisation in our region. This is why the responsible people should be caught and locked up in prison, tried and sentenced severely, so severely that their friends and family who were planning to build their palaces over there with the slavery of our people will promptly make a U-turn.

Like any innovation or project that [the Brabant killers](#) covet and steal from others, they always create tension and stress which results in a fight which is logical when they use lots of lies to convince you of the quality of their brains.

Considering the fact that Mr Luc Vuylsteke is one of Belgium's largest fortunes, I find it striking that he preferred to remarry a foreign woman rather than a native family. In his case, he remarried a woman from Thailand.

He was aware of the trafficking of women that the gang of [Brabant killers](#), particularly [Mr Lucien Leuwenkroon](#) and Mr. [Jens Högsholm](#), is conducting to acquire substantial capital for companies like [La Société Générale](#) and [Sofira](#) , including in Morocco.

These two companies are also behind the construction of almost all the football stadiums in Morocco, including in other countries in North Africa, and of the exploitation of the populations and resources of other countries through such projects.

These two companies and the [UNHCR](#) owe an explanation to FIFA, the Confederation of African Football and the AFCON, and perhaps to Interpol, to the European Commission who was also a sponsor and especially to the United Nations.

Mr. Luc Vuylsteke has a family that ran a petroleum transport company that filled its tankers in Mosul with free oil during the recent Iraq war with the Islamic State. They only handled the transport, leaving the sales and processing to others.

A temporary company was established in the port of Antwerp, which closed in September 2018. I met a Flemish man and his Russian wife at the Victor Night Shelter, once they have lost their home. He had worked for that petroleum company until it closed. suddenly couldn't pay the rent.

Mr. Luc Vuylsteke may have witnessed extreme injustices like attempted plagiarism of our plans to enhance the function of airports, to re-engineer the tourism of Morocco, to develop new technologies, to be masters of our economy and finance and [the plan I proposed to Dubai Airports to help millions of travelers enjoy their stopovers in the Emirates each year, something nobody thought of doing before](#). It may have helped him discover what kind of people he was working with for so long.

It is such a big mess that the only honourable way out is a total collapse of that bank and the rise of new banks that exclude the fraudsters.

When you experience that your bank has taken money from your account without your authorisation or notification, then contact the central bank of the country of the bank and file a complaint there. The central banks are not always aware of fake banks on their territory, and they will appreciate your complaint.

A list with Moroccan participants would also help the MASI (the Moroccan All Shares Index) value rise. That is not exactly what a coloniser wants for this country.

The percentage of local Moroccan or regional enterprises participating is what winning a contract from the International community is about.

It is all about allowing a country to create employment opportunities for the local people, a limited percentage must normally be agreed upon for international participation and for the transfer of technology.

If all that was prevented by anybody, then we need to take punitive measures related to transparency. We need that transparency to inform the young population about the public spendings. The lack of transparency led to the financing of rioters all over Morocco with the poisonous idea that the government has only money for building stadiums and no money for hospitals, for education and jobs.

The absence of a list of participating companies allows evil people to inspire the toxic belief that the members of the government enriched themselves with the funds from FIFA, the CAN and UNHCR. During the days of riots, they spread all sorts of rumours such as the one that the Prime Minister of Morocco would have fled the country. The envious people who are frustrated and who are critical of any personality in power immediately believed it and instead of figuring out if this might be foreigners who want to colonise Morocco and do anything possible to make the regime fall.

In that case, given the sequence of events, and the very short timespan in which the stadium was built, which happened in 1.2 years for each stadium, it looks like they saved a lot of budget some money laundering could be involved, but also human trafficking in both senses

if the supplier is a foreign company from a country with highly hostile partners. They could use the opportunity for their trucks driving in and out of the country easily, with a clearance from FIFA to impress the custom services who think of defending a place in the sunshine for Moroccan football clubs, and approve the transit. Mr Lucien Leuwenkroon is a shareholder of the Lions of the Atlas football club

The trucks or ships that deliver goods may return filled with masses of undocumented migrants who pay fortunes for getting into Europe albeit with fake passports and fake visas. That is how the Moulay Abdellah Stadium in Rabat has already generated incredible revenues for some long before it was inaugurated and long before any tickets were sold.


