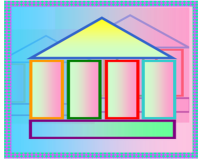

Arguments in favour of the prolonged detention in Egypt of four Belgians and one Surinamese national

Your Excellency Abdel Fattah El-Sisi,

Professor Roland Willemyns paid recruiters involved in recruiting troublemakers for the Arab Spring in Egypt. They were paid with funds from the Bank of New York Mellon in New York where Professor Willemyns holds an account under the name Robert de Béthune from Bouillon. He opened the account on 27 March 1981, which currently holds a total of 129,643,104.00 USD

From that bank account, sums were transferred to an account in Egypt where Professor Roland Willemyns opened an account also in **1981** at **HSBC Bank** in **Cairo** under the false identity of **Paul de Ruyter** from Vielsalm. He uses this account to raise funds for uprisings, such as the Arab Spring.

Throughout **January 2011**, he withdrew **75,000.00 euros** from that HSBC account for each of the **47 people who started the uprising** in Egypt.

The money was **handed over in cash** to a smuggler from Hungary. His name is **Janosz Vargas** and he lives in **Luxor** under the name **Johannes Sceptic**. He mainly **recruited foreigners** from **Nigeria** (Boko Haram), **Libya** (Al-Qaeda), **Jordan** and **Lebanon** (Hezbollah)

Two other accounts are involved in the financing of the uprising in Egypt, from which large sums were transferred and which ended up in the account at HSBC in Cairo in the name of Paul de Ruyter; these are:

A secret account held by the professor, also in the name of **Paul de Ruyter**, at **Société Générale** in **Paris** 12 Daumesnil on opened on **22 December 1992**, containing **100,009,665 euros**.

The other is at **Deutsche Bank** in **Hamburg**, which he opened on **2 January 1992** and currently holds a total of **99,986,155 euros**.

Mr Alfons Nuyts accompanied **Professor Roland Willemyns** in this endeavour, which involved sowing chaos. For the planning and execution, they **travelled together to Egypt from 4 to 23 January 2011**.

The trip was paid for by **Lucien Leuwenkroon**, the chairman of **the Belgium-Luxembourg Chamber of Commerce in Morocco**. He never appears to anyone. He only directs, instructs and pays.

Mr Alfons Nuyts travelled to Egypt under the name **Jean Millefeuille** from Cannes. Professor Roland Willemyns did not travel as Paul de Ruyter but he went to Egypt under the name **Pierre Renard** from Marseille. They stayed with a Frenchman who still lives and works as a property agent in Cairo.

Mr Alfons Nuyts opened an account on **17 November 1989** at **La Société Générale** on the Champs-Élysées in **Paris** under the false identity of **Jean Millefeuille** and has since accumulated a total of **109,778,052.00 euros**

Using the same false French identity, **Jean Millefeuille**, he opened a secret account on **17 March 1996** at **Attijariwafa Bank** in **Tunis** (Tunisia), where he is hiding a total of **97,110,483.00 USD** from the Belgian tax authorities.

He also has a third account under the same fake French identity at the **Bank of New York Mellon** in **New York**, which he opened on **23 November 1994**, in which he currently hides a total of **102,998,701.00 USD** to sponsor troublemakers,

From these accounts, sums were transferred to finance the uprising in Egypt to an account held by His Excellency **André Azoulay** at **HSBC Bank** in **Cairo** under his real name, which

he opened on **11 November 1972**, in which he currently conceals a total of **691,111,747.00 USD** from the Moroccan tax authorities.

To many, the unrest in Egypt appears to be a natural popular movement which started with spontaneous protests. Proof that this is not the case at all is that a lot of money was spent by someone to set this uprising in motion, and that is the part which until now remained unseen. This is an aspect of the reality of all wars that has never been studied by historians, who have never questioned the artificial nature of the wars in modern times. It is not natural for a war to break out in a society that has always managed peace successfully in the past.

Our research began with the question of why the Second World War lasted exactly five years, no more and no less, and how there could be so much hatred at one moment and so little immediately afterwards, unless it was linked to how much people were earning from harbouring that hatred. Our way of reasoning led eventually to the discovery of foreign legion fighters being paid extraordinary salaries to create the conflicts that we see all over the world. It also led to uncovering the source of funding.

The total cost of the 2011 uprising in Egypt is 311 million USD

In addition, there are the costs of the damage to the Egyptian state and the loss of life among the Egyptian population, which may have been caused by terrorists from the Occupied Territories and not by the Egyptian army, yet it was presented as the Egyptian army shooting down their own people. The whole world believed this and it increased the rejection and travel bans on Arabs and Muslims around the world, while the corrupt Belgians who occupy other people's countries can travel to anywhere without a visa.

The majority of the troublemakers who do it for the money were part of **the foreign legion**, most of whom were stationed in the **Occupied Territories of Palestine** and used to kill the **Arabs**. If they think they are the Belgian State so let them come up with their own plan to get out of prison. In this case, they do not need the Belgian government to intervene. As we just spoke about the Devil, allow me to elaborate on how [Attorney Inès Wouters](#) works :

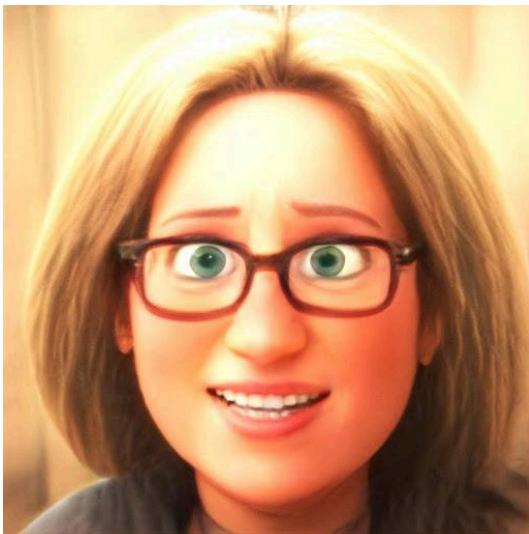
