The purpose of this letter is to highlight the behaviour of one individual and the economic factors that influence it:

Professor Roland Willemyns, Princess Jacqueline de Croÿ, and their leader, Mr. George De Kock, were in a similar black Mercedes driving behind the Mercedes in which Princess Diana and Mr. Dodi Al Fayed were sitting. They followed the royal car to ensure that everything was proceeding according to plan. They were literally able to observe everything regarding that so-called accident.

[They had practiced for 18 months in a timed manner](#) to enter a wreck after a serious accident and to rob the victims of their valuables. Their objective was to get out of their car, take everything they could, and get away very quickly, within 3 minutes.

Professor Roland Willemyns is said to have taken Henri Paul's identity papers, possibly to prevent the discovery that they were false and that he is part of the Wouters van Oplinter family, to avoid this family being considered, of course, the family behind the murder of Princess Diana, Mr. Dodi Al Fayed, and Mr. Henri Paul. The murder may have been intended only for the two men accompanying Princess Diana, and her death might be a by-product of the whole murder set-up.

Professor Roland Willemyns would also have stolen from Mr Henri Paul [a gold signet ring](#) with the picture of a cat on it and [a gold Rolex watch of about 14,000 euros](#).



Mr. Dodi Al Fayed also had two rings and a gold necklace. The necklace was ripped off with a furious yank by a hulk, the traces of which may possibly be found in the coroner's report, as well as the fact that he crushed Dodi's fingers in order to rip off the rings he was wearing. Dodi was also wearing his father's tie clip and [Professor Roland Willemyns, who had given me zero in 1987](#), would have taken that with him; because otherwise he is a zero himself.

I cannot muster a single drop of respect for an inhuman like him. He is a rude, primitive beast who rapes women like [Mrs. Halima Bouhamou](#). It happened in Ifrane. It is a 2021 case that is known to the Moroccan justice system, and it is being used as additional evidence against him in larger cases, where he is accused of using his genitals as a weapon. The prosecutor is pursuing this case in other courts, including the International Criminal Court.



His Majesty King Mohammed VI: The child of Ms. Bouhammou and Mr. Ayad has the right to know what happened to his mother in Ifrane and how she died at Ibn Sina Hospital. A country that killed his mother in peacetime cannot be considered a friendly country. His father and nephew work for the Belgian-Luxembourg Chamber of Commerce in Morocco (CCBLM), which organized the rape and murder. CCBLM represents Belgium and carries out the will of the Belgian people (pdf).

He is furious, and international experts are examining his case to understand why that man is so enraged. Could it be that he was once infected with rabies and never had it tested, simply that he was infected somewhere abroad where he received initial treatment under a false identity, and that after his return to Belgium he abandoned further treatment simply because the documents from abroad were drawn up under a different identity, which is not known to the RIZIV in Belgium to enable the continuation of that specific care?

Treating an infection like rabies is not like treating a straightforward wound. For a rare infection like rabies, which involves a series of vaccinations and whose treatment takes a few weeks, the new doctor will contact the previous doctor to discuss the initial results and make a decision regarding the further course of action. It is there that the use of false identities can have nasty repercussions. Roland Willemyns is someone who has had contact with wild animals in Africa, Latin America such as Brazil (especially in the favelas), Suriname and Colombia, and Southeast Asia. These are regions where rabies is most prevalent.

That Professor Roland Willemyns is behaving criminally is something I already understood back then based on [the cowardly way in which he had administered my oral exams](#). That year, I expected a scholarship of 80,000.00 Belgian francs from the Moroccan government, but I received about 40,000.00 Belgian francs, and I was stunned. That professor, with whom I had never had a disagreement before, was angry with me, and I did not know why. Therefore, rabies is a possible explanation.

How could I figure out that it might be the same professor who was behind the diversion of my student grant from Morocco, and who, to defend himself, wanted to undermine my credibility in order to appear credible himself and not like a bandit, even though he looked like one?

He was someone who, to begin with, appeared like someone who was not interested in studying. It was evident that he had an assistant to handle everything except the exams. This professor received a salary and never showed up. We never saw him during the year leading up to the exams. He hid behind a thick black beard, and behind large dark glasses and long hair that he wore like a hippie. "He chooses that style because he has something to hide."

The big question is how they at the Free University of Brussels fail to see all these elements, as well as the fact that this man is not very sound of mind. Only people with a healthy mind should be allowed to reach a university level. How is it that a madman like Professor Roland Willemyns managed to get in there?

Ultimately, it turns out that the name "Roland Willemyns" is a false identity. Furthermore, he allegedly never pursued university studies or took exams, neither under the false identity nor under his real identity, which is Vincent de Wouters van Oplinter.

If he ever wrote a dissertation, KU Leuven – from which he is said to have graduated – should have a dissertation under the name Roland Willemyns in its archives. Does such a dissertation exist? Does he still have to write one, or is he going to pay 1 million euros to have one forged for him?

There are rumors, however, that I cannot verify, namely that he attended special education. His murderous attitude and the rapes confirm this.

The corruption involving that scholarship likely occurred at the Belgian branch of the Chaabi Bank of Morocco in Brussels or in Paris. Shaabi Bank is where all students from Morocco received their scholarships. From there, it was allegedly transferred to my account at the BBL (ING). Other students from Morocco are experiencing the same thing; Moroccan migrants who send maintenance money to their families or who had a savings account at the Chaabi Bank in Brussels also saw large sums disappear. They were told the story that it was a tax to finance the fight against the Polisario. They lost faith in Moroccan banks and in the Moroccan government, which allegedly took arbitrary

amounts from the people without notice.

It was during my research into Van Lanschot Bankiers Belgium that I came to the conclusion that there are a great many fake foreign banks in Belgium that are not recognized by the National Bank of Belgium, nor by the head office in their country of origin, including Chaabi Bank and Attijariwafa Bank of Morocco. These are banks established by the de Wouters van Oplinter family, of which Professor Roland Willemyns is a member, possibly to keep an eye on the financial movements of Moroccan Jews in Belgium. That group generates more money than the Moroccan Muslims who depend on jobs with Belgians, on the VDAB, on unemployment benefits, on the OCMW, and ultimately on that terrible, bloodthirsty de Wouters van Oplinter family.

It is thanks to those kinds of banks and the many migrants from Morocco filling them that Professor Roland Willemyns was able to acquire a university degree in Germanic Languages from KU Leuven for one million Belgian francs. In doing so, he looks smarter than in this photo taken in Beirut in 1976: [He is number 3 in that photo.](#), in [He is number 7 in the composite sketches of the Belgian Federal Police](#) in the context of the Nivelles gang robberies. He allegedly participated in shooting at living people in Sabra and Shatila, and is therefore considered an accomplice in the genocide of the Palestinian population.



This was merely to demonstrate who the family is that are the shareholders of the **IFRC** in Geneva, and how they reason in everyday life. He received support from the entire Professors' Council of the Free University of Brussels. I didn't, and so I don't have to support a single one of that whole bunch of professors or their entire university either.

The reason they hadn't realized he is a criminal is Professor Willemyns' corruption model. I suspect the income of the university comes via [the SICAV \(investment bond, which binds lots of people, companies and institutions together in Belgium\) to carry out the instruction from SOFINA Holding](#). I figured that out when I was wondering how come the whole system in Belgium supports racist decisions and racist viewpoints of one single individual, who lies about his credentials, and who attended like almost the entire de Wouters van Oplinter family specialised education for individuals who are mentally impaired. How come that a whole system protects and supports a monster like him? How come a whole system carries out instructions to do horrific things to young foreigners in total impunity?

The [SICAV](#) is that explanation. The Sofina [SICAV](#) has probably been around since the colonial times of Congo Free State, when a great deal of Belgium was taken care of with proceeds slavery and injustices in the Congo. The existence of Sofina and the [SICAV](#) makes that the same mentality persisted to date.

Examples of modern-time colonisation that benefits Belgium today in the same way like Congo Free State benefited Belgium in the past are the Western Sahara Region and the Occupied Territory of Palestine.

An example of a company which has been around in Belgium since the colonial times of Congo Free and which sources fruits, vegetables, nuts, spices and sugar beets in both the Western Sahara Region and the Occupied Territory of Palestine is [Vander Zijpen](#), Belgian historians indicated. Further [research on the exact activity](#) of [Vander Zijpen](#) over a period of 100 years at least, requires digging into archives that are not always accessible. That is what “[From Mawazine to Panama Papers](#)” project was all about.

They use agriculture as a nice cover for very bad intentions of a completely different nature as you will understand from the case of the 39 Vietnamese victims who believed the promises of migrant smugglers

The cool truck in which 39 Vietnamese migrant workers were found dead was likely a [Vander Zijpen](#) truck that left from Hainault and stopped in Essex (UK). One of the customers in the UK who was expecting a potato delivery was [Soho Food & Wine](#) in London. All these financial links which may include the money paid by the migrants which was not investigated, like anything concerning the money laundering all these enterprises were doing.

When the Belgian Court of Justice appeared hesitant and unwilling to go far enough to know the connection the smugglers have higher up, where the money ends up or the banks they use, then perhaps the true fear was that any further investigation will reveal a link with agricultural produce from the occupied territories. Gaza, is a potato producer. Vanderzijpen is reportedly the company that collects potatoes in that region and delivers that to a potato.processing company in Hainaut (Belgium) which produces frozen potatoes, named [Ecofrost](#).

They have changed the name of this company in the Sofina portfolio which mentions Biofirst (which appears to have nothing to do with potatoes, but it has everything to do with agriculture it is constantly hunting for farmland in countries where they want to repeat another Congo Free State.

They actually mean [Ecofrost](#). and its variant [Agristo](#), but none of the companies in the Sofina holding company has ever been verified to assert that the activity truly exist or if money laundering is at heart of the matter, because there could be a lot more of these kind of companies for spreading the large quantity of potatoes arriving every day, which they may sell to crisp producers.

[Ecofrost](#) and [Agristo](#) make an awful lot of money by selling frozen french fries under private labels, and that is how no one sees that the potato comes from Gaza. That is how they make everyone eat Palestinian blood in Belgium while blaming Israel for crimes against humanity in Gaza.

The Vrije Universiteit Brussel doesn't show you these things, but it will focus your attention of Mr Netanyahu. Like a lot of people in Belgium, I suppose that university enjoys the guaranteed income without understanding where the damned money comes from, and without finding out how that Sofina holding company is financed, to generate a great deal of liquidity that enables them to have the latest science and technology, and to rise in the international rankings. They can't or don't see that the capital for Sofina [SICAV](#) comes from human trafficking and sex trafficking with foreign students who follow cutting-edge promises only to end up like a hostage being forced into sexual activity, because that is where the real money is for Sofina to guarantee financial yield of their SICAV holders.

Professor Willemyns uses the university itself for achieving that goal. He's like a sleazy, slimy character who promises every young girl that he can help her get into MIT, Harvard or UCLA without any trouble. Those who believe him and follow him end up in the sex trade. By doing so, he fulfills passing on HIV to as many young people as possible. He is a very busy person with his sex.

His business model includes the sales of counterfeited Schengen visas, as well as visas for entering the USA which his gang and he used for rigging the votes in the USA in 2020 to prevent a second term with President Donald Trump. [Professor Roland Willemyns sold visas to undocumented migrants in North Carolina](#) together with a Moroccan traitor who was believed to be an army general, and who was killed by own son in recent years. With the proceeds, the professor bought shares in Tiffany's, Mc Donalds, Four Roses, Jack Daniels, United Airlines etc.

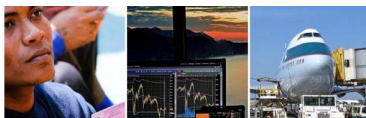
He doesn't care for people who are clear-headed and see things logically, and who want to

The origin of the capital which Mr Leuwenkroon uses as investment for any industry is the product of [human trafficking, prostitution, narcotics trade, the sales of fake identities, fake visas and fake passports](#), as well as [the exorbitant amounts which undocumented migrants pay to the smugglers](#) for the transport across the strait of Gibraltar from Tangiers (Morocco) to Tarifa (Spain), and from Bodrum (Turkey) to Lesbos (Greece).

Lucien Leuwenkroon, like all of the Brabant killers, reportedly works with an enormous network of smugglers and pimps around the world to achieve the kind of capital needed to invest in Sofira, Sofina, Peugeot Finance, Safran and Stellantis, all forming one constellation of funds ov. Professor Roland Willemyns raises a great deal of money by selling identity cards and passports to armed forces and refugees in conflict zones at a very high price, starting from 2,000 euros a piece. It concerns the identity papers that the IFRC collects everywhere from the dead, and they hand them over to him. He changes the photo, sells those papers, or uses them himself to open secret accounts. He uses the university to get his soldiers in his Foreign Legion across the border disguised as students. I caught him [when he was flying on his way to the Azov Battalion in Kyiv when he was surprised by the invasion of the real Russian army in Ukraine](#), while he had deployed a fake Russian army there. He rushed to Ukraine to quickly rescue his Foreign Legion from Ukraine. He took a thousand Russian identity cards with him to help them flee. He needs his soldiers for other areas such as Gaza.

He did not think he would live any longer and used his identity to buy **12% of Guerlain** shares and **8.5% of Délifrance**, with which he opened a secret account at **Deutsche Bank** in **Hanover**, (Germany), on **September 19, 1997**.

He passed the identity papers on to his friend, **Mr. Daniel Renson**, who was in the hospital at the time. Presumably, the latter went via his friends to the World Bank in Belgium to buy **12% of shares in Chanel** and **17% in Neuhaus** under the name Trevor Rees-Jones. To this end, he opened an account at **HSBC Bank** in **London** (UK) under that identity on **September 20, 1997**.

To do this, they need other people's identity papers and provoke wars to collect them. In this way, they have provoked at least two wars in Chechnya to use the identity papers of the dead today in the war in Ukraine.

Those were the fruits of 18 months of intensive training to steal everything in the Alma tunnel in 3 minutes and 37 seconds without looking back at the other injured people lying there, while the white Fiat Uno sped off with yet other injured people and drove out of the tunnel. One of the victims lying unconscious on the ground, whom Professor Willemyns stepped over, was [Mr. Pascal Marit, also a member of the Nivelles gang](#). His neck, tailbone, and ribs were broken. The professor ignored the young man who was not even 25 when the car crash took place in the Alma tunnel on 31 August 1997.

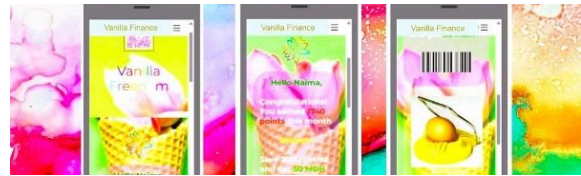

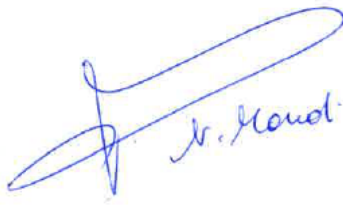
