I am referring to [my previous research](#) on the accident in which Princess Diana, Mr Dodi Al Fayed and Mr Henri Paul were killed and their bodyguard, Mr Trevor Rees-Jones, was severely injured.

We are finally finding answers as to who was behind this meticulously planned terrorist attack, which they could not blame on Muslims. Had they blamed an extremist group, the accident would not have remained a mystery like it is still today.

We found more victims and more people who were involved in the large setup, such as Mr Pascal Marit, the son of former neighbours in Sint Steven Woluwe.

On 31 August 1997 he was chasing the black Mercedes of Princess Diana and communicating through the CB radio possibly with several correspondents among which the driver in the white Fiat Uno and the control post of the security service which was dominated by Mr Jens Högsholm (see further down), then the CB radio technician acting as a security professional at the Ritz Hotel in Paris.

Pascal was chatting until the accident in his motorbike hit one of the cars and was projected meters away and fell on his head. I am discussing the possible brand and type of communication system that was used, with illustrations, a little further down. If **an airband monitor or a black box** exists for the telecom system (and there might be one in the wreckage) which was used, then the abrupt interruption in the communications with Mr Pascal Marit can be tracked.

Mr Pascal Marit was reportedly already working at a Volkswagen-Audi plant in Anderlecht (Brussels) under this very name. If it was him, there must be something concerning his absence from work and sick leave indemnities, and some insurance in his personnel file that would be of use to this investigation. That file should be confiscated by Justice.

The ambulance which transported him directly to Tournai in Belgium, was a Red Cross ambulance that was prepared by the conspiracy like all the other ambulances to either rescue the victims or to finish them off inside the ambulance, and to pretend that the person died on the way to the hospital. They prepared the ambulances to disappear quickly, through which the French authorities found only the four victims that we know, and not the others. There were severe injuries in the Fiat Uno which disappeared from the radar that night.

The brakes of the royal Mercedes were intentionally loosened to cause them to snap during the race through the Alma tunnel by people who actually targeted Mr Henri Paul, and that was his brother Mr Lucien Leuwenkroon.

He would have used this company for getting introduced to the Moroccan Royal Palace, to get as close as possible to King Hassan II, in the days before he died in 1999. So that is their trick. They use a security company like G4S for poisoning people, for slashing throats, for shooting down people in leadership positions, intellectuals, inventors, scientists, doctors, bankers, even artists and singers and all the people who are capable of leading humanity towards a higher form of living and attracting wealth. Progress is something they view as a threat for the wealth of their Société Générale.

When you make money, they have the feeling that their bank is losing money, even when there is no link whatsoever. **They are a super jealous breed** who don't deserve to be among the humans **at all**.

Mr Alfons Nuyts, born Jean Philippe de Wouters van Oplinter, has been on [the Belgian Federal Police's most wanted list since 1983](#). He was one of the passengers in the white Fiat Uno who carried and used a gun in the Alma Tunnel on 31 August 1997. He is a highly negative person, full of hatred. That is how you will recognise him. He carries out shootings and mass exterminations mostly in Islamic countries such as Lebanon, Gaza, Syria, Libya, Western Sahara, Yemen, Iraq and Afghanistan.



He is believed to be directly connected to the killing of Libyan leader Muamar Gaddafi,

Another variant of the same ploy is the use of humanitarian aid or relief work to get as close as possible to the victims of mass murders, while wearing the coat of humanitarian organisations in which he is a shareholder, such as the International Federation of Red Cross and Red Crescent Societies (IFRC), UNHCR, Caritas International and Gaza Humanitarian Foundation.

It is a widely spread ploy in Belgium where [the social aid system is used as a hub for the trafficking of women to buyers like Mr Jeffrey Epstein](#) and for the recruitment of drugdealers. It makes the whole of Belgium a country where good democratic values are projected illusions or as honey for victimising people. One has to be prepared to be disappointed in the promises their institutions make that this is a country of freedom where you can be who you want to be. They are oppressive by nature and combat free speech, and that explains why it takes the three decades to tackle a simple car crash caused by their citizens in someone else's country.

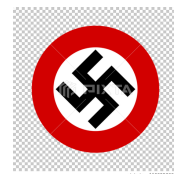
We continue to investigate whether Mr Alfons Nuyts used his capacity as a security guard, perhaps of G4S in the days leading up to the assassination of Princess Diana, Mr Dodi Al Fayed and Mr Henri Paul, and whether he had a licence of carrying around a weapon.

Mr Jens Högsholm is a major shareholder of G4S under a different fake identity than the one by which he is known in his hometown Copenhagen, by his wife, **Madame Filomenita Mongaya**, and his client-employer ESA. I am investigating the G4S shares with the plan to have everyone dump G4S, as they will only send spies and terrorists to destroy the businesses and the banks of your country. That's all they know how to do well, but to think of something constructive, they are zero, and La Société Générale educates entire societies to function exactly like them, which is to kill the good, to keep the very bad, and to let scam prevail.

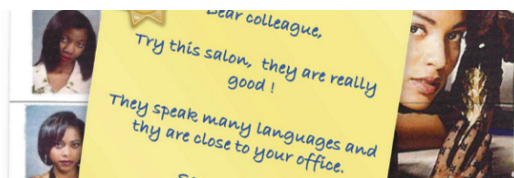

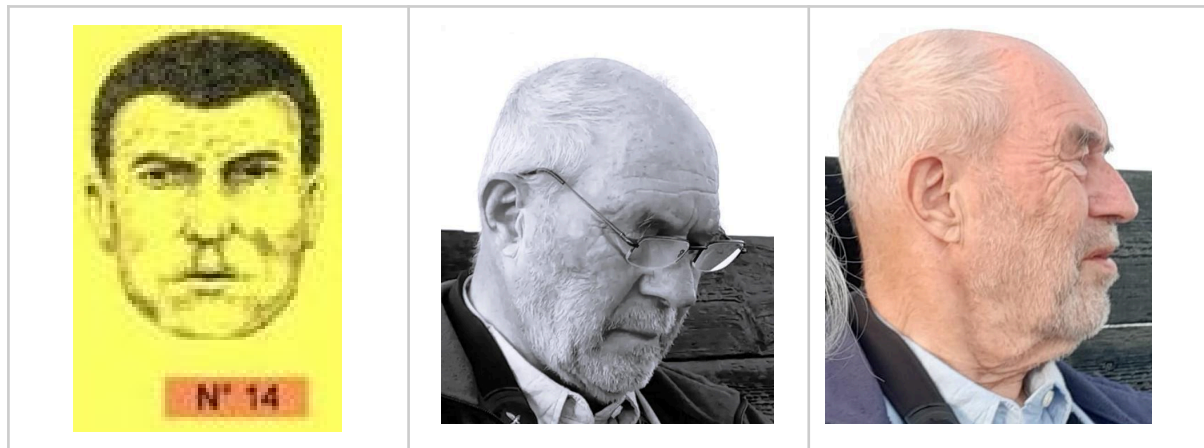

Our AI-driven facial recognition software indicated correspondence with [suspect number 14 in the dossier of the Brabant killers](#), who is on [the list of most wanted by the Belgian Federal Police](#) is someone who works at the European Space Agency in the Netherlands, albeit through an agency, like a security agency. This is his mugshot and his photo :



His name, job and even his home address, which is **Babaylan DK Phil.Women's Network, Strandhøjsvej 12,3050 Humlebæk DENMARK, tel.0045 49194690/ 26918354, orgweb: www.babaylan.dk**. This information is publicly known by all these services though his picture doesn't appear on any of the international wanted list. The explanation for the omission is that he was protected by big financial institutions among which [La Société Générale](#) in Paris, Crédit Agricole, Sofira Holding, Sofina Group SA, the World Bank and the IFRC pension fund in Geneva, and perhaps the Crédit Suisse as well.

It is unclear whether large sums were paid to achieve that omission, but I will continue to investigate because he was involved in killings and human trafficking to generate substantial funds not only for building a business empire, but also to secure his release whenever manslaughter is suspected. He was never stopped once. I was arrested for nothing. Wouldn't you do everything to see him captured, if you were me?

It is his habit to attack others and to never get arrested. His arrogance has reached the point in which he doesn't distinguish anymore cleaners or farmworkers from people with very big responsibilities like world leaders, first class business leaders, judges, Heads of State, kings and queens, princes and princesses, who we must respect whether we like it or not.

The man was described as an ultra-racist individual. When he got involved in orchestrating the clash between cars in Paris on 31 August 1997, he already had the habit of attacking highly visible public figures all over the world.

He was probably born between 1936 and 1942. By 1957, he was already old enough and skilled enough to carry out assassinations of leaders. These were numerous in the 1960ies and 1970ies because of the Civil Rights Movement in the south of the USA and a lot of social mobilisation everywhere. Many concerned racial tension, and he was old enough to be a racist sniper. He met his wife in Washington DC in the mid 70ies. He must have been living there for quite a few years before moving on to the Netherlands and then Denmark. He had links with Texas, perhaps through [G4S](#).

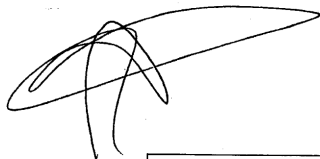

Mr Jens Högsholm was fired as a gendarme in 1982. He was accompanied by his colleagues from the gendarmerie who work for the state security and it is not clear if he pretended to be still part of the police or if he sneaked into the building through his own security company which is G4S, on which that office building was relying. The office building could be a property of Sofira Holding, the real estate arm of [La Société Générale](#).

I kept a copy of his picture, at a moment when I didn't know that he had anything to do with the fake visa scams in Antwerp in 1990, during which several home and office searches resulted in finding **TH26E transceiver radios**. TH in TH26E stands for Town Hall as Kenwood supplies adapted two-way telecommunication equipment for the government, the security services, the police and the military.

This particular model enables transmission between two devices at a distance of up to 50 km. Kenwood is a Japanese brand. It is recommended for maritime transport, and perhaps for helping smugglers dodge the maritime police, and for Red Cross ships to play the taxi to pick up refugees and migrants with fake Benelux visas, in order to say that I smuggled Moroccans into Belgium.

On 30 August 1997, he was also in Paris at Mohamed Al Fayed's Ritz Hotel. He is said to have worked there as a security guard under the false name of **Gilbert Beaufays** from Avignon.

He is said to have used this position to communicate via the same satellite telecommunications equipment as that seized by the police in 1990 in connection with the scam involving false visas for migrants from Morocco who were residing illegally in Belgium. His colleagues in the Nijvel gang all had such devices with them, enabling him, as the leader, to give instructions on who should leave when and where.

The French police allegedly found and confiscated such devices in the wreckage of the damaged Mercedes, which was driven by Mr Jens Högsholm' half brother, Mr Henry Paul; and Mr Pascal Marit's Yamaha or Kawasaki motorbike.

That is why the whole gang is angry with France for an accident that was prepared and organised by Belgians. In fact, they are angry with France for all the crimes they themselves decided to commit and carried out.

This is just like in my case, where they brought me before the criminal court with lies, with serious charges and then they got angry because it resulted in a court case in which I had to go to trial, and in which I was sentenced. They got angry with me.

I am requesting governments and courts around the world to help me understand why those who accuse me and they filed complaints against me at the court of justice, get angry with me afterwards, and I don't even know who they are. Because Belgium has refused to free me from that sort of injustice, I am seeking help beyond Belgium's borders.

The Kenwood radio system which is mentioned in the [judgement document of 8 March 1996](#) has directly led to questioning whether Mr Jens Högsholm could be the true suspect number one who didn't get caught in a highly confusing criminal case which remained unresolved until now.

So, the chances are that in Paris, Mr Högsholm would have used loads of this material which was probably stolen, because there is a court sentence mentioning a system that is exclusively reserved to the police and the military, not for street gangs.

What is missing so far are elements of aerospace. If we have that, then this would fit the profile of Mr [Jens Högsholm](#) in Denmark.

The investigators found **two TH26E transceiver radios**, which brings us one step closer to satellite communication which requires aerospace technology. This also brings us closer to airplanes and eventually to the drones that puzzle us today .

I kept inquiring about the driver of the Fiat Uno who reportedly was **George Mathews** from **Brisbane** (Australia). **The number plate of that car was French.** It was a genuine number plate from **Limoges**.

Mr George Mathews lives in Christchurch and is said to have been involved in [the shooting at the mosque on 15 March 2019](#). There, too, he was the driver who drove the shooter(s) away.

While the press reports about one shooter, they were actually two shooters, among which one was called **Sylvain Lemouch** from Caen (France). The high number of victims might provide indications of more than one perpetrator. He is married to Sophie, the sister of **Geert Leysen**, who was born Louis Fernand de Wouters – de Bucquoy.

I don't have a picture of this man, but he is married into a Moroccan family named **Fertoul** who got their whole entire forest in Tangier stolen in 1969. The forest is currently occupied by IS Jihadist, by masses of undocumented migrants and refugees who want to reach European grounds.

The migrants are temporarily employed almost like slaves in the exploitation of Moroccan timber, by cutting the trees. In this way the migrants make the money needed to pay smugglers to take them by boat to Europe or to buy a Schengen visa to travel by plane, train or bus. That, too, amounts to slavery, because the migrants are given forged Schengen visas against a price that equal one year of work in timber or agriculture.

The timber gets exported to [3D Pine Tree](#) in the USA and imported in Belgium as an American product. They were making an awful lot of money in Belgium with kitchen builders, funeral services, interior decoration companies, construction companies (like Verhoeven Tegelcentrum), and chances are that they were selling wood to Ikea as well. Morocco and the owner of the forest, who are the Fertoul family, were making zero money at least since 1970.

Mr Geert Leysen has a French wife with two adult sons in Tangiers for whom he built a hotel

which generates good income with forest-related activities. When this was brought to the attention of his Moroccan wife, she was in a state of denial, her sisters told me. She was very forgiving and stood by her man. He is not the kind of man who understands that language, because he is a crook and a human trafficker. She is not going to admit that she made a very big mistake.

The Moroccan family Mr Leysen married into have been wondering who the people are who got hold of their forest, until they met me. Sisters to the wife were complaining about a highly controlling Belgian interfering with their lives, and I immediately know that he was in that family for making money with contraband and for blaming the Moroccan family member to get them all locked in jail so that he can colonise their properties in Morocco.

Occupation of other people's land anywhere is **a practice from Belgium** and the Belgian man who married their daughter is a shareholder of La Société Générale under his real name. This is why he changed his name before he married the Moroccan woman, it is so that the daughter he has with her can't claim any inheritance of shares at La Société Générale, but he can use her mother's name to claim the forest to his advantage. As you will understand, such claims are only possible when the owner dies.

All the men in de Wouters van Oplinter family end up assassinating their wives and mothers. That is to be expected in Geert Leysen's and Jens Högsholm's case. They don't have family values and ought to be avoided. They are horrific.

La Société Générale is a bank that hunts for real estate by sexually exploiting people like the example of Geert Wouters who uses a marriage to get to owning the vast forest that he always wanted, for growing the international portfolio of her Sofira Holing.

It's a bank which doesn't need Mathematics or rocket sciences for becoming so gigantic. It uses beds, pillows and lingerie. That is how the revered Société Générale functions. It's called human trafficking.

This bank doesn't belong in any Arab country. It's only interested in people's pensions which she doesn't want to pay, like the one of the dancers of [Moulin Rouge](#) en [La Folies Bergère](#), who spend three of four decades performing on stage during long hours at night, on very high heels and they have to wake up early to maintain their fitness and to practice the choreography with the other girls,



In addition to fitting the costumes, preparing the hair and the make-up every day of the week. It is not a 9 to 5 job, and that is without serving individual clients on demand... you know what I mean. They can't make money when they are ill. They cry tears because they have to dance and if they keep on going, it is because they can't escape from that milieu. Show biz is one of the toughest activities on the planet. When they retire, they get deprived of a decent pension.



His Royal Highness Prince William and Her Royal Highness Princess Catherine, the Prince and Princess of Wales Mr Henri Paul led a double life as a security director and human trafficker. He killed Penelope and Virginie Dutoît, dancers at the Folies Bergère

For Her Excellency Ursula von der Leyen, President of the European Commission: Rabia Hamouche (80) may have worked for Henri Paul, who had a stake in every French cabaret. Her cleaner at the ZorgBedrijf Antwerpen, Marleen Seymour, is also a cabaret owner in France. This may explain why Hamouche's pensions are under attack.

The man who arranged for all the cars was Mr Moshe Weissmann, currently hiding in Sudan where he is attempting to develop a real estate business similar to Sofira Holding, which

owns large industrial areas. He is searched for in Morocco in the context of mass graves related to big infrastructure construction projects.

As you can see, the file concerning the accident that cost the life of Princess Diana, her friend and chauffeur contain a lot more injured people than what was known by the public, as one motorcyclist and 5 or 6 others who were in the white Fiat Uno were also severely injured. There are medical records existing of which one at Pitié Salpêtrière University Hospital in Paris concerning Professor Jan Wouters who received a bullet in his head injury and was kept in an artificial coma first in that hospital, then at a hospital in Tournai (Belgium).

It was while gathering clues about what happened to the hospital file concerning Miss Muna AbuSulayman, a prominent figure and media personality from Saudi Arabia, who in May 2013 was taken hostage, drugged, tied at the hands and feet, locked up, tortured and raped during at least 48 hours in Laayoune (then Occupied Western Sahara) by [Mr Lucien Leuwenkroon](#), the President of [the Belgium-Luxembourg Chamber of Commerce in Morocco](#) and by [Mr Moshe Ali Mustapha Weissmann Bouhamou](#), his cousin and righthand.

After the rape, Miss Muna AbuSulayman was rushed to a hospital in Morocco where she underwent several surgical operations for reconstructing the genitals. She was diagnosed pregnant and she carried through the pregnancy, as abortion would be doing worse.

Directly after giving birth in Luxembourg, she and her baby were both taken hostage again, first by Professor Roland Willemyns who drove her to Brussels, where she arrived blindfolded and received by Mr Alfons Nuyts who locked her up at a mansion in Saint-Josse-ten-Noode, where she remained inside to breastfeed her baby during two or three months after which he took away the baby from her and sold it to a Belgian adoptive family to prevent an Islamic upbringing and the circumcision of the young boy.

Meanwhile Miss Abuslayman developed swelling and infections in her reproductive organ, and went to a hospital in France where they recommended the removal of the entire reproductive organ to prevent the further spread of the infection or disease. [Mr Lucien](#)

[Leuwenkroon is a natural HIV carrier](#). He is also a pedophile, a necrophile, obviously a rapist, he visits whorehouses and he mass rapes in war zones like Bosnia, the Congo (Kivu in particular) and Rwanda with the intention to pass on deadly diseases like HIV. It is logical that any woman would narrowly survive sexual contact with this pig. He's a nasty beast.

Miss Muna Abusulayman was lucky that she visited a hospital where they are experienced with this phenomena. You will find that experience in and around Belgium, in the North of France, in Luxembourg, in Germany close to the borders with Belgium and in the Netherlands, but once one is outside that geographical scope, and one develops a health condition resulting from sexual contact with poisonous individuals like [the Brabant killers](#), it becomes harder to find doctors and surgeons who can handle efficiently matters HIV, HPV and cancer, and the death rates resulting from rapes in those geographical areas are much higher. That is the reason why [the Brabant killers](#) focus on areas in the Mediterranean for committing sexual violence.

During that phase Miss Muna Abusulayman accumulated lots of medical files in various countries. Though, she had [Miss Elisabeth Hughes](#) (see further down) arrange for the reimbursements of the hospitalisations by using someone else's identity, usually of some Belgian welfare recipient who is totally unaware that her identity is being used for recovering health care expenses for someone else. [Miss Elisabeth Hughes](#) was earning a lot of money this way, by crippling people through sex, while Miss Abusulayman was receiving nothing.

By the use of a different identity, Miss Muna Abusulayman's true medical history remains devoid of all the facts that truly happened and which she needs to prove that she was raped and had her reproductive system removed. This is like genocide and she won't be able to prove that. Someone was given that medical history without ever being raped, and that is how Miss Elisabeth Hughes uses the welfare system.

The medical file of Muna Abusulayman's son was also dominated by the same woman who is Madam Elisabeth Hughes, who plays the social secretary of everyone. Her son was actually smuggled into Belgium by Professor Roland Willemyns and Mr Alfons Nuyts. The new-born baby was undocumented, but they were not looking at that. At that moment, they imagined that they could use the child's name and nationality to get hold of oil fields in Saudi Arabia, later. This is why they allowed one Islamic feature about the child and that was the first name, which is Mohamed, which they abbreviated into "Mo". I have no information about the family name which was given to the child. We only know that the adoption family used to live in Westerlo.

The de Wouters van Oplinter have a family member in Westerlo, who is in the energy sector. His name is Mr Alexander III de Wouters van Oplinter and he sits at the board of Electrabel-GDF (Gaz de France) - Indo Suez, and in Belgium and in France. He also inherited a seat at the board of La Société Générale in France which seeks a stake in all these companies. That seat was previously occupied by [Baron Guy de Wouters van Oplinter](#).

As I said earlier: for growing the international portfolio of her Sofira Holing (which includes fields for industrial infrastructure related to water, electricity and petroleum) La Générale relies on beds, pillows, lingerie and rape, like the one that happened to Miss Muna AbuSulayman.

Initially her child grew up in Westerlo, where Mr Alexander de Wouters van Oplinter III lives in an impressive estate with large fields around it, and where he has a say at the municipality. He had everything arranged for the child through the same services that refugee centers use for allowing children from refugees to have a normal life until their situation is regulated.

These services are those of the Red Cross which supplies [orange identity cards](#), which is authorised to register foreign people in schools and universities, the OCMW (the Public Center for Social Welfare of the local municipality in Westerlo) which can arrange everything including [medical coverage for undocumented migrants](#), the Dokters van de Wereld (Doctors of the World) who is authorised to supply prescriptive medical care for undocumented people or medical supplies for free and dental care.

I was unable to locate the child and by the time I was thinking to involve governments in this highly absurd way of treating human beings, and to inform about how circumcision is totally misunderstood, the child was killed, so it seems to me from omissions in the press about the identity and the parents of one of the two teenagers who were killed in an apparent [accident in Buggenhout on 26 May 2026 involving the school bus company 'T Ros Beiaard, the train company Belgian Rail, and the rail traffic control company Infrabel.](#)

If I speak about "an apparent accident" it is because **Miss Elisabeth Hughes**, who is related to [the Brabant killers](#)' family and who was the European partner of **Mr Jeffrey Epstein** and **Miss Ghislaine Maxwell**, is a shareholder in all of these companies. She is the social secretary to all [the Brabant killers](#) who organises the necessary paperwork with fake identities to provide financial aid for [the Brabant killers](#), who live in hiding mostly in Belgium, but also in Morocco, Lebanon, the Occupied Territories of Palestine, France, Scotland, Denmark and in the USA. For what concerns those living in Belgium, Morocco and Denmark, she must be the one who engineered living allowances of the welfare under fake identities in various Belgian municipalities.

Miss Elisabeth Hughes takes a lot after the social assistant who was assigned to me in 2024 by the Victor Night Shelter of Centrum Algemeen Welzijn in Antwerp, to get my identity card and a living allowance sorted out.

Her name is **Madame Electra Laurent** and she looks like two drops of water like Elisabeth Hughes on the portrait I was given by an agent from a detective who works for an international court of justice inquiring on sex trafficking in various countries on the Epstein File. I answered that she looks a lot like my social assistant who has her office on Steenbokstraat number 1, in 2018 Antwerp, but I also has a neighbour called Annemarie DeVries on Rijmelgem 12, in 1932 Sint Stevens Woluwe, who also looks exactly like that. She has a classical appearance that is very common in Belgium, and that I didn't see her often enough to confirm or deny that she could be Electra Laurent.

Perhaps she can be identified based on the attitude of Electra Laurent with me. She changed her attitude after the recent publication of my pardon letter to [His Majesty King Philip of Belgium on the occasion of Belgium National Day on 21 July 2026](#).

One of the things I mentioned was the possibility that one of the teenagers killed in the Buggenhout accident was the child born from the 2013 rape of Muna AbuSulayman, as well as the name of a shareholder with financial positions in all the companies involved in that accident. The name is 'Electra Laurent', assuming it was a fake identity. In a letter to the Head of State, I don't withhold details. This is even if that means that she stops paying out social aid for me. It turns out that this is the case.

 When we asked whether this Mohamed could be the son of Muna AbuSulayman and Lucien Leuvenwoude, the answer was yes. It was indeed him. Upon examining the shareholdings of the parties involved, I discovered that Mrs Elisabeth Hughes held 9 per cent of Inthab's shares under the name of Marie-José Uythoven, of (Diest) Belgium. Mona Mustafa Al Wajez-Saymonos holds 7 per cent of Inthab's shares under the name of Ali Ben Heyan, of Tanger (Morocco). Baron Alexander de Kluysers II holds 11 per cent of Inthab's shares under the name of Alexander Dutoir, originally from Sint-Joosse-lez-Noode (Belgium). Upon examining the shareholding structure of T-Ros Beasard, I found that Elisabeth Hughes holds 7 per cent of the shares in T-Ros Beasard under the false or stolen identity of Electra Laurent. It cannot be ruled out that there are financial links and dealings between Elisabeth Hughes and the owner of the T-Ros Beasard mibus. It is this combination of shareholdings in T-Ros Beasard and Inthab that suggests this was not an accident, but a premeditated attack, probably coordinated via the EBA by a former genome working as a security guard at the EBA, perhaps on behalf of OAS, of which he is a shareholder. Inthab is a security system and, with the complicity of the other shareholders, he would have had access to the system to coordinate the train's passage with the arrival of the mibus carrying little Mohamed and others. There should be a record of this in the communication system of the T-Ros Beasard mibus. 30	I had never seen a forged visa in my entire life until 2017, when I discovered one in a CV. The judgement of 8 March 1998 refers to a large number of Benelux visas sold to numerous Moroccan nationals who were working in Belgian agriculture, specifically at Tuitouwe Marc Pittoons in Lier. This last detail was not mentioned, but this is the company that employs undocumented migrants as slaves, as it uses the forged visas to occupy the wages paid. In 2017, Madame Elisabeth Hughes would have sent Ms. Colette Dorgno to cross my path, to take me out of my comfort zone towards a zone where Madame Elisabeth Hughes and Madame Laurent have an easy time trapping the victims for human trafficking, and that is in Achenecht (Belgium). I was fully aware about being misled to follow someone else, like Miss Dorgno, but I didn't know who was pulling the strings. At that moment, I had never heard of Madame Elisabeth Hughes, but vaguely remembered having seen a woman that looks like her staring at me from the corner of her eyes, when I was using Vale Punt (a computer facility at Atlas airport). That woman was Madame Electra Laurent. I was only able to make that link in recent years, when this woman became my social assistant in 2024, but I never knew her at all.  She was first asked to organise a murder, then she secured the job she wanted with an airline, where she was responsible for passenger safety (French - English). Ms. Colette Dorgno requested my help in building a CV for an hostesses. She kept following in an insistent way trying to find the weaknesses that she could fit, such as the fact of being hostesses. It was clear that she was sent, and finding this out requires going along till a certain point. I think Ms. Colette Dorgno was paid to insist so much that I gave it a try. While in Brussels, I took a photo of all the identity documents like a copy of her passport what I was preparing her CV so that she could become a flight attendant. It seems to me that there is a document from Belgium dated 05-11-12 from whom the name BHO has been observed to make it look like a try. The stamp bearing the date 05-11-12. From the international airport, you can reach National Security. Nieuwste Airport (Nieuwste, Cameroon). 29	 The truth is that Ms. Colette Dorgno was already in Belgium when this visa was obtained for her. While staying in Belgium as an undocumented migrant, she flew to Morocco from Brussels Airport on 12 July 2011. She travelled to Casablanca using a false identity and a passport in the name of Julia Ouedraogo, originally from Bamako. She took a Royal Air Maroc flight from Brussels. She attended a dinner at the Leuvenwoude family's home, where Ms. Soraya Badagui was supposed. To begin with, she was already in Belgium at that time. She then managed, as an undocumented person, to travel round the world and return to Belgium. As you will see in Belgium story, Ms. Colette Dorgno stated that she had received help from Elisabeth Hughes in obtaining the visa, which was valid from November 2012. 30

I have been reporting about the rape of Miss Muna AbuSulayman for 18 month now, and i know one thing about all [the Brabant killers](#), which that they are impulsive individuals who are never fully aware of the impact at a later stage of the decisions they take today. Like drunken people they don't have the ability to think about the consequences of their acts.

After reading my reports they realised that the rape dossier was not a simple crime, that it was supported by a poisoning with drugs, a kidnapping, a hostage taking in which the victim's hands and feet were tied, and that physically and sexually tortured, and poisoned by diseases, that she was kidnapped to another country with her baby (little Mo), which was smuggled into Belgium undocumented and thus illegally, where both were held captive during at least three months in a house in Brussels in which they were locked up and guarded by Mr Alfons Nuyts until the adoptive family came to take her child, because he wanted to make money by the sales of a baby a family he had contacted.

All the actors involved were being themselves and unaware that their behaviour is criminal. This is why everyone should avoid them **totally**. Only Miss Muna Abusulayman was undergoing that whole list of violations **against her will**.

Belgium will be in big trouble with the Kingdom of Saudi Arabia on diplomatic, commercial and juridical level by attacking their female citizens in this way through conspiracy obviously involving Belgian State institutions. First they had issues with Miss Abusulayman. Now the issue has become bigger if Mo was one of the deadly victims

To solve the problem, they got rid of the child by applying the system that they know how to do best, because they are terribly experienced in this, but not their police or justice system to the point that the whole country believes in the premise of an accident. How much percent of accidents are there? Can they quantify the degree of accident? Do they know what they are talking about when they say "accident"?

Did little Mo and his friend have less luck than the three other children who survived, Is their luck different or was it the same bad luck that struck some and not others? Belgium is the country of conspiracies, but they have a police and justice system that are not prepared to tackle that aspect of the problem.

In any case Mo is dead so that they can re-write history their way and deny that such a rape has ever taken place. This is why all the files concerning the child from the day Miss Abusulayman was pregnant until the day the child was killed were dominated by the same hands, those of Miss Elisabeth Hughes who uses the welfare (OCMW / CPAS) to the benefit of undocumented foreigners like Miss Muna Abusulayman's son, at the expense of the Belgian taxpayers and the foreigners with a regular status.

In July 2026, I did not receive any welfare pay. I immediately knew this was in retaliation for something I had published in [the pardon letter dated 21 July 2026](#). In the letter, I had mentioned Elisabeth Hughes' shares in 't Ros Beiaard, Belgian Railways and Infrabel under

the name Electre Laurent. By mentioning these shares, I provided evidence that she had the means to orchestrate an apparent accident.

I still haven't received anything to date. She is starving me. This is the second time she has done this to me this year, without prior notice. I don't know why she wants to deprive me of my income. This is how she has attracted attention to herself. It prompted me to look into her case a little more closely, only to discover that she is involved in human trafficking.

I would like my case of non-payment of social aid to be considered as a murder attempt through starvation

An earlier announcement on X in which I published the robot photo a detective gave me, has caused a female RSF-member in Sudan to send in a robot photo from the local court of Justice in Sudan saying that the name of this woman is not Elisabeth Hughes but **Madame Electre Laurent** who in 2011 would have pushed through the window an 11-year old child she had with a Sudanese man. Their child fell to its death. That year, a criminal case was opened with the police in Khartoum.

The young man is Mr Mowafag Omer, and he used to live in Belgium. He is also a British national and he may have filed the case with police of Great Britain as well. This is clearly a case of child abuse and human trafficking if the child or the child's death is used by one of the parents as a bargaining currency to obtain something such as a marriage.

The robot photo is identical to the one I received from an international court detective in the Jeffrey Epstein dossier. "That is why you should forget about any welfare paid out from that woman", she said and recommended that I seek help from another welfare, and to avoid exposure to this dangerous individual who may have murdered more children.

Miss Elisaebth Hughes or Madam Electra Laurant reportedly also arranges [sickness pay for the Brabant killers based on HIV, which they treat as an incapacitating infection for claiming benefits](#). With all the money they receive from the welfare and the health insurance, in addition to the proceeds from the human trafficking with fake identities, they can pay anyone to cause accidents on demand.

There was a question of surgical operations for removing bullets because there were gunshots in the Alma Tunnel injuring three, of which one in the head, and that was [Professor Jan Wouters](#). It makes this dossier a very interesting dossier.

When I was not given the name of the hospital in Tournai, I inquired who the person was who arranged the refund by the health insurance. That person must be a genius. That person is Miss Elisabeth Hughes or Electra Laurent. She had to hand over all the files to [Attorney Inès Wouters](#) who took all of it to a safe at La Générale in Paris, most likely in Paris XII, or at the headquarters.

[Attorney Inès Wouters](#) may have used the same safe at the same bank for hiding other [loot from the car crash in the Alma tunnel in Paris on 30 August 1997](#), such as the jewelry, diamonds, passports, bank cards or anything of value that the victims in the black Mercedes had on them.

The people who are involved in this accident which targeted little Mo, in that they decided, funded and organised to get rid of Muna AbuSulayman's child, are exactly the same people who decided, funded and organised the accident targeting Princess Diana, Mr Dodi Al Fayed and Mr Henri Paul.

I have [more examples of this type](#) involving the same conspiracy. I thought we needed the other cases to eliminate the possibility of an accident. Which you will find in this dossier in which you will find her role in the accident of 31 August 1997 under this chapter "[Where was Elisabeth Hughes on 31 August 1997 and what was she doing?](#)".

The topping on the cake which completely wipes the premise of an accident is that there were rehearsals which took 18 months and there were expenditures related to the rehearsals such as the purchase of cars and the rental of a bungalow in the Ardennes.

One person was unable to be in Paris on 30 August 1997. That person is [Mr Lucien Leuwenkroon](#). He was hospitalised following gunshots that occurred at the Ritz Hotel in which he was injured. He appears innocent because he was not in Paris, by luck like one the harlots also have. However, he sponsored the 18 months of preparation and **spent €47,191,334 (£55,050,872.33 or \$54.982.859,20)**. He is invested with hatred and racism,

which I will report on separately.

The latest news, which is helpful in clearing the entire dossier is that [Miss Marleen Seymour](#), the woman who was sent to help the heart surgeon in cutting out the heart of Princess Diana on instruction of [Professor Roland Willemyns](#) is currently in prison in **Tunisia**. She is likely to be held in prison for a little while unless Belgium or another country requests that she be extradited.

I am insisting on her wellbeing and safety. She too is a shareholder of La Société Général and she was involved in the assassination of Washington Post journalist, Mr Jamal Khashoggi in Istanbul in October 2018. He is family to Mr Dodi Al Fayed, whose mother is Madame Nabila Khashoggi, the aunt to Mr Jamal Khashoggi.

His murder was perpetrated by exactly the same conspiracy which was involved in the murder of Mr Dodi Al Fayed, for whom they plotted and organised the accident which also cost the life of the British Princess, Lady Diana.

The people who cut Mr Jamal Khashoggi's body in smaller pieces were more numerous than previously thought and include [Miss Marlène Seymour](#), Mr Alfons Nuyts and [Mustapha Moshe Weissmann Bouhammou](#). I am pleading for the extradition to Saudi Arabia of all these individuals.

Mr Jamal Khashoggi was perhaps one of the first journalists to be killed in the context of the war in Gaza. In the hours before his murder, he delivered a presentation at a large congress organised by [PICUM](#). Among the audience were [the Brabant killers](#), as Mr Jens Högsholm is the founder of the non-profit organisation that defends the rights of undocumented people. Mr Khashoggi's speech was presumably about the mass migration of refugees and asylum seekers, about the slavery of these people in bug industries along the migration path, like food processing industries, and about people smuggling. Some say his murder was related to this topic, while others claim it was connected to a meeting he had with his compatriot, Miss Muna AbuSulayman, and the subsequent rape and birth of her child. They guaranteed his silence in this way.

Mr Khashoggi and Miss Abusulayman met at the Ciragan Palace Kempinski Hotel, where they were both staying. Both were friends of Cardinal Dominique Mathieu, who used to visit their homes in Saudi Arabia. They both knew the same man under a different French identity.

Someone of [the Brabant killers](#) brought to his awareness that the two were in Istanbul talking to each other, which is normal between compatriots from Saudi Arabia and the USA, and they were both media personalities who know each other through the profession.

The Belgian mafia feels threatened each time they notice two foreigners talking to each other in a language that they don't understand. They kept an eye on them. I have seen this happening a lot to me in Belgium, when I have a conversation with my own Moroccans or with other Arabs. I have been gathering lists of violations by [the Brabant killers](#) against my family and me to support demand for a pardon for the sentence to pay a fine in the dossier concerning the fake visa scam that was used to blame and shame me, and indirectly also [Dr Amine Matta of UCL Saint Luc](#), because is a Lebanese and he is a surgeon.

In bed, we want to speak our own language. There's something that gets lost when communicating with someone who's supposed to be our other half. How much of another half is it when you have to explain what you feel in a secondary or a third language, unless sex is the only thing that matters? It forces you to be rational when you need to translate something in a foreign language right at the moment when you want to go to sleep.

They don't realise how stressful that is

[They gave me zero for Dutch linguistics](#). They use that when they don't know what to use for putting you down. Do you think I'll care to use Dutch in bed to understand what the damned idiot is saying to me? I've been conducting my own personal boycott at all levels. That is why I feel safer with a Lebanese or an Arab. We don't want any stress in the couple, especially not about material stuff like money, like family visits.

We love family around, and that is not guaranteed when you marry selfish racists who only want to see you, but not your family who come with different habits. You don't want to have someone who counts the kilo's they eat, the cubic meters of water they use. With someone like that, you will feel restricted and oppressed. Once you have that, the relationship cannot be called a marriage anymore, because it is sliding towards human trafficking. We set people free in a marriage. They use marriage as a hostage-taking.

Only human traffickers are not concerned with the language you speak because they are not 100% humans. They only look like humans, but they share HIV with the chimpanzees. That is why they think they can make money with mail-order marriages and prostitution in which feelings don't exist. You can't have a normal relationship with that breed

Dr Amine Matta is an institutional investor in Belgian education, that too seems to go down the wrong throat. They mean to say "why does he invest in Belgium?" Since it hurts them so much, I think it is time we do something about it, to soothe their pain.

I am sharing that list. I was working on [the folder with cases for the General Prosecutor of Ukraine](#) to provide an easy mapping of criminal situations, something else happened of importance for our common justice files. If I want to have my defense lawyer accuse them of racism, I need to provide evidence or real life facts, such as the kidnapping of Miss Marlène Seymour to Lebanon to shoot her down in that country and perhaps to blame Hezbollah for her death.

The only questions which remain unanswered for me, in the case of the death of Princess

Diana, Mr Dodi Al Fayed, Mr Henri Paul and the severe injury that Mr Rees-Jones suffered unnecessarily is how did the culprits manage to make sure it took place in Paris and not in another country? Something prompted Diana and Dodi to go to Paris after all. What drew them there?

The only partial answer that I have so far is that they have had an easy time in France, and they are fearless because they are shareholders of [La Société Générale in Paris which their forefathers founded](#). Masses of people, companies and institutions in that country are clients of La Société Générale and its own affiliated banks such as Crédit Agricole, Crédit Lyonnais, Sofira Holding and other smaller investment companies, that they will be able to split the whole of France into two or more independent states, or by establishing another country to create a situation like the one in Palestine, with Ramallah on one side and Gaza on the other, with a whole strip of no-man's-land between them, and with a Belgium up north that will probably behave like Israel does today, seeking annexation of Gaza. They will definitely try to annex Paris. That is why in France they kept Diana's case quiet.

If in this letter, I was referring to the Congo as a Belgian colony, to mass graves existing in Belgium in addition to a lot of cemeteries with foreign military forces who died in this country, and to Gaza, it is to indicate that the same oppressive pattern which a mafia in this country has been showing over a period of 100 years still continues and it is affecting our countries and our people.

The IFRC operates two pension plans, the Base Pension Plan and the Supplemental Pension Plan, for expatriate field staff and all headquarters staff. The pension plans are funded plans. They provide retirement benefits based on a participant's accumulated account balance. They also provide [benefits on death, disability and termination](#).

22(h) Funding obligations, including Swiss legal requirements

Pension obligations are covered by an independent fund which is held in a single, separate legal entity. The Pension Fund of the International Federation of Red Cross and Red Crescent Societies (hereafter "the Pension Fund"), is a foundation, as defined in articles 80 to 89 "bis" of the Swiss Civil Code (Swiss law). The Pension Fund is registered with the Swiss supervisory authority in the Canton of Geneva and the Swiss pension guarantee fund. As such, it must comply with the compulsory insurance requirements established by Swiss Federal law on Occupational Retirement, [Survivors and Disability Pension Funds \(LPP to use the French acronym\)](#). The Pension Fund has the objective to comply with the requirements of the LPP and for foreign employees to replace the state retirement plan ("premier pilier"). It is fully funded through payments, as determined by periodic actuarial calculations, in accordance with Swiss law. The Pension Fund undertakes to respect at least the minimum requirements imposed by the LPP and its ordinances. If the Pension Fund is underfunded according to Swiss Law, the Pension Fund Governing Board (see below) decides measures that will allow the coverage ratio to get back to 100% within an appropriate time frame (usually five to seven years is considered appropriate).

The Pension Fund Governing Board is responsible for the Fund's management. It comprises six representatives appointed by the IFRC, six representatives elected by the Pension Fund's participants and four supplemental members.

I also think that we should all forget about our pensions because [the Brabant killers](#) take the money out with [fake identities linked to bank accounts at the Crédit Suisse Bank](#). 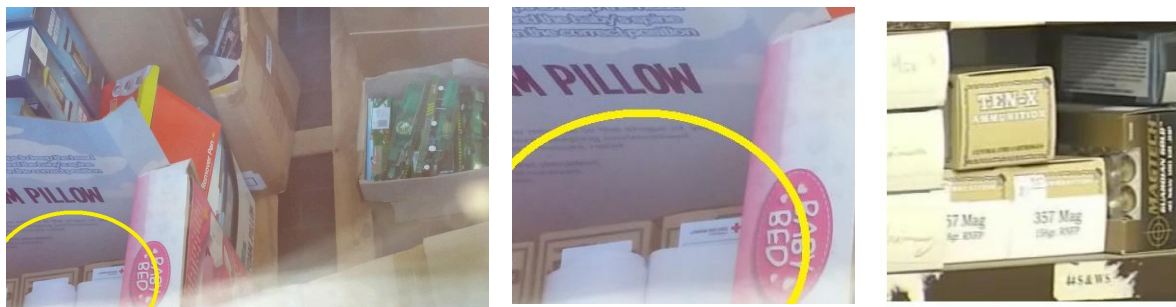

The IFRC's shareholders were never interviewed by the press about their appreciation of Princess Diana walking over a minefield in Angola. reports, including those of individual users of Red Cross facilities around the world.

Only in Belgium, the municipal welfare service has access to the Red Cross or the IFRC intranet. We suspect that Elisabeth Hughes consults the database on a regular bases from her office at the Public Center for Social Welfare. The Belgium Luxembourg Chamber of Commerce in Morocco has access to the IFRC intranet as one of the major shareholders, who is Mr Lucien Leuwenkroon, lives there. That database lists all the IFRC workers in the world, we understand now that this includes volunteer fighter and foreign legion fighters who use fake identities and might be ordering them through that system, which could be the one which coordinates people smuggling around the world.

There is the case of an asylum seeker from Ukraine who was flown over by a Red Cross aircraft because she is worth a lot of money to the shareholders of La Société Générale. She is said to have been an actress in Iran before fleeing to Ukraine, where she was reportedly involved in the sex industry and trained young women to become models and escorts. She was recently seen in Antwerp, where she had travelled to coach young Russian women.

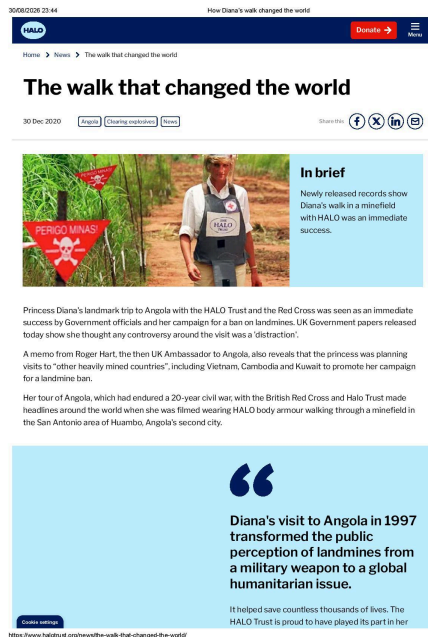

The de Wouters van Oplinter and [Verhoeven](#) families, who are shareholders, have access to the database in which they monitor family situations, health, housing, finances, and meeting reports on social assistance and asylum demands, in order to guide their own UNHCR decisions on a global scale. 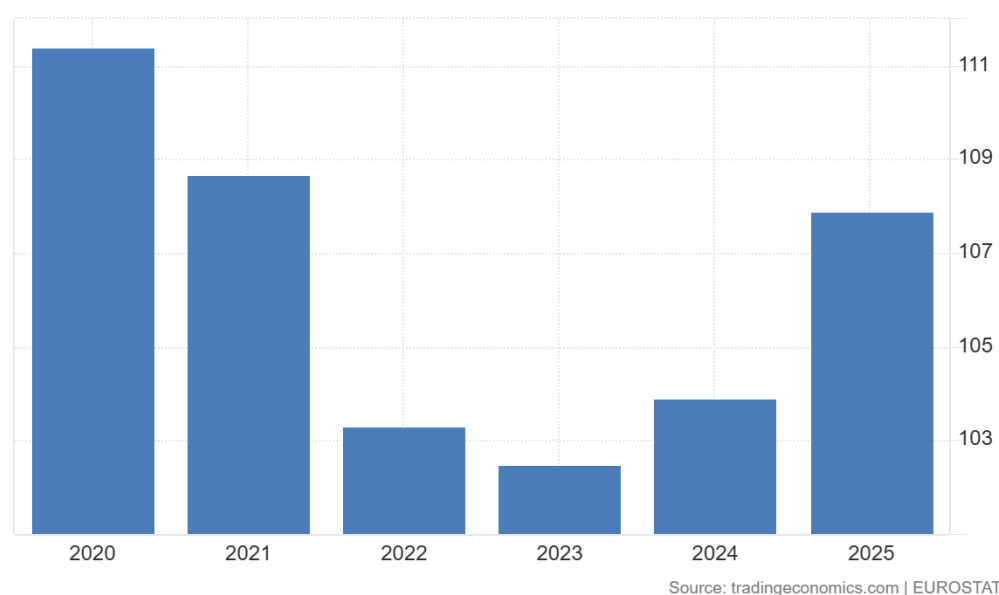


They Promise You a Bed of Roses When Meaning a Bed of Nails (français - Nederlands)

Comments from CMIA (Center for Moroccan International Alliances):

When it comes to the immigrants, it should be noted that there are Moroccan banks established in Belgium, such as Banque Chaabi, Banque Attijariwafa and BMCE, of which the size is being reduced, compared to 2023 when I notified Bank Al Maghrib on the

existence of fake Moroccan banks in Belgium. An awful lot of people lost their money with those fake banks of which the first was opened around 1976.

The good news is that they are not included in the [list of underwriters](#) due to their irregular nature on the Belgian financial market, on the one hand. On the other hand, however, the fake foreign banks were excluded from participation on the financial markets and lacking the full picture of the Belgian economy and perhaps that was the whole purpose of the fake foreign banks, against which the Belgian authorities did nothing. The market share of Moroccan banks and the contribution of Moroccan immigrants to total GDP and debt is **unknown** because these statistics are missing.

These fake Moroccan banks have no links with the headquarters in Morocco, which makes that Morocco's banks and central banks have no idea what the situation is of their citizens in Belgium. Are they making progress? Do they have jobs, if not why? What's the main source of income most of them have? Is that sufficient for paying all the expenses? Do they support their families in the home countries?

These fake Moroccan banks have links to a branch of the same brand in France, which is recognised by the headquarters in Morocco, but it is not clear if at the headquarters they agree that the branch operates out of scope. That branch probably has links through capital investment with La Société Generale in Paris and Morocco who use France for fooling the Moroccans.

To change this situation, we believe that buying the Belgian debt is a good way of adjusting bilateral differences in a fair and equitable way, and for sorting out that financial mess.

The list of bilateral differences can be found in the [memorandum of understanding](#) of the United Chambers, a multicultural chamber of commerce which has been in existence since 2006 and which is struggling to see the light of day due to opposition from an unknown source which is exercising an unhealthy policy of oppression towards the Moroccan people which is not conducive to human development nor compliant with the sustainable development goals (SDG's) of the United Nations.

Parts of the returns on the investment in the State bond or the Belgian Debts will be used to finance a financial product named [the Vanilla Finance card](#), which aims to intervene in the debts of all citizens, and in particular the immigrants, with a view to involving the country of origin in taking partial or full responsibility for health insurance and social security, in the event of unemployment or disability. This approach is part of [the Magrexit programme](#), to organise the return of an inactive mass of migrants in the European Union and the reduction of social debt.

I am in the process of setting up an international coalition to obtain justice in criminal cases involving the same criminals as [the Brabant killers](#). Examples include [Covid19](#), [HIV](#), [electoral fraud](#), [war and famine](#), [mass migration](#), [torrential rains](#), [forest fires](#) and so on.

[They've been protected](#) because it's otherwise impossible to hide [106,085,373,786.64 in secret accounts all over the world](#). Nobody is bothering them, and that explains why they occupy other people's land and why they can organise rehearsals for killing leaders of other countries, compared to the ordinary citizen in Belgium who has a hard time save any money, otherwise he or she will be taxed or sued in the case of non-payment of taxes related to moonlighting, or if it has been hidden in the house and the police or bailiff comes by and

finds it. They confiscate it and keep it for the duration of the investigation, which can take years during which people are deprived of their wealth.

That they first confiscate the secret accounts in foreign countries with a fake identities, before they come bothering ordinary citizens who try to make ends meet with small jobs that they don't declare for tax reasons, and at their own expense when something goes wrong.

Does anyone in Belgium understand what that debt is all about? By creating fake bank and by omitting the statistics, the migrant population will not be able to prove their contribution to the GDP. With a debt exceeding 90 % of the GDP, you can make the Belgian people believe anything you want on where those debts come from.

They will likely blame the immigrants and the Moroccans in particular for creating a gigantic Belgian sovereign debt.

In Belgium, they think they can move forward by depriving people of their money or their social rights. They create debt without realising that they do so. The only time when they understand debts is when a person dies and leaves debts. That is the only time they understand that a person will never be able to repay anything at all. [The Brabant killers](#) go with this understanding to foreign countries to get this kind of debt as a result everywhere, which is that people and money disappear and are never replaced. They engage in armed conflicts all over the world, as long as there are no restrictions on access to other people's territories. Their plan is to increase the poverty rate so that all the countries raise money indefinitely for humanitarian aid. [The Red Cross / Red Crescent movement](#) is their vehicle for doing both "to take care of their wounded soldiers" as well as to comfort the civilian victims with humanitarian aid. I don't want a Red Crescent organisation in any of the Islamic countries.

Whether war or peace, I just don't want an organisation in my country of which the owner is unknown, if they are unable or unwilling to supply an incorporation document with that information. This is a principle to stick to in any business.

Most citizens do not understand where the debt comes from. No school teaches people how to understand the debt, and the risk of this ignorance is that one day someone will explain this debt by the strong presence of Moroccans in Belgium, [almost all of whom depend on social benefits that come from the taxes paid by all the workers in Belgium](#). Accusing a foreign community is easier to understand than if you have to prove the fake companies like the Red Cross / Red Crescent to begin with, and all those masses NGOs that swallow tons of funds for not producing any profits. The average citizen is not concerned about [how NH Hotel Group came to be](#), they only want to [enjoy a vacation in your country and mine](#), As the school are not teaching this economic reality, they don't know who is behind [Regus Offices](#), [the fake banks](#) and [the fake identities with which they get paid a social pension](#).

History shows that nasty politicians will be able to take advantage of this void of knowledge to get themselves elected and to organise "the recovery of our taxes from immigrants", by giving everyone the feeling that "it's normal to attack thieves". As they have kept most Moroccans poor by putting big obstacles in their way, it works to make people believe that Moroccan immigrants are more likely to steal from you than anyone else. It works all the more because [many young people are employed by the Brabant killers to commit crimes](#), ranging from robbing people's mobile phones (for data) and burglaries to suicide bombings.

What will help is having the financial clout to ensure that these criminals are no longer protected and that the justice system can do its job properly, and that's what I'm aiming with

this new action, which is to purchase some of Belgium's federal debt.

I work alone and until recently I was homeless, sleeping in shelters, with friends and sometimes with family. While I prepare the court files there is no money coming in, which means that I can't rent an apartment or a home.

Throughout this summer I did not have food at all because the only social kitchen in town free of charge provided that you are registered is Kamiano of Sant'egidio in Rome (Italy). They kept me on my feet for 20 months until I found this studio. It was closed for vacation. I have been [begging for food at shops](#) and restaurants, but [this takes up the vital time we need for solving urgent issues](#) to liberate more countries. I am particularly thinking of Yemen, Irak, Libya, Tchad, Niger, but also Palestine who undergo violence not knowing where it comes from and why. Rest assured that we have the names of who finances the violence and now we also know why. You will find the names [on this link](#). I inform guerillas also, including Hamas, Hezbollah, the [RSF](#), the Taliban and Wagner Group, because the only good thing about them is that they understand injustice and they became rebels because of that. I show them the injustices against the immigrants in Belgium, as well as the financial injustices against everyone by the World Bank and the IFRC.

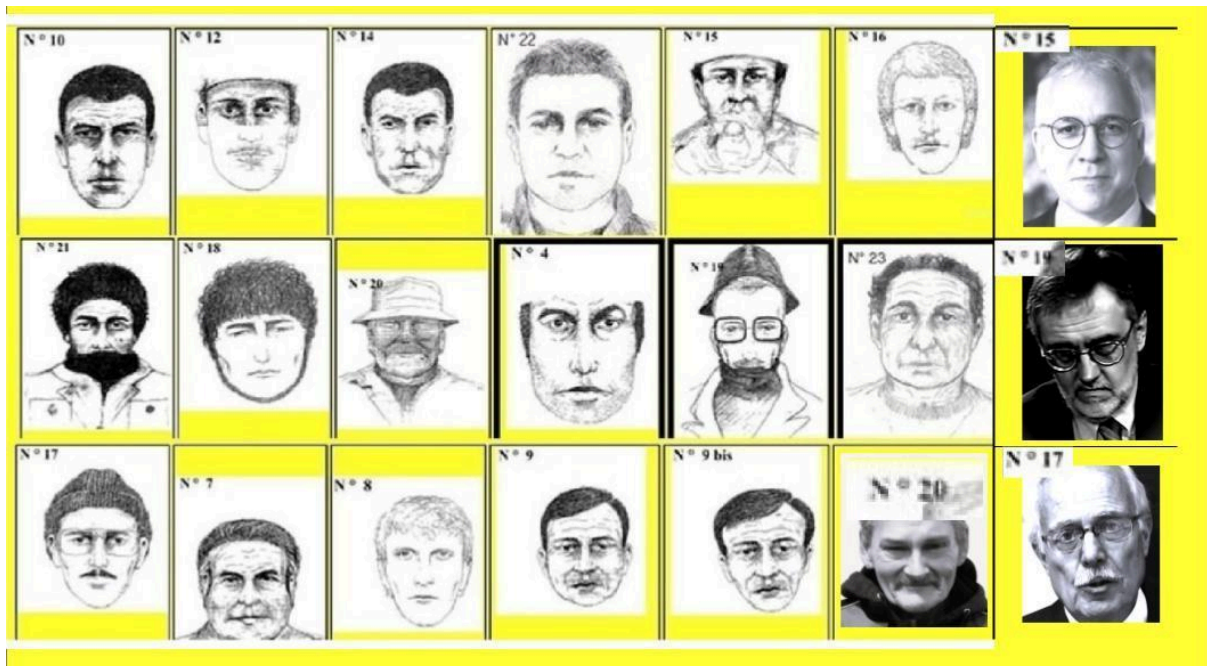

For the faces on the far right column which are robot photos I found the real pictures with [an artificial intelligence application that I devised in spring this year consisting of a camera which is equipped with a 3D calculator for producing virtual reality pictures linked to a database with the wanted faces](#).



The calculator reflects precisely the same results for the same person no matter how recent or old the picture is, and even if the person has had plastic surgery. The database searches for constants instead of variables and decides that this picture is the same as that picture. For filtering I use etymology for quick recognition, as we all have something we can associate to an animal, like [a dog](#), an owl or [a beluga](#). The next challenge is to find the corresponding name of the person and that search would represent for the police less than 20% of the time they take for identifying criminals.

I discussed further development and fine tuning with [His Excellency Narendra Modi, the President of India on 16 August 2023](#) and on [4 August 2023 with His Excellency Mr Hans Muller, the CEO of Delhaize Supermarkets](#), a distribution chain in Belgium which has been the target of [the Brabant killers](#) in the 1980ies.

Next thing, I discovered at [Georgia Tech](#) a lot of programs that resemble all the propositions that I have been preparing for New Morocco, for allowing my country to develop technology strength for useful things, not for games, among which this multidisciplinary AI concept. It seems like at [Georgia Tech](#) they are planning to spend a lot of money on interdisciplinary research instead of development with AI. Where does it start and when will it end? That is how they work in Belgium, and that is one way through which they create debt. They need a whole university to find just one thing.

They made me homeless in this way, by robbing strategies and selling them for very high sums to pay their terrorists somewhere. It was the military aspect of the concept which may have triggered jealousy. The military plan is to equip weapons with a camera that recognises the members of the same battalion to prevent soldiers from killing one of their own. The camera recognises the individual even if they are hooded.

I don't mind working with [Georgia Tech](#) at all, but I am not inclined to work with traitors on military projects. That's excluded. That said, I am not pointing the finger to [Georgia Tech](#), but to one or more [Brabant killers](#), with an academic clout that makes people believe him and not me.

I live at risk of homelessness any minute. The longer it takes, the more the owner has the right to put everything on the street including the Russian lady who has been kind to help me. They did that to a Spanish-Moroccan couple a little a month ago. I reported about it to the United Nations, while being very hungry myself.

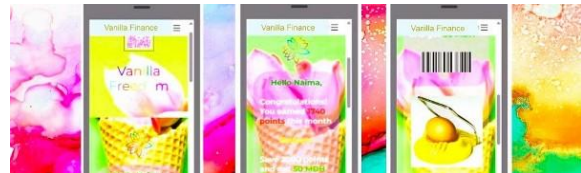
